A BILL FOR AN ACT

RELATING TO VEHICLE SALES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that Hawai'i has set clear 2 and attainable goals for the reduction of fossil fuel 3 dependency. In 2014, the State agreed to the Aloha+ Challenge, which among other goals, commits to achieving seventy per cent 4 5 clean energy usage by 2030. In 2016, Governor Ige and the 6 departments of the executive branch put forth the Sustainable 7 Hawai'i Initiative, which commits the State to one hundred per 8 cent renewable electricity by 2045. The legislature also finds 9 that currently one third of the fossil fuel brought into the 10 State is being used for ground transportation, while another one 11 third is used for aviation. The legislature therefore finds 12 that in order to comply with the initiatives and promises made 13 for a sustainable community, the only option is to address the 14 fossil fuel usage by all combustion engine-powered vehicles. 15 The legislature also acknowledges that the average life span of a vehicle powered by a combustion engine is twelve to fifteen 16 17 The purpose of this Act, therefore, is to commence years.

(a) Beginning 11 January 1, 2025, no retailer shall sell or offer for sale any 12 combustion engine-powered vehicle unless the vehicle was 13 initially purchased in a consumer transaction completed prior to 14 January 1, 2025; provided that the transaction was not initiated 15 before July 1, 2024; provided that commercial motor vehicles as 16 defined in section 286-2 shall be excluded. 17 This section shall not be construed to prohibit any (b) 18 individual or retailer from reselling, renting, or offering for 19 resale or rent, a combustion engine-powered vehicle that was 20 initially purchased in a consumer transaction prior to

2	not more than \$1,000 for each separate offense. Each violation
3	shall constitute a separate offense.
4	(d) For the purposes of this section, "retailer" means a
5	person or entity that engages in the practice of selling
6	vehicles to consumers."
7	SECTION 3. Section 286-2, Hawaii Revised Statutes, is
8	amended by adding a new definition to read as follows:
9	""Combustion engine-powered vehicle" means any vehicle with
10	an engine propelled by the combustion of a fossil-fuel-and-air
11	mixture inside one or more closed chambers or cylinders."
12	SECTION 4. New statutory material is underscored.
13	SECTION 5. This Act shall take effect upon its approval.
