A BILL FOR AN ACT

RELATING TO BUSINESS REGISTRATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that certificates of good
- 2 standing are frequently used to verify the status of a business
- 3 entity and, to many, can suggest that the State has engaged in a
- 4 more thorough review of compliance with other entities or
- 5 regulations than what actually occurs when such certificates are
- 6 issued, whereas certificates of vendor compliance certify
- 7 compliance with multiple agencies, including the Internal
- 8 Revenue Service, department of labor and industrial relations,
- 9 department of commerce and consumer affairs, and the department
- 10 of taxation.
- 11 Accordingly, to ensure that the State and counties are
- 12 engaging in business and entering into agreements with entities
- 13 that have the financial ability and business integrity necessary
- 14 to perform duties under those agreements, the purpose of this
- 15 Act is to prohibit the director of the department of commerce
- 16 and consumer affairs from issuing a certificate of good standing

- 1 to any entity unless the entity has submitted a certificate of
- vendor compliance as part of its annual reporting requirements.
- 3 SECTION 2. Chapter 414, Hawaii Revised Statutes, is
- 4 amended by adding a new section to be appropriately designated
- 5 and to read as follows:
- 6 "S414- Certificates of good standing; compliance
- 7 requirements. The department director shall not issue a
- 8 certificate of good standing to any entity unless the entity has
- 9 submitted a certificate of vendor compliance with its annual
- 10 report, as required pursuant to section 414-472."
- 11 SECTION 3. Chapter 414D, Hawaii Revised Statutes, is
- 12 amended by adding a new section to be appropriately designated
- 13 and to read as follows:
- 14 "§414D- Certificates of good standing; compliance
- 15 requirements. The department director shall not issue a
- 16 certificate of good standing to any entity unless the entity has
- 17 submitted a certificate of vendor compliance with its annual
- 18 report, as required pursuant to section 414D-308."
- 19 SECTION 4. Chapter 415A, Hawaii Revised Statutes, is
- 20 amended by adding a new section to be appropriately designated

19	(a)(3) shall be current. A domestic or foreign partnership that		
20	has filed with the department director a statement of

Business Registrations; Corporations; Nonprofit Corporations; Professional Corporations; Partnerships; Limited Liability Companies; Certificates of Good Standing; Annual Reports; Certificates of Vendor Compliance

Description:

Prohibits the Director of the Department of Commerce and Consumer Affairs from issuing certificates of good standing unless the entity has submitted a certificate of vendor compliance with its annual report certifies compliance with the Internal Revenue Service, Department of Labor and Industrial Relations, Department of Commerce and Consumer Affairs, and the Department of Taxation. Requires entities to submit certificates of vendor compliance as part of their annual reporting requirements.
