#### A BILL FOR AN ACT

RELATING TO ANIMAL CRUELTY.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The purpose of this Act is to clarify section		
2	711-1109, Hawaii Revised Statutes, with respect to tethering and		
3	restraints. It is not the intent of the legislature to prohibit		
4	all tethering, and the legislature acknowledges that it is		
5	possible for individuals to humanely tether or restrain dogs.		
6	SECTION 2. Section 711-1109, Hawaii Revised Statutes, is		
7	amended as follows:		
8	1. By amending subsection (1) to read:		
9	"(1) A person commits the offense of cruelty to animals in		
10	the second degree if the person intentionally, knowingly, or		
11	recklessly:		
12	(a) Overdrives, overloads, tortures, torments, beats,		
13	causes substantial bodily injury to, or starves any		
14	animal, or causes the overdriving, overloading,		
15	torture, torment, beating, or starving of any animal;		
16	(b) Deprives a pet animal of necessary sustenance or		
17	causes [ <del>such</del> ] that deprivation;

1 (C) Mutilates, poisons, or kills without need any animal 2 other than insects, vermin, or other pests; provided 3 that the handling or extermination of any insect, 4 vermin, or other pest is conducted in accordance with 5 standard and acceptable pest control practices and all 6 applicable laws and regulations; 7 (d) Keeps, uses, or in any way is connected with or 8 interested in the management of, or receives money for 9 the admission of any person to, any place kept or used 10 for the purpose of fighting or baiting any bull, bear,

11 cock, or other animal, and includes every person who
12 encourages, aids, or assists therein, or who permits
13 or suffers any place to be so kept or used;
14 (e) Carries or causes to be carried, in or upon any
15 uchicle or other correspondence or animal in a graph or

vehicle or other conveyance, any animal in a cruel orinhumane manner;

(f) Confines or causes to be confined, in a kennel or
cage, any pet animal in a cruel or inhumane manner;
(g) Tethers, fastens, ties, or restrains a dog to a
doghouse, tree, fence, or any other stationary object
[by], or uses a trolley, trolley with swivels, pulley,

15		from using such restraints when walking a dog	
16		with a hand held leash or while a] unless the dog	
17		is engaged in [ <del>a supervised</del> ] <u>an</u> activity[ <del>;</del> ]

By amending subsection (4) to read: 2 "(4) Cruelty to animals in the second degree is a 3 misdemeanor, except [where] that if the offense involves ten or 4 more pet animals in any one instance [which], then cruelty to 5 animals in the second degree is a class C felony." 6 SECTION 3. This Act does not affect rights and duties that 7 matured, penalties that were incurred, and proceedings that were 8 begun before its effective date. 9 SECTION 4. Statutory material to be repealed is bracketed 10 and stricken. New statutory material is underscored. 11 SECTION 5. This Act shall take effect upon its approval. 12 Kal Mhond

INTRODUCED BY:

**Report Title:** Cruelty to Animals; Dogs; Restraints; Tethers; Penalties

#### Description:

Prohibits specified trolleys, trolleys with swivels, pulleys, cables, or running lines designed to attach a dog to two stationary objects in a configuration that endangers the dog, including by depriving the dog of sustenance. Prohibits tethering or restraining a dog under the age of six months unless the dog is engaged in an activity supervised by its owner or an agent of its owner. Prohibits tethering or restraining a dog with a tow or log chain. Prohibits tethering or restraining a dog with a choke collar, pinch collar, or prong collar unless the dog is engaged in an activity supervised by its owner or an agent of its owner.
