# A BILL FOR AN ACT

RELATING TO ELECTIONS BY MAIL.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that Act 136, Session 2 Laws of Hawaii 2019, required all elections statewide to be 3 conducted by mail beginning with the 2020 primary election. 4 The purpose of this Act is to: 5 Amend the State's election laws to clarify and improve (1) the administration of elections by mail; 6 Establish voters with special needs advisory 7 (2) 8 committees: 9 Require the department of public safety and Hawaii (3) 10 paroling authority to inform individuals on parole or 11 probation of their right to vote and provide them with 12 information on how to register and vote; and 13 Require the office of elections and the county clerks (4) to make a determination, as soon as practicable, of 14 15 the optimal number and placement of voter service

1 SECTION 2. Chapter 11, Hawaii Revised Statutes, is amended 2 by adding three new sections to be appropriately designated and 3 to read as follows: 4 Minimum number of precincts. Beginning with the "§11-2022 primary election, there shall be a minimum of four 5 6 precincts in each district; provided that each inhabited island 7 with at least one hundred residents shall include at least one 8 precinct. 9 §11- Statewide voters with special needs advisory 10 committee. (a) There is established a statewide voters with 11 special needs advisory committee within the office of elections 12 for administrative purposes. The purpose of the advisory committee is to ensure equal and independent access to voter 13 14 registration, casting of ballots, and all other office of 15 elections services. 16 (b) The advisory committee shall consist of five members **17** appointed by the governor based on recommendations from 18 organizations within the State that are comprised of a majority 19 of officers and members who are persons with physical

disabilities including visual impairment. Each member shall

The terms of advisory 4 5 committee members shall be four years; provided that initial 6 terms shall be one, two, three, or four years to ensure 7 staggered rotation of members. 8 (c) Each advisory committee shall meet at least annually 9 to review election procedures, services, and technology and 10 access to information, and shall make recommendations to the 11 office of elections on at least an annual basis. The advisory committees may meet and subsequently make recommendations at 12 13 additional times as determined by a majority of the members." 14 SECTION 3. Chapter 353C, Hawaii Revised Statutes, is 15 amended by adding a new section to be appropriately designated

(a) At 4:30 p.m. on the 2 [thirtieth] tenth day [prior to] before each [primary, special 3 primary, or special] election, but if the day is a Saturday, 4 Sunday, or holiday then at 4:30 p.m. on the first working day 5 immediately thereafter, the general county register shall be closed to registration for persons seeking to vote [at the 6 7 primary, special primary, or special election] and remain closed 8 to registration until after the election, subject to change only 9 as provided in sections 11-15.2, 11-21(c), 11-22, 11-25, 11-26, 10 and this section. 11 Notwithstanding the [closing of the register for 12 registration to vote at the primary or special primary election, 13 the register shall remain open for the registration of persons seeking to vote at the general or special general election, 14 15 until 4:30 p.m. on the thirtieth day prior to the general or 16 special general election, but if the day is a Saturday, Sunday, 17 or holiday then at 4:30 p.m. on the first working day 18 immediately thereafter, at the end of which period the general 19 county register shall be closed to registration and remain 20 closed until after the general or special general election next 21 following, subject to change only as provided in

sections 11-21(c), 11-22, 11-25, and 11-26.] time of closing the 1 2 general county registrar under subsection (a), the clerk may accept an application submitted on the tenth day if it was 3 received electronically through the online voter registration 4 system in accordance with section 11-15.3 or received as part of 5 6 a driver's licensing transaction or from another designated voter registration agency under the National Voter Registration 7 8 Act of 1993. The clerk shall also accept an application that is postmarked before or on the tenth day before the election." 9 SECTION 12. Section 11-25, Hawaii Revised Statutes, is 10 11 amended by amending subsection (a) to read as follows: Any registered voter may challenge the right of a 12 "(a) person to be or to remain registered as a voter in any precinct 13 14 for any cause not previously decided by the board of 15 registration or the supreme court in respect to the same person. 16 The challenge shall be in writing, setting forth the grounds 17 upon which it is based, and be signed by the person making the 18 challenge. The challenge shall be delivered to the clerk who shall immediately serve notice thereof on the person challenged. 19 The clerk shall, as soon as possible, investigate and rule on 20 21 the challenge."

- 1 SECTION 13. Section 11-26, Hawaii Revised Statutes, is
- 2 amended as follows:
- 3 1. By amending subsection (a) to read:
- 4 "(a) In cases where the clerk, or [precinct] voter service
- 5 center officials, rules on a challenge on election day, the
- 6 person ruled against may appeal from the ruling to the board of
- 7 registration of the person's county for review under part III.
- 8 The appeal shall be brought before the challenger and challenged
- 9 party leave the [polling place.] voter service center. If an
- 10 appeal is brought, both the challenger and the challenged voter
- 11 may be parties to the appeal."
- 12 2. By amending subsection (c) to read:
- "(c) If the appeal is sustained, the board shall
- 14 immediately certify that finding to the clerk, who shall
- 15 thereupon alter the register to correspond to the findings of
- 16 the board, and when necessary, the clerk shall notify the
- 17 [precinct] voter service center officials of the change in the
- 18 register."
- 19 SECTION 14. Section 11-91, Hawaii Revised Statutes, is
- 20 amended to read as follows:

1 "§11-91 Proclamation. [Not] No later than 4:30 p.m. on 2 the tenth day [prior to] before the close of filing in elections 3 involving state offices, the chief election officer shall issue an election proclamation. In elections involving only county 4 offices the clerk shall issue the proclamation. In elections 5 6 involving both state and county offices the proclamation may be 7 issued jointly. The proclamation shall contain a statement of the [time and 8 9 places where, and the purposes for which [7] the election is to 10 be held, and a designation of the offices and the terms thereof for which candidates are to be nominated or elected. It may 11 12 also contain any other relevant matter including an offer of rewards for the detection and conviction of offenders against 13 14 the election laws. The chief election officer or clerk shall cause the election proclamation to be published at least once in 15 16 a newspaper of general circulation and [not] no later than on 17 the tenth day [prior to] before the close of filing." SECTION 15. Section 11-92.1, Hawaii Revised Statutes, is 18 19 amended to read as follows: 20 "§11-92.1 Election proclamation; establishment of a new 21 precinct; voter service centers and places of deposit; changes

- 1 to [district] precinct boundaries. (a) The [chief election
- 2 officer | clerk shall issue a proclamation listing all voter
- 3 service centers and places of deposit, including the days each
- 4 voter service center and place of deposit is open and the hours
- 5 of operations and location of each voter service center and

- 19 (c) Notwithstanding subsection (a), and pursuant to
- 20 section 15-2.5, the clerk is not required to establish voter

- 1 service centers for [districts] precincts affected by natural
- 2 disasters, as provided in section 15-2.5."
- 3 SECTION 16. Section 11-92.3, Hawaii Revised Statutes, is
- 4 amended to read as follows:
- 5 "§11-92.3 Natural disasters; postponement; consolidation
- 6 of [districts;] precincts; special elections. (a) In the event
- 7 of a flood, tsunami, earthquake, volcanic eruption, high wind,
- 8 or other natural disaster, occurring before an election where
- 9 the extent of damage caused is such that the ability of voters,
- 10 in any precinct, district, or county, to exercise their right to
- 11 vote is substantially impaired, the chief election officer or
- 12 clerk in the case of county elections may postpone the
- 13 conducting of an election in the affected [area] precinct,
- 14 district, or county for no more than twenty-one days; provided
- 15 that any postponement shall not affect the conduct of the
- 16 election, tabulation, or distribution of results for those
- 17 precincts, districts, or counties not designated for
- 18 postponement. The chief election officer or clerk in the case
- 19 of county elections shall give notice of the postponement by
- 20 whatever possible news or broadcast media are available.

- 1 (b) In the event the chief election officer or the clerk
- 2 in a county election determines that the number of candidates or
- 3 issues on the ballot in a special, special primary, or special
- 4 general election does not require the full number of established
- 5 [districts,] precincts, the [districts] precincts may be
- 6 consolidated for the purposes of the special, special primary,
- 7 or special general election into a small number of special,
- 8 special primary, or special general election [districts.]
