Repeals the requirement for reconstructed vehicles to obtain a special inspection and certification on 1/1/2022 and reenacts the requirement on 7/31/2025. Requires the department of transportation to submit a report on the effects of the repeal by 7/1/2024. Effective 7/1/2040. (HD1)
