### A BILL FOR AN ACT

RELATING TO TRAFFIC.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 291C, Hawaii Revised Statutes, is amended by amending the title of Part VIII to read as follows: 2 3 "PART VIII. TURNING [AND STARTING], STARTING, AND PROCEEDING AND SIGNALS ON STOPPING [AND TURNING], TURNING, AND 4 5 BICYCLE PROCEEDING" SECTION 2. Section 291C-81, Hawaii Revised Statutes, is 6 7 amended to read as follows: 8 "§291C-81 Required position and method of turning at 9 intersections [-]; bicycle proceeding through intersections. (a) 10 The driver of a vehicle intending to turn at an intersection shall do so as follows: 11 12 (1) Right turns. Both the approach for a right turn and a right turn shall be made as close as practicable to 13 14 the right-hand curb or edge of the roadway. 15 (2) Left turns. The driver of a vehicle intending to turn 16 left at any intersection shall approach the 17 intersection in the extreme left-hand lane lawfully

1	available to traffic moving in the direction of traver
2	of [such] the vehicle, and, after entering the
3	intersection, the left turn shall be made so as to
4	leave the intersection in a lane lawfully available to
5	traffic moving in [such] the direction upon the
6	roadway being entered. Whenever practicable the left
7	turn shall be made in that portion of the intersection
8	to the left of the center of the intersection.
9	(b) Any person operating a bicycle proceeding in a right
10	turn only lane may continue proceeding through an intersection
11	in the direction of travel if the operator cannot with
12	reasonable safety merge left into the traffic lane prior to the
13	intersection; provided that the operator shall make a signal of
14	intention to turn left, which in this circumstance shall
15	indicate the intention to merge left into the traffic lane as
16	soon as practicable and continue proceeding in the traffic lane.
17	$[\frac{(3)}{(3)}]$ <u>(c)</u> The director of transportation and the counties
18	in their respective jurisdictions may cause official traffic-
19	control devices to be placed within or adjacent to intersections
20	and thereby require and direct that a different course from that
21	specified in this section be traveled by vehicles turning at an

- 2 vehicle shall turn a vehicle at an intersection other than as
- 3 directed and required by [such] the devices."
- 4 SECTION 3. Section 291C-84, Hawaii Revised Statutes, is
- 5 amended to read as follows:
- 6 "§291C-84 Turning and bicycle proceeding movements and
- 7 required signals. (a) No person shall turn a vehicle at an
- 8 intersection unless the vehicle is in proper position upon the
- 9 roadway as required in section 291C-81, or turn a vehicle to
- 10 enter a private road or driveway, or otherwise turn a vehicle
- 11 from a direct course or move right or left upon a roadway unless
- 12 and until [such] the movement can be made with reasonable
- 13 safety. No person shall so turn any vehicle without giving an
- 14 appropriate signal in the manner [hereinafter] provided[-] by
- 15 this section.
- 16 (b) A signal of intention to turn right or left when
- 17 required shall be given continuously during not less than the
- 18 last one hundred feet traveled by the vehicle before turning;
- 19 provided that for a bicycle or moped, [such] the signal shall be
- 20 given continuously during not less than the last one hundred
- 21 feet traveled by the bicycle or moped before turning, and shall

- 1 be given when the bicycle or moped is stopped waiting to turn;
- 2 [and further] provided further that a signal by hand and arm
- 3 need not be given continuously by the driver of a bicycle or
- 4 moped if the hand is needed in the braking, control, or
- 5 operation of the bicycle or moped.
- 6 (c) Any person operating a bicycle proceeding in a right
- 7 turn only lane may continue proceeding through an intersection
- 8 in the direction of travel if the person cannot with reasonable
- 9 safety merge left into the traffic lane prior to the
- 10 intersection; provided that the person shall make a signal of
- 11 intention to turn left, which in this circumstance shall
- 12 indicate the intention to merge left into the traffic lane as
- 13 soon as practicable and continue proceeding in the traffic lane.
- 14 [<del>(c)</del>] (d) No person shall stop or suddenly decrease the
- 15 speed of a vehicle without first giving an appropriate signal in
- 16 the manner provided [herein] by this section to the driver of
- 17 any vehicle immediately to the rear when there is opportunity to
- 18 give [such] a signal.
- 19 [<del>(d)</del>] (e) The signals provided for in section 291C-85(b)
- 20 shall be used to indicate an intention to turn, change lanes, or
- 21 start from a parked position and shall not be flashed on one

4	SECT	ION 4. Section 291C-145, Hawaii Revised Statutes, is					
5	amended to read as follows:						
6	"§29	1C-145 Riding on roadways and bikeways. (a) Every

8	the normal speed of traffic moving in the same direction [at						
9	such time	] shall ride as near to the right-hand curb, on the					
10	edge of the roadway, or on the shoulder off of the roadway as						
11	practicable, exercising due care when passing a standing vehicle						
12	or one proceeding in the same direction; except under any of th						
13	following situations:						
14	(1)	When preparing for a left turn at an intersection or					
15		into a private road or driveway, except where					
16		prohibited by official traffic-control devices;					
17	(2)	When reasonably necessary to avoid conditions					
18		(including but not limited to fixed or moving objects,					
19		vehicles, bicycles, pedestrians, animals, surface					
20		hazards, or substandard width lanes) that make it					
21		unsafe to continue along the right-hand curb, on the

6	opposite directions shall pass each other to the right.

8	counties by ordinance may with respect to bikeways under their

12	motor on any sidewalk. The counties may, by ordinance, post
13	bicycle lanes and bicycle paths to prevent persons riding a

16	and stricken. New statutory material is underscored.

#### Report Title:

Bicycles; Traffic Safety; Right Turn Only Lanes

#### Description:

Permits a bicyclist to proceed through an intersection from a right turn only lane if they cannot safely merge into the traffic lane, provided they signal intention to merge left. Permits a bicyclist to proceed in a right turn only lane when approaching an intersection, even if they do not intend to turn right, provided that they do not pass a stopped vehicle and that they exercise reasonable safety when passing a moving vehicle.
