### A BILL FOR AN ACT

RELATING TO SPECIAL NUMBER PLATES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 249, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	"§249- Special number plates for Polynesian Voyaging
5	Society authorized. (a) Notwithstanding any law to the
6	contrary, the director of finance shall issue to any registered
7	owner of an electric vehicle, who is a resident of the State,
8	upon completed application and payment of required fees, a
9	special number plate for the registered owner's electric vehicle
10	commemorating the Polynesian Voyaging Society.
11	(b) The director of finance of the city and county of
12	Honolulu, in consultation with the directors of finance of the
13	counties of Kauai, Maui, and Hawaii, the chiefs of police of the
14	city and county of Honolulu, and the counties of Kauai, Maui,
15	and Hawaii, and the board of directors of the Polynesian
16	Voyaging Society, shall establish a special number plate design
17	that:

1	(1)	Contains words, images, or both, that indicate the
2		special number plate is issued to recognize the
3		Polynesian Voyaging Society;
4	(2)	Is similar in shape and size to the uniform state
5		number plate prescribed by law; and
6	(3)	Does not obstruct the visibility of the number or
7		letters of any other information that is required by
8		law to be on a number plate and are readily
9		identifiable and distinguishable under actual traffic
10		conditions.
11	<u>(c)</u>	The special number plate design shall not:
12	(1)	Infringe or otherwise violate any trademark, trade
13		name, service mark, copyright, or other proprietary or
14		property right;
15	(2)	Represent any obscene or degrading image, idea, word,
16		or phrase;
17	(3)	Advertise or endorse a product, brand, or service that
18		is provided for sale;
19	(4)	Promote any religious belief; or
20	(5)	Promote any philosophy based on prejudice or that is
21		contrary to state civil rights laws.

1	(d) Each special number plate shall be securely fastened
2	to the electric vehicle in lieu of the uniform state number
3	plate.
4	(e) The director of finance shall charge a special number
5	plate fee at least equal to the county's cost of providing the
6	special number plate and administrative costs, if any, plus a
7	fundraising fee to be determined by the director of finance in
8	consultation with the board of directors of the Polynesian
9	Voyaging Society. The fundraising fee shall be in addition to
10	any other state or county fees collected for a motor vehicle
11	registration or license plate.
12	(f) The director of finance may charge an additional
13	fundraising fee of the same or a different amount as the
14	fundraising fee established pursuant to subsection (e), for the
15	renewal of a special number plate. If an additional fundraising
16	fee is implemented pursuant to this subsection, the director of
17	finance shall revoke the special number plate of the registered
18	owner of a motor vehicle who fails to pay the additional
19	fundraising fee imposed by this subsection.
20	(g) The revenue generated by the fundraising fees, or a
21	portion of the revenue generated by the fundraising fees as

1	determined by the director of finance, shall be deposited in the
2	name of the Polynesian Voyaging Society in a separate county
3	budget account. The director of finance shall determine the
4	most efficient means of directing the revenue generated by the
5	fundraising fees to the Polynesian Voyaging Society.
6	(h) The director of finance may revoke all special number
7	plates issued pursuant to this section if the total number of
8	registered owners of electric vehicle that obtain the special
9	number plate is less than one hundred fifty within three years
10	of issuance of the first special number plate.
11	(i) Nothing in this section shall be construed to apply to
12	any plates issued pursuant to section 249-9.2.
13	(j) For purposes of this section, unless a different
14	meaning appears from the context, "special number plate" means a
15	license plate that represents the Polynesian Voyaging Society."
16	SECTION 2. New statutory material is underscored.
17	SECTION 3. This Act shall take effect upon its approval.
