### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I									
2	SECTION 1. The purpose of this Act is to:									
3	(1) Authorize the development of a new Oahu community									
4	correctional center; and									
5	(2) Appropriate funds for an oversight coordinator									
6	position and necessary support staff positions for the									
7	Hawaii correctional system oversight commission, as									
8	authorized by section 353L-2, Hawaii Revised Statutes,									
9	for the fiscal biennium.									
10	PART II									
11	SECTION 2. (a) The department of public safety shall									
12	develop a new Oahu community correctional center in accordance									
13	with section 26-14.6, Hawaii Revised Statutes. The development									
14	may be phased to allow for the development of a new Oahu									
15	community correctional facility and a new mental health									
16	facility.
