(5) Recommend a weighted student formula to the board of
education;

3 (6) Perform any other function that may facilitate the 4 implementation of the weighted student formula; and 5 (7) Meet not less than once every odd-numbered year, to 6 review the weighted student formula and, if the 7 committee deems it necessary, recommend a new weighted 8 student formula for adoption by the board of 9 education.


10 (b) The composition of the committee on weights shall be 11 determined by the board of education based on recommendations 12 from the superintendent of education and dean of the University 13 of Hawaii at Manoa college of education and include principals, 14 teachers, and other members with the appropriate professional skills, experiences, and qualifications needed to facilitate the 15 16 work of the committee. The superintendent or the 17 superintendent's designee shall chair the committee on weights. 18 (C) The committee on weights may form advisory 19 subcommittees to obtain input from key stakeholders as 20 determined necessary by the committee.
