A BILL FOR AN ACT

RELATING TO COMMUNITY COLLEGE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Chapter 304A, Hawaii Revised Statutes, is
2	amended by	y adding a new section to part IV, subpart A,
3	subdivisio	on 1 to be appropriately designated and to read as
4	follows:	
5	" <u>\$304A-</u> Community college tuition waiver. (a) The	
6	board of 1	regents shall waive the tuition of any person who is
7	admitted t	to and enrolled full-time at a community college campus
8	of the Un	iversity of Hawaii; provided that the person:
9	(1)	Is a United States citizen or eligible non-citizen;
10	(2)	Has been a resident of the State for at least twelve
11		months prior to applying for the waiver;
12	(3)	Qualifies for resident tuition;
13	(4)	Maintains satisfactory academic progress, as
14		determined by the community college at which the

15 person is enrolled;



1	(5)	Maintains continuous full-time enrollment at a
2		community college, except for medical or personal
3		absences approved by the community college; and
4	(6)	Is physically present in the State.
5	(b)	As used in this subsection, an "eligible non-citizen"
6	means an	individual who is:
7	(1)	A United States permanent resident who holds a
8		permanent resident card;
9	(2)	A conditional permanent resident of the United States;
10		or
11	(3)	The holder of an arrival-departure record (I-94) from
12		the Department of Homeland Security showing any one of
13		the following designations:
14		(A) Refugee;
15		(B) Asylum granted;
16		(C) Parolee; or
17		(D) Cuban-Haitian Entrant."
18	SECT	ION 2. There is appropriated out of the general
19	revenues	of the State of Hawaii the sum of \$ or so
20	much ther	eof as may be necessary for fiscal year 2021-2022 and
21	the same	sum or so much thereof as may be necessary for fiscal

1	year 2022-2023 to establish and implement tuition waivers at
2	community college campuses of the University of Hawaii.
3	The sums appropriated shall be expended by the University
4	of Hawaii for the purposes of this Act.
5	SECTION 3. New statutory material is underscored.
6	SECTION 4. This Act shall take effect on July 1, 2021.
