#### A BILL FOR AN ACT

RELATING TO CHILDREN.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 577-25, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "[{| §577-25[}] Emancipation of [certain] minors. (a) Any
- 4 law to the contrary notwithstanding, a minor who has been
- 5 married pursuant to chapter 572 shall be deemed to be
- 6 emancipated and shall be regarded as though [he or she] the
- 7 minor were of legal age and shall have all the rights, duties,
- 8 privileges, and responsibilities provided by [the] civil law to
- 9 a person who has reached the age of majority under civil law;
- 10 provided that:
- 11 (1) Nothing in this [section] subsection shall be deemed
- to confer upon [such person] a minor the right to vote
- in any federal, state, or county election or the right
- to purchase, possess, or sell alcoholic beverages; and
- 15 (2) Nothing in this [section] subsection shall change the
- 16 status of [such persons as minors] a person as a minor
- in connection with any criminal law, nor affect the



1		exclusive original jurisdiction of the family court
2		over [such persons] a person under section 571-11(1).
3	(b)	A minor who has reached the age of sixteen may
4	petition	the family court in the circuit in which the minor
5	resides f	or a determination that the minor named in the petition
6	be emanci	pated. The petition shall:
7	(1)	Outline how the minor has demonstrated independent
8		capabilities, separate from the minor's parents or
9		guardians, in matters of care, custody, control, and
10		earnings; and
11	(2)	Be filed by the minor seeking emancipation. A parent
12		or guardian shall not petition, individually or on
13		behalf of the minor, for an order of emancipation.
. 14	(c)	Pursuant to a petition for emancipation under
15	subsectio	n (b), the court may:
16	(1)	Require child welfare services to investigate any
17		reports or allegations of child abuse or neglect and
18		to file a report of that investigation with the court;
19		<u>or</u>
20	(2)	Require the minor to receive a mental health
21		evaluation from an appropriate mental health

1		professional, as arranged for by the court or the
2		minor's parents or guardians.
3	(d)	Pursuant to a petition for emancipation under
4	subsectio	n (b), the court shall:
5	(1)	Appoint a guardian ad litem for the minor;
6	(2)	Appoint client-directed legal counsel to represent the
7		minor throughout the emancipation proceedings and
8		advise the minor regarding the rights,
9		responsibilities, and legal consequences associated
10		with emancipation;
11	(3)	Provide the minor with an informational pamphlet and
12		counseling explaining the minor's rights and
13		responsibilities as an emancipated minor and a listing
14		of alternatives to emancipation, if available;
15	(4)	Provide service of the petition and notice of hearing
16		to the minor's parents or legal guardians. If needed,
17		the court appointed counsel shall assist the minor to
18		locate the minor's parents or legal guardians. Upon a
19		showing of due diligence to locate the minor's parents
20		or legal guardians, the court may waive notice
21		requirements; and

1	<u>(5)</u>	At a hearing on the petition prior to issuing a ruling
2		on the petition, ensure the minor understands the
3		rights, responsibilities, and alternatives, if any, to
4		emancipation.
5	(e)	Pursuant to a petition for emancipation under
6	subsectio	n (b), the court may enter an order declaring the minor
7	emancipat	ed if, after a hearing, it is found by clear and
8	convincin	g evidence that:
9	(1)	The minor is on active duty with any of the armed
10		forces of the United States of America; or
11	(2)	The minor willingly resides separate and apart from
12		the minor's parents or legal guardians irrespective of
13		their consent, the minor understands the rights,
14		responsibilities, and alternatives, if any, to
15		emancipation, the minor is currently self-supporting
16		or is capable of self-support and managing the minor's
17		own financial affairs, and that emancipation is in the
18		best interest of the minor.
19	(f)	A minor emancipated under subsection (e) shall be
20	considere	d to have the rights and responsibilities of an adult,
21	except fo	r those specific constitutional and statutory age

Ţ	requiremen	nts including but not limited to voting, consuming or
2	purchasing	g liquor, and other relevant health and safety
3	regulation	ns imposed based on age. A minor shall be considered
4	emancipate	ed for the purposes of, but not limited to, all of the
5	following:	<u>:</u>
6	(1)	The right to enter into enforceable contracts,
7		including apartment leases;
8	(2)	The right to sue or be sued in the minor's own name;
9	(3)	The right to retain personal earnings;
10	(4)	The right to establish a separate domicile;
11	(5)	The right to act autonomously, and with the rights and
12		responsibilities of an adult, in all business
13		relationships, including but not limited to property
14		transactions and obtaining accounts for utilities,
15		except for estate or property matters that a court
16		determines may require a conservator or guardian ad
17		<pre>litem;</pre>
18	<u>(6)</u>	The right to earn a living, subject only to the health
19		and safety regulations designed to protect those under
20		the age of majority regardless of their legal status;

1	(7)	The right to file as an individual under state
2		statutes and rules regarding income taxes;
3	(8)	The right to authorize personal preventive health
4		care, medical care, dental care, mental health care,
5		and substance abuse treatment without knowledge or
6		liability of a parent or legal guardian;
7	(9)	The right to apply for a driver's license or other
8		state licenses for which the minor may be eligible;
9	(10)	The right to register for school;
10	(11)	The right to marry;
11	(12)	The right to personally apply for medical and other
12		public assistance benefits administered by the State
13		or the counties, if needed;
14	(13)	The right, if the minor is a parent, to make decisions
15		and give authority in caring for the minor's child;
16		and
17	(14)	The right to execute a will and other estate planning
18		documents, including trust documents, durable power of
19		attorney, and an advance health care directive.
20	<u>(g)</u>	The court may require a minor's parents or legal
21	guardians	to pay for any services ordered by the court for the

- 1 minor pursuant to a petition for emancipation under subsection
- 2 (b), including service of the petition, the guardian ad litem,
- 3 legal counsel, or mental health providers.
- 4 (h) If a petitioning minor has an active case under
- 5 chapter 587A pursuant to sections 571-11(9) and 587A-5, then the
- 6 proceeding for emancipation shall be stayed until the final
- 7 disposition of the chapter 587A case.
- 8 (i) For the purposes of this section, "minor" means a
- 9 person under the age of majority."
- 10 SECTION 2. This Act does not affect rights and duties that
- 11 matured, penalties that were incurred, and proceedings that were
- 12 begun before its effective date.
- 13 SECTION 3. Statutory material to be repealed is bracketed
- 14 and stricken. New statutory material is underscored.
- 15 SECTION 4. This Act shall take effect upon its approval.

#### Report Title:

Emancipation of Minors; Children; Parents; Family Court

#### Description:

Allows a minor who has reached the age of 16 to petition the Family Court for emancipation, and directs the court regarding investigation of the petition, appointment of legal counsel and a guardian ad litem for the petitioner, and the findings necessary to grant the petition. Specifies the rights gained by the minor upon emancipation and authorizes the court to require the minor's parents or legal guardians to pay for any services ordered by the court. Requires emancipation proceedings to be stayed until final disposition of the minor's child protective case under Chapter 587A, HRS.
