### A BILL FOR AN ACT

RELATING TO METROPOLITAN PLANNING ORGANIZATIONS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 279D-3, Hawaii Revised Statutes, is 2 amended to read as follows:
- 3 "[+] §279D-3[+] Establishment of metropolitan planning
- 4 organizations; duties. (a) Metropolitan planning organizations
- 5 shall be designated pursuant to 23 United States Code section
- 6 134(d)(1) and shall meet all requirements of 23 United States
- 7 Code sections 134-135 and 49 United States Code sections 5303-
- 8 5304, as amended, and any federal regulations adopted pursuant
- 9 thereto.
- 10 (b) A metropolitan planning organization shall:
- 11 (1) Operate according to executed comprehensive
- agreements, including any supplemental agreements,
- between the State, county, and other operators of
- 14 public transportation receiving federal funds; and
- 15 (2) Facilitate and support the continuing, cooperative,
- and comprehensive transportation planning process
- between the State, county, and other operators of

I		public transportation receiving federal funds,
2		including the consideration of projects and strategies
3		that support national planning factors as defined in
4		23 United States Code section 134, regional goals and
5		objectives, and consideration of plans and planning
6		activities of others as they affect transportation.
7	(c)	A metropolitan planning organization may:
8	(1)	Assign to staff members duties not defined or
9		designated by federal law, this chapter, or executive
10		agreement;
11	(2)	Enter into agreements with the State, county, other
12		operators of public transportation receiving federal
13		funds, and other entities as needed to fully comply
14		with all requirements of federal law and this chapter;
15	(3)	Be placed within a state or county agency, as
16		appropriate, for administrative purposes only;
17	(4)	Contract to purchase goods and services, including
18		professional and technical assistance and advice;
19	(5)	Contract for or accept revenues, compensation,
20		proceeds, and gifts or donations or grants in any form
21		from any public agency; and

2		public or private organizations for the use of their
