A BILL FOR AN ACT

RELATING TO HAWAIIAN AFFAIRS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that article XII, section
- 2 2, of the Hawaii State Constitution states in part: "The State
- 3 and its people do further agree and declare that the spirit of
- 4 the Hawaiian Homes Commission Act looking to the continuance of
- 5 the Hawaiian homes projects for the further rehabilitation of
- 6 the Hawaiian race shall be faithfully carried out." Affording
- 7 the opportunity to utilize lands designated for agriculture by
- 8 the department of Hawaiian home lands would allow for increased
- 9 revenue for both beneficiaries and the department of Hawaiian
- 10 home lands.
- 11 The purpose of this Act is to increase the number of
- 12 medical cannabis dispensaries by requiring the department of
- 13 health to issue eight dispensary licenses to the department of
- 14 Hawaiian home lands.
- 15 SECTION 2. Chapter 329D, Hawaii Revised Statutes, is
- 16 amended by adding a new section to be appropriately designated
- 17 and to read as follows:



1	"§329D- Medical cannabis dispensaries on Hawaiian home				
2	lands. (a) The department shall issue to the department of				
3	Hawaiian home lands eight dispensary licenses; provided that two				
4	dispensary licenses shall be issued for the city and county of				
5	Honolulu; three dispensary licenses shall be issued for the				
6	county of Hawaii with one for east Hawaii, one for north Hawaii,				
7	and one for west Hawaii; two dispensary licenses shall be issued				
8	for the county of Maui, one for Maui and one for Molokai; and				
9	one dispensary license shall be issued for the county of Kauai.				
10	(b) The department shall advise and assist the department				
11	of Hawaiian home lands in establishing a license application				
12	procedure and verification in accordance with section 329D-4 and				
13	the selection process in accordance with section 329D-5 to				
14	include the criteria of section 329D-7(3).				
15	(c) Each application for a dispensary license shall				
16	include both an individual applicant and an applying entity.				
17	The application shall be submitted to the department of Hawaiian				
18	home lands and shall include supporting documentation to				
19	establish the following:				
20	(1) That the individual applicant:				

1		<u>(A)</u>	Is native Hawaiian as defined in section 201 of
2			the Hawaiian Homes Commission Act;
3		<u>(B)</u>	Has been a legal resident of the State for not
4			less than five years preceding the date of
5			application;
6		<u>(C)</u>	Is not less than eighteen years of age; and
7		(D)	Has had no felony convictions;
8	(2)	That	the applying entity:
9		(A)	Has been organized under the laws of the State;
10		<u>(B)</u>	Has a Hawaii tax identification number;
11		<u>(C)</u>	Has a department of commerce and consumer affairs
12			business registration division number and suffix;
13		<u>(D)</u>	Has a federal employer identification number;
14		<u>(E)</u>	Is not less than fifty-one per cent held by
15			native Hawaiians as defined in section 201 of the
16			Hawaiian Homes Commission Act or entities wholly
17			controlled by native Hawaiians as defined in
18			section 201 of the Hawaiian Homes Commission Act
19			who have been Hawaii legal residents for not less
20			than five years immediately preceding the date
21			the application was submitted.

1	<u>(F)</u>	Has financial resources under its control of not		
2		less than \$1,000,000 for the license applied for,		
3		plus not less than \$100,000 for each retail		
4		dispensing location allowed under the license		
5		applied for, in the form of bank statements or		
6		escrow accounts, and that the financial resources		
7		have been under the control of the applying		
8		entity for not less than ninety days immediately		
9		preceding the date the application was submitted;		
10		and		
11	<u>(G)</u>	Is composed of principals or members, each of		
12		whom has no felony convictions.		
13	A dispensary l	icense shall not be sold or otherwise transferred		
14	from one perso	n to another person. No person may be granted		
15	more than one	dispensary license.		
16	(d) Medi	cal cannabis production centers and dispensaries		
17	on Hawaiian ho	me lands are not subject to county zoning,		
18	ordinances, ru	les, or regulations."		
19	SECTION 3	. The provisions of the amendments made by this		
20	Act to the Hawaiian Homes Commission Act, 1920, as amended, are			
21	declared to be	severable, and if any section, sentence, clause,		

- 1 or phrase, or the application thereof to any person or
- 2 circumstances is held ineffective because there is a requirement
- 3 of having the consent of the United States to take effect, then
- 4 that portion only shall take effect upon the granting of consent
- 5 by the United States and effectiveness of the remainder of these
- 6 amendments or the application thereof shall not be affected.
- 7 SECTION 4. New statutory material is underscored.
- 8 SECTION 5. This Act shall take effect upon its approval.
