BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 Section 28-8.3, Hawaii Revised Statutes, is SECTION 1. 2

Authorizes the Department of Hawaiian Home Lands to use the services of the Attorney General as needed and when the interests of the State and the Department of Hawaiian Home Lands are aligned. Provides that funds owed to independent legal counsel shall be paid by the State.
