### A BILL FOR AN ACT

RELATING TO ANIMAL FUR PRODUCTS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that animals were 2 historically hunted and trapped for food, and their pelts were 3 used to provide protective clothing. Over time, clothing technology has developed, making fur a luxury item, rather than 4 5 a necessity. Fur garments are typically designed for fashion 6 rather than for warmth, and more animals are now killed to make decorative fur trim than to manufacture full fur garments. 7 Due 8 to serious animal welfare concerns, more and more countries are 9 phasing out fur farming and enacting fur farming bans.

10 The legislature recognizes that more than one hundred million animals are violently killed every year solely for their 11 fur. More than eighty-five per cent of pelts in the world's fur 12 13 trade come from fur farms, while the remaining fifteen per cent 14 of pelts are from animals trapped in the wild. The legislature finds that, especially considering the wide array of faux fur 15 and other fashion and apparel alternatives, the demand for fur 16 17 products does not justify the cruel treatment and unnecessary

1 killing of animals. Eliminating the sale of fur products in Hawaii will foster a more humane environment in the State. 2 3 The legislature further finds that the fur trade poses 4 serious human health and animal welfare concerns. Recent 5 reports from mink fur farms abroad have revealed dangerous links 6 between the industry and the further spread of the SARS-CoV-2 7 virus to humans from animals. Additionally, mink, raccoon, dogs, and foxes that are commonly farmed for their fur have been 8 9 linked to a variety of coronaviruses. 10 The legislature further finds that fur farming can be 11 damaging to the environment and contributes to water and air 12 pollution in multiple ways. Fur farming often involves the use 13 of toxic chemicals, including chromium and formaldehyde, which 14 can seep into ground water and other water sources. For each 15 kilogram of factory-farmed mink fur produced, one hundred ten

16 kilograms of carbon dioxide are released into the atmosphere.
17 Fur farming also consumes significant quantities of energy and
18 water; producing a real fur garment uses more than fifteen times
19 the energy needed to produce a faux fur garment.

20 The legislature acknowledges that existing laws provide21 relatively little oversight of the fur trade industries.

1 Compliance with guidelines issued by the American Veterinary 2 Medical Association is not mandatory, and fur farms are not 3 monitored or inspected by any government agency. Federal laws 4 do not prohibit the import or export of dog or cat fur products into the United States, prohibit the introduction of dog or cat 5 6 fur products into interstate commerce, forbid deceptive labeling 7 of fur products, or require products made with real fur to be 8 properly labeled. Imposition of such requirements would allow 9 Hawaii consumers to choose whether to purchase real or faux fur 10 garments.

11 As human, animal, and ecosystem health are inextricably linked, it is vital for our health, economy, and security that 12 13 Hawaii, the United States, and countries across the globe shut 14 down the cruel, risky, and unpopular fur farming industry and 15 end the fur trade by banning fur sales. Accordingly, the 16 purpose of this Act is to prohibit the manufacture for sale, 17 offer for sale, display for sale, sale, trade, or distribution 18 of certain animal fur products in the State.

19 SECTION 2. The Hawaii Revised Statutes is amended by 20 adding a new chapter to be appropriately designated and to read 21 as follows:

1 (5) The pelt or skin of any animal that is preserved 2 through taxidermy or for the purposes of taxidermy. 3 "Nonprofit organization" means any entity organized under 4 title 26 United States Code section 501(c)(3) for charitable, 5 religious, philanthropic, educational, or similar purposes. 6 "Taxidermy" means the practice of preparing and preserving 7 the skin of an animal that is deceased and stuffing and mounting 8 it in lifelike form. 9 "Ultimate consumer" means an individual who buys a fur 10 product for the individual's own use, or for the use of another, 11 but not for resale or trade. 12 "Used fur product" means a fur product that has been worn 13 or used by an ultimate consumer. 14 -2 Manufacture of fur products for sale prohibited; S It shall be unlawful to manufacture fur 15 exemption. 9 (c) The director shall issue a warning notice to a person 10 for the person's violation of this chapter. The person shall 11 remedy the violation within twenty-four hours of receipt of the 12 warning notice or be subject to the penalties provided by this 13 section or rules adopted pursuant to this section.

This Act does not affect rights and duties that 5 matured, penalties that were incurred, and proceedings that were 6 begun before its effective date. 7 SECTION 4. If any provision of this Act, or the 8 application thereof to any person or circumstance, is held 9 invalid, the invalidity does not affect other provisions or 10 applications of the Act that can be given effect without the 11 invalid provision or application, and to this end the provisions 12 of this Act are severable. 13 SECTION 5. This Act shall take effect upon its approval.
