### A BILL FOR AN ACT

RELATING TO HEALTH.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that there is a shortage
- 2 of primary care providers in the State, which will be
- 3 exacerbated by the projected retirements of current physicians,
- 4 advanced practice registered nurses, and pharmacists. Further,
- 5 although students are interested in pursuing careers in the
- 6 health care service industry in Hawaii, in-state educational
- 7 institutions are constrained by the lack of clinical education
- 8 sites in Hawaii and limited supply of qualified primary care
- 9 preceptors. One way to encourage the participation of
- 10 preceptors is to offer an income tax credit for professionals
- 11 who serve as preceptors.
- 12 The purpose of the existing healthcare preceptor income tax
- 13 credit is to incentivize volunteer preceptors to offer
- 14 professional instruction, training, and supervision to students
- 15 and residents seeking careers as healthcare providers. During
- 16 the first-year implementation of the tax credit, a large number
- 17 of providers trained eligible students in 2019, but only a small

- subset met the eligibility requirements due to the primary care
  qualifying criteria.
- 3 The legislature further finds that training physicians,
- 4 advanced practice registered nurses, and pharmacists in primary
- 5 care requires training from specialties that support primary
- 6 care, in addition to training from primary care providers. The
- 7 legislature also finds that the definition of "volunteer-based
- 8 supervised clinical training rotation" may be clarified to
- 9 facilitate the preceptor credit assurance committee's
- 10 implementation of the tax credit.
- 11 Therefore, the purpose of this Act is to:
- 12 (1) Amend the definitions of "preceptor" and "volunteer-
- based supervised clinical training rotation" to
- 14 improve accessibility for providers to receive income
- tax credits for acting as preceptors; and
- 16 (2) Revise the membership of the preceptor credit
- 17 assurance committee to include the director of health.
- 18 SECTION 2. Section 235-110.25, Hawaii Revised Statutes, is
- 19 amended by amending subsection (g) to read as follows:
- 20 "(g) For the purposes of this section:

1 "Academic program" means an academic degree granting 2 program or graduate medical education program that: 3 (1)Holds either its principal accreditation or a physical location in Hawaii; and 4 Provides education to students, of whom more than 5 (2) 6 fifty per cent are residents of Hawaii. 7 "Advanced practice registered nurse student" means an 8 individual participating in a nationally accredited academic 9 program that is for the education of advanced practice 10 registered nurses and recognized by the state board of nursing 11 pursuant to chapter 457. 12 "Eligible professional degree or training certificate" 13 means a degree or certificate that fulfills a requirement to be 14 a physician or osteopathic physician, pursuant to chapter 453, 15 an advanced practice registered nurse, pursuant to chapter 457, 16 or a pharmacist, pursuant to chapter 461. 17 "Eliqible student" means an advanced practice registered 18 nurse student, medical student, or pharmacy student who is 19 enrolled in an academic program.

"Medical student" means an individual participating in a

- 6 certification.
- 7 "Nationally accredited" means holding an institutional
- 8 accreditation by name to offer post-secondary medical primary
- 9 care education. Accreditation for medical students shall be
- 10 offered by the Liaison Committee on Medical Education or
- 11 American Osteopathic Association Commission on Osteopathic
- 12 College Accreditation. Accreditation for advanced practice
- 13 registered nurse students shall be offered by the Commission on
- 14 Collegiate Nursing Education.
- 15 "Pharmacy student" means an individual participating in an
- 16 academic program that is nationally accredited for the training
- 17 of individuals to become registered pharmacists pursuant to
- 18 chapter 461.
- 19 "Preceptor" means a physician or osteopathic physician,
- 20 licensed pursuant to chapter 453, an advanced practice
- 21 registered nurse, licensed pursuant to chapter 457, or a

- 1 pharmacist, licensed pursuant to chapter 461, who is a resident
- 2 of Hawaii [and who], maintains a professional [primary care]
- 3 practice in this State[-], and whose specialty supports the
- 4 development and training of an eligible student in primary care.
- 5 "Primary care" means the principal point of continuing care
- 6 for patients provided by a healthcare provider, including health
- 7 promotion, disease prevention, health maintenance, counseling,
- 8 patient education, diagnosis and treatment of acute and chronic
- 9 illnesses, and coordination of other specialist care that the
- 10 patient may need.
- "Volunteer-based supervised clinical training rotation"
- 12 means [an uncompensated] a period of supervised clinical
- 13 training [0f] to an eligible student that totals at least eighty
- 14 hours of supervisory time annually, in which a preceptor
- 15 provides personalized instruction, training, and supervision to
- 16 an eligible student to enable the eligible student to obtain an
- 17 eligible professional degree or training certificate[-];
- 18 provided that, while a preceptor may be compensated for
- 19 providing standard clinical services, the preceptor shall be:
