A BILL FOR AN ACT

RELATING TO PUBLIC EMPLOYMENT COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

PART I

SECTION 1. There are appropriated or authorized from the sources of funding indicated below to collective bargaining statewide (BUF 102) the following sums or so much thereof as may be necessary to fund for fiscal biennium 2021-2023 all collective bargaining cost items in the agreement negotiated with the exclusive representative of collective bargaining unit (4):

 14 from the respective funds.


15 SECTION 22. The fiscal year 2021-2022 appropriations under
 16 this Act shall not lapse until the end of fiscal biennium 2021-
 17 2023; provided that funds appropriated or authorized by this Act
 18 that are not expended or encumbered by June 30, 2023, shall
 19 lapse as of that date.

Provides appropriations for collective bargaining cost items for the members of bargaining unit (4) and their excluded counterparts, including the cost of salary adjustments and Hawaii employer-union health benefits trust fund costs negotiated between the State and the bargaining unit representative for fiscal biennium 2021-2023.
