SENATE CONCURRENT RESOLUTION

AFFIRMING SUPPORT FOR THE PURCHASE, PRESERVATION, AND RESTORATION OF AGRICULTURAL AND CONSERVATION LANDS IN MAUNAWILI VALLEY, OAHU TO PROTECT THE IMPORTANT ANCIENT AND HISTORIC SITES, TRAILS, AND WATERS IN MAUNAWILI VALLEY.

WHEREAS, Maunawili Valley in the ahupuaa (land division) of 1 Kailua is celebrated in story and chant for its association with 2 3 akua (gods), alii (chiefs), cultural heroes, and important 4 historical figures, including Queen Liliuokalani; and 5 6 WHEREAS, Maunawili Valley contains wetlands, streams, and 7 freshwater springs that provide most of the water that flows to the Kawainui Marsh ecosystem and more than fifty springs and 8 smaller streams are present, including Maunawili Stream, the 9 10 most significant stream in the Kailua ahupuaa; and 11 WHEREAS, ancient and historic sites throughout Maunawili 12 13 Valley include heiau (temples or sacred sites), sacred stones, petroqlyphs, Hawaiian burials, ala hele and alahula (paths or 14 15 trails), house sites, grinding stones, irrigated and dryland agricultural terraces, large auwai (irrigation ditches) related 16 17 to extensive loi (taro patches), and nineteenth and early twentieth century structures related to agriculture and food 18 19 production; and 20 21 WHEREAS, Kawainui Marsh is a designated Ramsar Wetland of 22 International Importance; and 23 24 WHEREAS, the 1994 Kawainui Master Plan recommended that the State acquire the privately-owned wetland/semi-wetland areas in 25 Maunawili, noting that they are hydrologically part of the 26 economic, ecological, and cultural resources of Kawainui Marsh, 27 28 separated only by the highway, and that acquisition would "protect the wetlands from future undesired developments" and 29 inappropriate alteration of the landscape and waterways; and 30

1 2 WHEREAS, there is a need to protect and conserve the Maunawili wetlands, semi-wetlands, Maunawili's Hanalei soil, 3 which is the most fertile soil in Hawaii, fresh water resources, 4 ancient and historic sites, and historic trails within the vital 5 context of agricultural sustainability; and 6 7 8 WHEREAS, there is a need to provide managed and restricted access to the State's Maunawili and Olomana Trails in proximity 9 to Maunawili Historic Wetland/Semi-Wetland areas and The Queen's 10 Retreat; and 11 12 WHEREAS, there is a long history of public interest in 13 14 acquiring and protecting lands in Maunawili, but the State has 15 not been able to secure these Maunawili lands, which remain 16 privately owned; and 17 18 WHEREAS, HRT Realty, LLC, owns more than one thousand acres in Maunawili, including most of the biocultural resources noted 19 20 above as well as the Royal Hawaiian Golf Course; and 21 22 WHEREAS, HRT Realty, LLC, has expressed an interest in selling its Maunawili lands, or a significant portion thereof, 23 24 to the Department of Land and Natural Resources and Department 25 of Agriculture, working in partnership with The Trust for Public Land, Hui Maunawili-Kawainui, and the Kailua community; and 26 27 WHEREAS, the Hui Maunawili-Kawainui is a group of 28 29 descendants and residents of Maunawili and Kailua who represent 30 a coalition of respected Hawaiian cultural and environmental organizations, who have joined to protect prime agricultural and 31 32 culturally significant lands in Maunawili; and 33 WHEREAS, Hui Maunawili-Kawainui seeks to restore the health 34 of Maunawili so that the valley can resume its vital and 35 36 traditional role in the ahupuaa of Kailua as a source of free-37 flowing fresh water and a place of abundant agriculture and rich 38 cultural resources; and 39 40 WHEREAS, Governor David H. Ige has declared a state goal to 41 double local food production by 2020, which is in line with

Maunawili's legacy as historically fertile ground to produce 1 2 food crops; and 3 WHEREAS, Hui Maunawili-Kawainui members have met with 4 representatives of HRT Realty, LLC, and are now working in 5 partnership with The Trust for Public Land, a national nonprofit 6 organization that has helped to protect lands throughout Hawaii, 7 to identify ways to acquire HRT properties in Maunawili; and 8 9 WHEREAS, this is a rare opportunity to secure Maunawili's 10 irreplaceable resources for the health and welfare of the people 11 of Hawaii today and for future generations; now, therefore, 12 13 14 BE IT RESOLVED by the Senate of the Thirty-first Legislature of the State of Hawaii, Regular Session of 2021, the 15 House of Representatives concurring, that this body affirms 16 support for the purchase, preservation, and restoration of 17 agricultural and conservation lands in Maunawili Valley, Oahu, 18 and for the protection and preservation of important ancient and 19 historic sites and trails and waters in Maunawili; and 20 21 BE IT FURTHER RESOLVED that this body believes that it is 22 23 in the best interest of the people of the State to realize the larger, community-based vision of restoring Maunawili to its 24 vital and traditional role in the ahupuaa of Kailua as a source 25 26 of free-flowing fresh water and place of abundant agriculture and rich cultural resources; and 27 28 BE IT FURTHER RESOLVED that this body urges the Department 29 of Land and Natural Resources, Department of Agriculture, and 30 other relevant state entities, as well as the City and County of 31 Honolulu, and Hawaii congressional delegation, to work with The 32 Trust for Public Land and the Hui Maunawili-Kawainui in their 33 efforts to acquire these important and rich agricultural, 34 35 cultural, and historic lands; and 36 37 BE IT FURTHER RESOLVED that certified copies of this Concurrent Resolution be transmitted to Hawaii's congressional 38 39 delegation, the Governor, Chairperson of the Board of Land and Natural Resources, Chairperson of the Board of Agriculture, 40 Mayor of the City and County of Honolulu, Chairperson of the 41 Honolulu City Council, Councilmember of District 3 of the City 42





1 and County of Honolulu, Chairperson of the Board of Trustees of
