SENATE CONCURRENT RESOLUTION

REQUESTING THE GOVERNOR TO CONVENE AND PARTICIPATE IN THE HAWAII CIRCULAR ECONOMY TASK FORCE THAT SUPPORTS HAWAII'S TRANSITION TOWARD A CIRCULAR ECONOMY BY 2035.

WHEREAS, the planet will reach a crucial threshold of 1 climate change as early as 2030, and rising global temperatures 2 threaten biodiversity in every ecosystem and cause widespread 3 effects, including sea level rise; and 4 5 WHEREAS, climate change is an emergency that requires 6 7 changes in Hawai'i's energy, agriculture, mobility, water, 8 construction, industrial sectors, and development infrastructure to promote the health and well-being of the 'āina and kānaka; and 9 10 11 WHEREAS, the Hawai'i Climate Change Mitigation and 12 Adaptation Commission reports that a climate-ready Hawai'i looks to Hawai'i's ahupua'a concept, or the Hawaiian tenure system, 13 because of the effective management of watersheds and 14 agricultural lands, the protection of environmental and 15 community health, and connecting communities with kuleana, or 16 responsibility, to land and ocean environments; and 17 18 19 WHEREAS, a circular economy models the transition of economic activities to be regenerative, equitable, resource 20 efficient, and sustainable, yet still competitive, by closing 21 22 loops within economic models; and 23 24 WHEREAS, a circular economy focuses on the sustainable management of resources, specifically designing out waste and 25 26 pollution, maintaining the value of existing products and materials, and regenerating natural systems; and 27

22 23 24 25	WHEREAS, there is a resurgence in demand for Hawai'i to reshape its economy to eliminate the overdependence on extractive industries; and
26 27 28 29	WHEREAS, the adoption of a circular economy in Hawai'i would model traditional Hawaiian values, including the core value of aloha 'āina; and
30 31 32 33 34 35 36	WHEREAS, aloha 'āina represents a deep and abiding love for Hawai'i's communities and natural environment, while placing 'ike kūpuna, or native Hawaiian ancestral knowledge, as the foundation upon which collective action is determined to achieve pono, or balanced, management of our resources and community health; and
30 37 38 39 40	WHEREAS, aloha 'āina promotes an abundant economic system that establishes inherently circular processes and structures such as lo'i kalo and loko i'a, which continue to be utilized by Hawaiian communities today; and

WHEREAS, a statewide survey found that Hawai'i residents 1 support growing green economic industries such as food 2 production, forestry, and natural resource management, and 3 express community interest in economic transition toward more 4 sustainable initiatives; and 5 6 WHEREAS, over two thousand seven hundred individuals, 7 businesses, and organizations have expressed their support and 8 commitment for the State to adopt aloha 'āina principles through 9 the 'Aina Aloha Economic Futures Declaration; and 10 11 WHEREAS, the principles of a circular economy would also 12 help advance multiple initiatives, including those created by 13 the Hawai'i Climate Change Mitigation and Adaptation Commission, 14 Greenhouse Gas Sequestration Taskforce, Hawai'i Clean Energy 15 16 Initiative, Hawai'i 2050 Sustainability Plan, and Aloha+ Challenge; and 17 18 WHEREAS, Hawai'i is a leader in climate change and renewable 19 20 energy goals and has the potential to model an economy rooted in centuries of island-based values, such as sustainable practices, 21 environmental health, and community well-being; and 22 23 WHEREAS, with the adoption of circular economy goals that 24 25 are practiced internationally in partnership with aloha 'āina principles, Hawai'i is poised to become a global leader in the 26 transition toward a circular economy grounded in indigenous 27 28 values; now, therefore, 29 BE IT RESOLVED by the Senate of the Thirty-first 30 Legislature of the State of Hawaii, Regular Session of 2021, the 31 House of Representatives concurring, that the Governor is 32 requested to convene and participate in the Hawai'i Circular 33 Economy Task Force that supports Hawaii's transition toward a 34 circular economy by 2035; and 35 36 37 BE IT FURTHER RESOLVED that any recommendations made by the 38 task force achieve the following objectives: 39 Consideration of circular economy values in decision-40 (1)making in all economic transition efforts across 41
