## SENATE RESOLUTION

URGING THE DEPARTMENT OF LAND AND NATURAL RESOURCES TO ADOPT ADMINISTRATIVE RULES TO STREAMLINE THE PROCESS FOR ALLOWING TRADITIONAL HAWAIIAN FARMING SYSTEMS ON CONSERVATION LANDS.

WHEREAS, the State enacted Act 31, Session Laws of Hawaii 1 2015, which encouraged, as agricultural objectives of the State, 2 the growth and development of traditional Hawaiian farming 3 systems and traditional Hawaiian crops, as well as small-scale 4 5 farms; and 6 WHEREAS, the rights of native Hawaiians are codified in 7 articles IX and XII of the Constitution of the State of Hawaii, 8 9 as well as other state laws and judicial decisions; and 10 WHEREAS, Hawai'i's traditional farming systems, such as loko 11 i'a (fishponds), māla (cultivated gardens), and lo'i (irrigated 12 13 patches) were important agricultural technologies that once 14 sustained a thriving and robust island community; and 15 16 WHEREAS, traditional Hawaiian farming systems play a critical role in Hawaii and should be encouraged to promote 17 greater self-sufficiency, crop diversity, and food security; and 18 19 WHEREAS, traditional Hawaiian crops like kalo, 'uala (sweet 20 potato), limu (various seaweeds), 'awa (kava), hō'i'o (large 21 native fern), and 'olena (turmeric) that were cultivated using 22 these traditional Hawaiian farming techniques continue to be 23 24 important agricultural products for food, medicine, and cultural 25 practices today; and 26 27 WHEREAS, supporting traditional Hawaiian farming systems is critical towards helping the State achieve food security and 28 29 increasing domestic production of a local food supply; and 30 WHEREAS, streamlining the permitting process for loko i'a, 31 traditional fishponds, has had a significant beneficial impact 32 33 throughout the islands; and 34

1 WHEREAS, traditional farming and the native Hawaiian 2 culture generally play a vital role in preserving and advancing the quality of life and cultural vitality of Hawaii; and 3 4 WHEREAS, the State of Hawai'i has an affirmative obligation 5 to ensure that its regulatory actions do not adversely impact 6 the constitutionally protected rights of native Hawaiians; now, 7 therefore, 8 9 BE IT RESOLVED by the Senate of the Thirty-first 10 Legislature of the State of Hawaii, Regular Session of 2021, 11 that the Department of Land and Natural Resources is urged to 12 adopt administrative rules to streamline the process for 13 14 allowing traditional Hawaiian farming systems on conservation 15 lands; and 16 BE IT FURTHER RESOLVED that certified copies of this 17 Resolution be transmitted to the Governor, Chairperson of the 18 Board of Land and Natural Resources, Attorney General, 19 Chairperson of the Board of Trustees of the Office of Hawaiian 20 Affairs, and Chairperson of the Environmental Council. 21 22 23 24 OFFERED BY:
