## SENATE RESOLUTION

CONDEMNING AND DENOUNCING ALL FORMS OF ANTI-ASIAN SENTIMENT AND ALL ACTS OF RACISM, XENOPHOBIA, INTOLERANCE, DISCRIMINATION, HATE CRIME, AND HATE SPEECH AGAINST ASIAN AMERICANS AND ASIAN INDIVIDUALS IN THE UNITED STATES.

WHEREAS, racism and discrimination towards individuals of 1 2 Asian origin based on unfounded fear have always existed in the 3 United States, manifesting in hate crimes and enactment of 4 racist laws such as: 5 6 (1)The Chinese Massacre of 1871, in which twenty Chinese men were lynched by five hundred white men in Los 7 8 Angeles who were provoked by "yellow peril" - fear of an Asian invasion and resentment of cheap labor coming 9 10 from China; 11 The Chinese Exclusion Act of 1882 that banned new (2)12 Chinese immigrants and prevented existing Chinese 13 14 residents from becoming U.S. citizens until 1943, instigated by the same fear against individuals of 15 Chinese descent; 16 17 18 (3) The internment and confiscation of property of over 120,000 Japanese Americans during World War II, due to 19 20 war propaganda depicting Asians as crafty and cunning, despite many of their families fighting against the 21 Japanese as members of the United States armed forces; 22 23 (4) The 1982 symbolic murder of Vincent Chin, a Chinese 24 25 American, by white automobile workers enraged by the success of Japanese automobile manufacturers in the 26 United States at a time when America was losing 27 manufacturing jobs; and 28 29 The revenge-motivated crimes against Hindus, Muslim, 30 (5) 31 and Sikhs, many of whom were South Asians, in the wake of the September 11, 2001, terrorist attacks; and 32 33



WHEREAS, despite the undeniable history of persistent 1 2 discrimination, violence, and hate crimes against Asians in the 3 United States, racism against Asians is often considered 4 nonexistent, insignificant, or justified, due to a false but 5 pervasive stereotype about the Asian community being a "model minority", a myth that was created during the Civil Rights era 6 to stymie racial justice movements, which suggests a fallacy 7 8 that Asian Americans are more successful than other ethnic 9 minorities, and therefore, they do not experience struggle, 10 racial discrimination, violence, or hate crimes; and 11 12 WHEREAS, as the coronavirus disease 2019 (COVID-19) pandemic began to spread across the United States in early 2020, 13 14 prominent public figures and the media utilized politicallycharged, inflammatory, and xenophobic rhetoric when referring to 15 COVID-19 as the "Chinese virus", "Wuhan virus", and "kung flu" 16 to push a disproved theory that COVID-19 originated in a lab in 17 China; and 18 19 20 WHEREAS, according to a poll taken of the adult population in the United States, including Alaska and Hawaii, approximately 21 22 three in ten Americans blame China or Chinese people for the 23 pandemic; and 24 WHEREAS, anti-Asian sentiment surged and random crimes and 25 hate crimes against Asians skyrocketed, instigating violent 26 27 attacks against individuals of not only Chinese, but also of Thai, Vietnamese, Filipino, and Japanese origin; and 28 29 30 WHEREAS, an August 2020 report by the United Nations found more than one thousand eight hundred racist incidents against 31 Asians in the United States over an eight-week period from March 32 33 to May 2020, and data from the New York Police Department showed a one thousand nine hundred percent increase in anti-Asian hate 34 crimes in New York City in 2000; and 35 36 37 WHEREAS, the persistent discrimination, violence, and hate crimes against Asians in the United States are placing Asian 38 39 individuals and their families, communities, and businesses at 40 risk; and 41



WHEREAS, advancing inclusion and belonging for people of 1 2 all races, national origins, and ethnicities is critical to the 3 safety and security of the people of the United States; and 4 5 WHEREAS, rooted deeply in the culture of Hawaii is the "Aloha Spirit" that is codified in section 5-7.5(a), Hawaii 6 7 Revised Statutes, as "the coordination of mind and heart within 8 each person" that "brings each person to the self," under which 9 "each person must think and emote good feelings to others"; and 10 11 WHEREAS, "Aloha" is "more than a word of greeting or farewell or a salutation", but "means mutual regard and 12 affection and extends warmth in caring with no obligation in 13 14 return" and constitutes "the essence of relationships in which each person is important to every other person for collective 15 existence"; now, therefore, 16 17 18 BE IT RESOLVED by the Senate of the Thirty-first 19 Legislature of the State of Hawaii, Regular Session of 2021, that this body condemns and denounces all forms of anti-Asian 20 sentiment and all acts of racism, xenophobia, intolerance, 21 22 discrimination, hate crimes, and hate speech against Asian Americans and Asian individuals in the United States; and 23 24 25 BE IT FURTHER RESOLVED that this body asserts the State's commitment to diversity, inclusiveness, equality, and 26 27 compassion, in the spirit of Aloha to serve as a positive role model for not only the United States but also for the people of 28 other nations, global alliances, and unions to ensure that all 29 members of the Asian community, regardless of their background, 30 spoken language, or religious beliefs, are treated with dignity 31 and equity; and 32 33 34 BE IT FURTHER RESOLVED that State and county departments and agencies are urged to take all appropriate measures to 35 36 ensure that official actions, documents, and statements, 37 including those that pertain to the COVID-19 pandemic, do not exhibit or contribute to racism, xenophobia, intolerance, 38 39 discrimination, or hate crimes against the Asian community; and 40 BE IT FURTHER RESOLVED that certified copies of this 41 Resolution be transmitted to the President of the United States, 42



members of Hawaii's congressional delegation, Governor, Mayor of 1 2 the County of Hawaii, Mayor of the City and County of Honolulu, 3 Mayor of the County of Kauai, Mayor of the County of Maui, and 4 Chairpersons of the county councils of Hawaii, Honolulu, Kauai, 5 and Maui.
