SENATE RESOLUTION

REQUESTING THE DEPARTMENT OF LAND AND NATURAL RESOURCES TO ESTABLISH A TASK FORCE TO PROPOSE A COMMUNITY-BASED STEWARDSHIP PROGRAM FOR POLIHALE STATE PARK ON THE ISLAND OF KAUAI.

WHEREAS, Polihale State Park, located on the west to 1 northwest end of Kauai, possesses a large expanse of sand and 2 3 shoreline against a background of sand dunes that, together with other areas of the park, are known to contain the remains of 4 native Hawaiian burials; and 5 6 7 WHEREAS, beach goers and park users reportedly drive their 8 motor vehicles and recreational vehicles on the sand and among the dunes for camping, boating, and recreational purposes; and 9 10 WHEREAS, overuse and abuse of the beach and camping area 11 led the Department of Land and Natural Resources to shut down 12 the park in the summer of 2020; and 13 14 WHEREAS, community discussions about the future management 15 of the park include a stewardship agreement to cover issues such 16 17 as capital improvement projects to protect the dunes and entry road from damage, facilitating access to the park, improving 18 19 parking conditions, and properly maintaining camping areas; and 20 WHEREAS, these discussions also include ways to mitigate 21 22 the concerns raised by the lineal and cultural descendant families who have burial sites in the area; now, therefore, 23 24 25 BE IT RESOLVED by the Senate of the Thirty-first Legislature of the State of Hawaii, Regular Session of 2021, 26 that the Department of Land and Natural Resources is requested 27 to establish a task force to propose a community-based 28 stewardship program to address capacity access, fishing, 29 surfing, and vehicle use for Polihale State Park on Kauai; and 30 31

BE IT FURTHER RESOLVED that the Department of Land and 1 Natural Resources is requested to invite the following persons 2 3 to serve on the task force: 4 (1) An official from the Office of the Governor; 5 6 7 (2) Members of the Legislature; 8 (3) Staff from its own department; 9 10 (4) An official from the Office of the Mayor of the County 11 12 of Kauai; and 13 (5) Residents of the County of Kauai; and 14 15 16 BE IT FURTHER RESOLVED that Department of Land and Natural Resources is requested to report the task force's findings and 17 18 recommendations, including any proposed legislation, to the Legislature not later than twenty days prior to the convening of 19 20 the Regular Session of 2022; and 21 22 BE IT FURTHER RESOLVED that a certified copy of this Resolution be transmitted to the Chair of the Board of Land and 23 24 Natural Resources. 25 26 27 OFFERED BY: Mun M.M.
