Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 599, H.D. 1, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO ASSOCIATION GOVERNANCE,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to:

- (1) Clarify that regular, annual, and special meetings of planned community associations may be conducted remotely consistent with the Hawaii Nonprofit Corporations Act; and
- (2) Authorize condominium associations to conduct electronic meetings and electronic, machine, or mail voting in a state of emergency or local state of emergency, or any meeting noticed during such emergencies and for which the

applicable emergency has since expired under certain circumstances.

Your Committee on Conference has amended this measure by:

- (1) Changing the effective date to upon approval; and
