Your Committee on Consumer Protection & Commerce, to which was referred H.C.R. No. 187 entitled:

"HOUSE CONCURRENT RESOLUTION REQUESTING THE COUNTIES TO DEVELOP AN OPTION TO ALLOW RESIDENTS TO REMIT MOTOR VEHICLE REGISTRATION TAXES AND FEES ON A PRO-RATED BIANNUAL BASIS,"

begs leave to report as follows:

The purpose of this measure is to request the counties to develop an option to allow residents to remit motor vehicle registration taxes and fees on a pro-rated basis and consider a moratorium for these charges.

Your Committee received testimony in support of this measure from seven individuals. Your Committee received comments on this measure from the Department of Transportation.

Your Committee finds that the COVID-19 pandemic and the effects of the extraordinary governmental responses to mitigate the transmission of the virus have placed a substantial financial strain on Hawaii families. Your Committee further finds that the annual taxes and fees collected for the registration of motor vehicles may be substantial and have a dire impact on low-income families. Providing for a moratorium and alternative payment plans, as requested in this measure, would alleviate the financial

burden of these taxes and fees on low-income families and families impacted by the COVID-19 pandemic.

Your Committee has amended this measure by:

- (1) Amending the title to read, "REQUESTING THE COUNTIES TO DEVELOP AN OPTION TO ALLOW HAWAII RESIDENTS TO REMIT MOTOR VEHICLE REGISTRATION TAXES AND FEES ON A PRO-RATED BIANNUAL BASIS.";
- (2) Specifying that certified copies of the measure be transmitted to the Mayors of each county and Chairpersons of each county council; and
- (3) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.

As affirmed by the record of votes of the members of your Committee on Consumer Protection & Commerce that is attached to this report, your Committee concurs with the intent and purpose of H.C.R. No. 187, as amended herein, and recommends that it be referred to your Committee on Finance in the form attached hereto as H.C.R. No. 187, H.D. 1.
