Your Committee on Conference on the disagreeing vote of the Senate to the amendments proposed by the House of Representatives in S.B. No. 1053, S.D. 2, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO THE HAWAII COMMUNITY-BASED ECONOMIC DEVELOPMENT TECHNICAL AND FINANCIAL ASSISTANCE PROGRAM, "

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to expand the eliqibility of organizations that may receive community-based economic development technical and financial assistance beyond community-based organizations to also include for-profit businesses.

Your Committee on Conference finds that expanding the eligibility for community-based economic development technical and financial assistance to include for-profit businesses will allow the Department of Business, Economic Development, and Tourism to assist

in the success and viability of a larger number of organizations throughout the State.

Your Committee on Conference has amended this measure by:

- (1) Reverting to the maximum grant amount per applicant of \$100,000;
- (2) Changing the effective date to upon its approval; and
- (3) Making technical, nonsubstantive changes for the purposes of clarity and consistency.

As affirmed by the record of votes of the managers of your Committee on Conference that is attached to this report, your Committee on Conference is in accord with the intent and purpose of S.B. No. 1053, S.D. 2, H.D. 1, as amended herein, and recommends that it pass Final Reading in the form attached hereto as S.B. No. 1053, S.D. 2, H.D. 1, C.D. 1.
