Your Committee on Water & Land, to which was referred S.B. No. 1166, S.D. 2, entitled:

"A BILL FOR AN ACT RELATING TO RENTALS FOR PUBLIC LAND LEASES,"

begs leave to report as follows:

The purpose of this measure is to authorize the Board of Land and Natural Resources to approve reductions in or waivers of rent for leases that require substantial demolition costs or infrastructure improvement costs for the lessee to utilize the premises.

Your Committee received testimony in support of this measure from the Department of Land and Natural Resources. Your Committee received testimony in opposition to this measure from Kūpuna for the Moʻopuna. Your Committee received comments on this measure from the Office of Hawaiian Affairs.

Your Committee finds that this measure seeks to authorize the Board of Land and Natural Resources to approve reductions in or waivers of rent for certain long-term leases by an amount that must not exceed the amount of the lessee's total expenditures for demolition or provision of infrastructure. This measure is part

of an effort by the Department of Land and Natural Resources to bring its leasing practices to commercially reasonable standards.

Your Committee has amended this measure by:

- (1) Changing its effective date to upon approval; and
- (2) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.

As affirmed by the record of votes of the members of your Committee on Water & Land that is attached to this report, your Committee is in accord with the intent and purpose of S.B. No. 1166, S.D. 2, as amended herein, and recommends that it pass Second Reading in the form attached hereto as S.B. No. 1166, S.D. 2, H.D. 1, and be referred to your Committee on Judiciary & Hawaiian Affairs.
