<u>HB 424, HD1</u> <u>(HSCR805)</u> <u>Status & Testimony</u>	RELATING TO PROCUREMENT OF CONTRACTS FOR VEHICLE RENTAL. Requires all agencies of the State, when renting a vehicle on behalf of a state employee conducting official government business, to adopt a preference for renting electric vehicles or hybrid vehicles; provided that such a vehicle is suitable for the specific travel requirements and available when needed. Effective 7/1/2050. (HD1)	GVO/CPN, WAM
<u>HB 516, HD1</u> <u>(HSCR646)</u> <u>Status & Testimony</u>	RELATING TO SUSTAINABLE ELECTRONICS MANAGEMENT. Requires persons who receive state funds and state financial assistance to donate unnecessary but functioning electronic devices, hardware, and televisions to nonprofit organizations that will refurbish and distribute them to eligible persons in the State. Sets reporting requirements for donating entities, nonprofit refurbishers, and the department of accounting and general services. Sets penalties for violations. Effective 7/1/2112. <u>SCR 142</u> <u>Status & Testimony</u>	REQUESTING THE AUDITOR TO UPDATE ITS REPORT NO. 12-09, WHICH ASSESSES THE SOCIAL AND FINANCIAL EFFECTS OF MANDATORY HEALTH INSURANCE COVERAGE FOR FERTILITY PRESERVATION PROCEDURES FOR PERSONS OF REPRODUCTIVE AGE WHO HAVE BEEN DIAGNOSED WITH CANCER.	GVO/CPN
