SB 222, SD1 (SSCR852) Status	RELATING TO THE DEPARTMENT OF ACCOUNTING AND GENERAL SERVICES. Requires the Comptroller's annual report to the Governor and to the Legislature to include a list of all accounts that were closed by the Comptroller during the immediately preceding fiscal year, and a list of accounts that remain open but that are serving a lapsed program or initiative. (SD1)	GVR, FIN
SB 332, SD2 (SSCR792) Status	RELATING TO PREAUDIT PAYMENTS. Increases the minimum dollar amount of payments required to be preaudited. Allows, rather than requires, the comptroller to preaudit all proposed payments of expenditures under the threshold dollar amount. (SD2)	GVR, FIN

RELATING TO ELECTIONEERING COMMUNICATIONS.

GVR, JHA

Increases the monetary threshold that requires disclosure of electioneering communications. Requires that disclosures of electioneering communications occur on the date the electioneering communications are publicly distributed. Classifies election advertisements sent by mail at any postal rate, and election advertisements that are expenditures of an organization, as electioneering communications.

Testimony submitted will be placed on the legislative website. This public posting of testimony on the website should be considered when including personal information in your testimony.

The chair may institute a per-testifier time limit.

Committees meeting in the morning must adjourn prior to the day's Floor Session. Therefore, due to time constraints, not all testifiers may be provided an opportunity to offer verbal comments. However, remote testifiers' written submissions will be considered by the committee.

Please refrain from profanity or uncivil behavior. Violations may result in ejection from the hearing without the ability to rejoin.
