HB 345, HD2 (HSCR904) Status & Testimony	RELATING TO ASSISTED COMMUNITY TREATMENT. Mandates appointment of a guardian ad litem to represent the best interests of a mentally ill individual in assisted community treatment proceedings. Effective 7/1/2060. (HD2)	HMS/HTH, JDC/WAM
HB 474, HD2 (HSCR902) Status & Testimony	RELATING TO THE HOSPITAL SUSTAINABILITY PROGRAM. Extends the hospital sustainability program through 06/30/2024. Increases the maximum fee for inpatient care services to five and one-half per cent. Increases the amount of time hospitals have to pay the hospital sustainability fee from thirty days to sixty days. Increases the pool of medicaid services that can be used for matching purposes. Appropriates funds. Effective 7/1/2060. (HD2)	HMS/HTH, WAM
