Provides that the prohibition against serving two consecutive terms not to exceed eight consecutive years pursuant to section 26-34(a), Hawaii Revised Statutes, shall not apply to the representative of Hawaiian medium early learning providers' term limit. Repeals on June 30, 2025.	EDU, JDC
<a href="#">SB 151</a> (SSCR82) <a href="#">Status &amp; Testimony</a>	RELATING TO THE STATEWIDE TRAFFIC CODE. Replaces the term "accident" with collision for purposes of certain provisions of the statewide traffic code.	TRS, JDC
<a href="#">SB 178, SD1</a> (SSCR139) <a href="#">Status &amp; Testimony</a>	RELATING TO DRIVING ON BEACHES. Establishes a two-year beach protection pilot program under which no vehicles are authorized to drive on the beach in Polihale state park without a permit. Requires a report to the legislature. Repeals on 6/30/2023. (SD1)	WTL, JDC

<p><b><a href="#">SB 238, SD1</a></b>  <a href="#">(SSCR17)</a>  <a href="#">Status &amp; Testimony</a></p>	<p>RELATING TO THE OFFICE OF HAWAIIAN AFFAIRS.  Amends ballot requirements to display candidates for the Office of Hawaiian Affairs Board of Trustees, by residency and non-residency requirements and to randomize the order of candidate names within those groupings. <p><b><a href="#">SB 329, SD1</a></b>  <a href="#">(SSCR105)</a>  <a href="#">Status &amp; Testimony</a></p>	<p>RELATING TO CONDOMINIUMS.  Shortens the notice period from sixty days to thirty days for a board to sell, store, donate, or dispose of personalty when the identity and address of the owner are known. Removes the publication requirement and permits the board of directors of a condominium association to proceed directly to the sale, storage, donation, or disposal of personalty that has been abandoned in or on the common elements of a condominium when the identity or address of the owner is unknown. <p><b><a href="#">SB 562, SD1</a></b>  <a href="#">(SSCR47)</a>  <a href="#">Status &amp; Testimony</a></p>	<p>RELATING TO DECEPTIVE TRADE PRACTICES.  Establishes that charging shipping and delivery charges that exceed the actual cost to ship or deliver a commodity to a consumer in Hawaii shall constitute an unfair and deceptive practice. (SD1)</p>	<p>CPN, JDC</p>
<p><b><a href="#">SB 703</a></b>  <a href="#">(SSCR76)</a>  <a href="#">Status &amp; Testimony</a></p>	<p>RELATING TO SUICIDE PREVENTION TRAINING.  Requires two hours of annual in-service training in suicide prevention for all teachers, principals, and school counselors.</p>	<p>EDU, JDC</p>
<p><b><a href="#">SB 811</a></b>  <a href="#">(SSCR40)</a>  <a href="#">Status &amp; Testimony</a></p>	<p>RELATING TO THE DEPARTMENT OF EDUCATION.  Requires the department of education to publish a weekly report on schools that have reported COVID-19 cases.</p>	<p>EDU, JDC</p>
