| SB 819, SD1 (SSCR239) Status & Testimony | RELATING TO THE HOSPITAL SUSTAINABILITY PROGRAM. Extends the hospital sustainability program through June 30, 2024. Increases the maximum fee for inpatient care services to five and one-half per cent. Increases the amount of time hospitals have to pay the hospital sustainability fee from thirty days to sixty days. Increases the pool of medicaid services that can be used matching purposes. Appropriates funds. (SD1) | HMS/HTH, WAM |
| SB 266, SD1 (SSCR135) Status & Testimony | RELATING TO THE CORONAVIRUS 2019 PANDEMIC. Appropriates moneys. Effective 7/1/2050. (SD1) | HTH, WAM |
| SB 1018, SD1 (SSCR141) Status & Testimony | RELATING TO EFFECTIVE GOVERNMENT OPERATIONS. Requires the department of health to establish a reorganization pilot project to reorganize the department of health behavioral health services administration; environmental health administration; general administration, including the office and the director of health; and health resources administration. Effective 7/1/2050. (SD1) | HTH, WAM |
