DECISION MAKING ON THE FOLLOWING MEASURE(S):

HB 58, HD1 (HSCR789) Status & Testimony	RELATING TO STATE FUNDS. Temporarily reallocates conveyance tax revenues for purposes of paying the principal and interest of general obligation bonds. Authorizes the issuance of general obligation bonds to be appropriated into and out of the land conservation fund and rental housing revolving fund. Effective 1/1/2050. (HD1)	WAM
HB 1298, HD1 (HSCR843) Status & Testimony	RELATING TO STATE FUNDS. Transfers to the general fund the excess balances of various non-general funds from various state departments and agencies. Effective 6/30/21. (HD1)	WAM
HB 1299, HD1 (HSCR844) Status & Testimony	RELATING TO NON-GENERAL FUNDS. Repeals various non-general funds of the department of agriculture; department of budget and finance; department of business, economic development, and tourism; department of defense; department of education; department of health; department of human services; department of labor and industrial relations; department of land and natural resources; department of the attorney general; department of public safety; department of transportation; University of Hawaii; department of commerce and consumer affairs; department of Hawaiian home lands; judiciary; and Hawaii public housing authority. Implements recommendations of the auditor. Transfers most unencumbered balances to the credit of the general fund. (HB1299 HD1)	WAM
