## KAPOLEI SCHOOLS RECEIVE MONEY SECURED BY REP. HAR

Over the past six years, I have served as a member of the House Finance Committee, fighting for critical infrastructure funds to improve our quality of life. Most recently, in the 2012 legislative session, I helped to secure:

- (1) **\$40 MILLION** for the construction of a new elementary school in Kapolei (to be located across Kapolei High School off of Ft. Barrette Road;
- (2) \$4.7 MILLION for a new locker room and showers at Kapolei High School (KHS); and
- (3) \$375,000 for a new portable special education building at Makakilo Elementary. GREAT NEWS! Governor Abercrombie RELEASED THESE FUNDS on June 20, 2013 which means these infrastructure improvements at our area schools are on their way to becoming a reality! These projects represent an investment in our children and in our community. I always say that government does not accomplish things overnight but together, we can accomplish great things with a little patience.

Many thanks to Principal Esmeralda, former principal of Makakilo Elementary Sean Tajima, and all of our principals from the Kapolei Complex who worked with me in securing these essential funds.

# Makakilo Drive Extension Meeting Update

As most of you may know by now, the Oahu Metropolitan Planning Organization ("OMPO") policy committee meeting that was scheduled for June 12, 2013 to discuss the Makakilo Drive extension project is rescheduled to <u>July 9, 2013 at 10:30 a.m.</u> For those of you who might not be familiar with the project, a 2008 Pacific Business News (PBN) diagram of the proposed extension is illustrated below.

While I am working hard to represent the interests of West Oahu residents at OMPO, your testimony is needed to ensure that this project is both approved and funded to improve the safety of Makakilo residents. Testimony must be submitted at least 24 hours prior to the time of the hearing to the attention of the Executive Director (fax: (808) 587-2018 or email: OahuMPO@OahuMPO.org). Testimony is limited to 4 single-sided pages. I recently sent out an attachment via an email blast to many residents with a boilerplate testimony that can be used by individuals who are pressed for time but would still like to testify on the matter. If you are not on my email list and would like a copy of the boilerplate please email or call my office using the information in the top left corner of this page and we will be more than happy to send it to you.

In-person testimony is even better. The OMPO policy committee meeting is now scheduled for Tuesday, July 9, 2013 from 10:00 a.m.-12:00 p.m., in the City Council Committee Meeting Room 205, Honolulu Hale. We need as many residents as possible to support the Makakilo Drive extension so that my colleagues know that this is not just a matter of

convenience, but public safety. There is metered public parking available in the State Capitol basement and in the municipal building located next to Honolulu Hale. There are two entrances to this metered parking lot—Alapai Street across the bus terminal and Beretania Street across from the Board of Water Supply.

I hope you can attend this very important meeting, or at least submit testimony. Please contact me by email or telephone if you have any questions.



### Hawaiian Homes Commission offers Ka Makana Ali'i Developers a Stern Warning

You may recall that last month, I voiced my concerns about the lack of transparency and details provided to the community from the developer regarding the Ka Makana Ali'i project.. Based on my conversations with community members involved, it appears that details regarding the project are more fiction than fact. The lack of communication from the developer is unacceptable, considering that the development will be located on DHHL (Department of Hawaiian Homelands) land and because this project could impact the Hawaii Railway Society which has its tracks protected under the federal historic preservation register.

DeBartolo, the developer, appeared before the Hawaiian Homes Commission (HHC) on June 18, 2013 and requested to defer their request for an extension on their option period. Commissioners expressed grave concern that few details regarding this project have materialized after seven years and sternly warned DeBartolo that at the August Commission meeting, DeBartolo must provide a detailed presentation warranting an extension of the option period. The request will be heard again at the August HHC meeting on Maui.

I take solace that commissioners at the HHC shared my strong concerns regarding the Ka Makana Ali'i project. The West Oahu community has graciously accepted Bartolo into its ohana but their has been menial reciprocation. I remain hopeful that they will be much more forthcoming in the next two months before their request is addressed by the HHC.
