# 500-acre solar project proposed in Central Maui

AES Distributed Energy was recently selected by the Hawaiian Electric Companies for two of its seven solar-plus-storage projects in Hawai'i, representing the largest addition of renewable energy in the state's history. One of AES Distributed Energy's projects is on the island of Maui with the Maui Electric Company.

The AES Maui project is located just east of Kuihelani Highway near Waikapu. A community meeting on the project was held in mid-November. Additional meetings are planned and will be announced. The solar project is aimed to help the State of Hawai'i realize its goal of reaching 100 percent renewable energy by 2045. ### Details of the project include:

- 60 MWac solar PV plus 240 MWh battery energy storage system
- Approximately 200,000 solar panels
- Enough energy to power about 18,000 homes
- Solar panels mounted on single-axis-tracking system
- Containerized Lithium-Ion battery energy storage system
- 25-year Power Purchase Agreement in negotiations with
- Maui Electric Company
- Up to 500 acres of land required
- (Agricultural soil type D and E only)
- Estimated Construction Commencement in 2020
- Estimated Commercial Operations in 2021 or 2022

### Department of Health to hold immunization public hearings

The Hawai'i State Department of Health (DOH) has scheduled additional public hearings on the counties of Kaua'i, Maui and Hawai'i to gather public comments on the proposed amendments to Title 11, Chapter 157, "Examination and Immunization," which include health examination and immunization requirements for school attendance in Hawai'i.

Scheduled hearings are open to the public and will be held at the following dates, times and locations:

### Date: Friday, Dec. 14, 2018

*Time:* 2 – 4 p.m.

*Place:* Maui – Wailuku State Office Building, 54 South High Street, Wailuku, Maui

"We decided that hearings should be conducted statewide based on the interest around these changes," said Health Director Dr. Bruce Anderson. "The proposed rules conform with current national recommendations by the Centers for Disease Control and Prevention (CDC) on vaccinations."

The proposed changes update and clarify the immunization and examination requirements for school, post-secondary school, and child care facility attendance in Hawai'i, which were last revised in 2001. Since then, updates have been made to the vaccine recommendations from the CDC, resulting in differences between current national standards and Hawai'i's pediatric and school entry and attendance requirements.
