NEWS AND UPDATES FROM Representative Troy N. Hashimoto September/October 2021

Aloha! As we head into the fall, I would encourage you to continue staying safe and doing your part in keeping our COVID-19 hospitalization rates low. There are many new guidelines announced by both the Governor and Mayor to ease positive COVID cases, which I have summarized in this newsletter. My hope is that if we all do our part, the sooner we can get back to a normal way of life.

In August, the U.S. Census Bureau released the results of their 2020 Census, showing that Maui County's population increased by 6.4 percent over the last decade to 164,754. In reviewing the numbers closer, the most growth was in Wailuku and Kahului, not surprisingly with all the new development around the community.

The new Census information will be used by the State Reapportionment Commission, which meets every 10 years to review all state legislative districts in Hawai'i to ensure that each district is proportional. The Commission has already decided that statewide, each island will not change the number of state representatives or senators as populations have not shifted dramatically from one island to another. Therefore, in Maui County, my hope is that our legislative districts will not change significantly. As the Commission completes its work, I will be sure to keep you informed. Their decisions are important as it impacts what communities belong together in a legislative district. Public testimony is accepted at each of their meetings. Eviction and Mediation Information

On Aug. 6, the statewide eviction moratorium that began in April 2020 expired, which allowed Act 57 passed by the Legislature to take effect. The Act calls for free mediation that must be completed before any court action can take place and sets a timeline for court action. Those with 3+ months in back rent can begin court filings on Sept. 6, 2+ month on Nov. 6, and 1+ month on Jan. 6, 2022. Despite this timeline for court actions, mediation centers are encouraging anyone with back rent to pursue mediation as soon as possible and develop a payment plan. Federal rental and utility assistance is also still available for Maui County residents. The County has paid out nearly \$11 million since launching the program in the spring. Additional federal funds are still available and unlike Oahu, Maui County's application portal has never closed. As of Sept. 15, Maui County launched its Safer Outside initiative, which requires proof of a COVID-19 vaccination. Operators of bars, restaurants, gyms, fitness centers, recreational boating, ground transport, and commercial tours may operate at 50 percent capacity indoors, provided that all customers 12 years of age and older provide proof of full vaccination. Operators are responsible for verifying vaccination status and identity through government or school-issued identification. Fully vaccinated for COVID-19 is defined as more than two weeks since receiving the second dose in a two-dose series, or more than two weeks after receiving a single-dose vaccine. Restaurants and bars will also be required to close at 10 p.m.

Acceptable proof of vaccination includes a completed vaccination card (which includes name of the person vaccinated, type of vaccine provided, and date of the last dose administered) in original, photocopied, or digital form; the Hawai'i SMART Health Card digital health pass; or other similar vaccination documentation from a healthcare provider.

Those unvaccinated may dine outdoors, order take-out, or use drive thru services. The proof of vaccination requirement will only apply to those ages 12 years and older.

Full or part-time employees 12 years of age and older must show proof of full vaccination or must provide proof of a negative COVID-19 test result taken within seven (7) days of entry to the businesses listed above.

The order also states that the indoor gathering limit is five and the outdoor gathering limit is ten. This order will be in place until October 15 and will be reviewed by Mayor Victorino at that time for an extension. Rules related to this order may continue to change. Hawai'i SMART Health Card

Governor Ige announced on Sept. 8, the roll-out of the Hawai'i SMART Health Card which enables individuals who received their COVID-19 vaccinations in Hawai'i to create a state-issued digital health card that may be used to confirm their vaccination status. The program is voluntary and started on Sept. 10.

The Hawai'i SMART Health Card QR code cannot be used for traveling to Hawai'i. Travelers arriving in Hawai'i are required to use the Travel Exemption/Exception feature on the Safe Travels Hawai'i Digital Platform to receive a travel entry QR code. Here's how the Hawai'i SMART Health Card works:

- 1. Go to the Hawai'i Safe Travels Digital Platform, https://travel.hawaii.gov
- 2. Create an account or use your existing account.
- 3. Click on the SMART Health Card logo.
- 4. Take a picture of your vaccination card and upload it.
- 5. Enter your vaccination information.
- 6. If you are a parent or guardian and have COVID-19 vaccination records for minors, upload O Pontally Ved each digital vaccine record request separately.
- 7. Once validated by the system, you will receive a QR code that you may present to business and establishments that require proof of vaccination status.
- 8. Your QR Code will be available for display in the Hawai'i SMART Health Card section of the Safe Travels platform.
- 9. Businesses and establishments may use a SMART Health Card verifier app to verify status. (For the app go to *https://thecommonsproject.org/smart-health-card-verifier*)

At this time, the Hawai'i SMART Card allows for the upload of vaccinations cards issued in Hawai'i only. Individuals not vaccinated in Hawai'i may present a hard copy of a vaccination document as proof of vaccination. In addition, the State is looking into developing a system to allow the upload of negative COVID-19 test results. For now, patrons may present a physical copy of their negative COVID-19 test result where required.

Unemployment Insurance update

On Sep. 4, 2021, all Federal aid assisted programs like the Pandemic Emergency Unemployment Compensation (PEUC), Pandemic Unemployment Assistance (PUA), Federal Pandemic Unemployment Compensation (FPUC), and Mixed Earners Unemployment Compensation (MEUC) programs ended. Currently, only the State Unemployment Insurance (UI) program continues to be available.

COVID-19 HIDOE CASE COUNT



HIDOE COVID-19 case dashboard The Hawai'i State Department of Education (HIDOE) launched an interactive dashboard on its website to display confirmed COVID-19 case data. The dashboard includes confirmed and probable COVID-19 case information from the state, district, complex area and school levels. Case counts are visually displayed by date reported and as a cumulative running total of cases since July 1, 2021. In accordance with Act 4, Session Laws of Hawai'i 2021, the dashboard also includes the date each case was reported to the Department and the date the positively tested individual was last on a school campus.

Daily case counts will reflect confirmed COVID-19 cases reported the day prior. Reported cases that still require confirmation or processing will not be included in the total. Data will be updated daily, Mon. through

Fri. (excluding holidays), prior to the close of business at: www.hawaiipublicschools.org/ConnectWithUs/MediaRoom/PressReleases/ Pages/COVID-19-Information-Updates.aspx

Schools will continue to make the following notifications for all confirmed and probable cases:

- Immediate notification to individuals who may have come into close contact with the infected person about possible exposure while maintaining confidentiality in accordance with state and federal law.
- Notification to staff and parents/guardians about the possible exposure and HIDOE activities to contain the spread of infection.

Testing: The Hawai'i State Department of Education has partnered with the Hawai'i State Department of Health to coordinate schoolbased COVID-19 testing for eligible students, staff, and school communities which are offered at no cost. Currently, H.P. Baldwin High School, 'Īao Intermediate School and Pu'u Kukui Elementary School are offering a program called "Operation Expanded Testing".

Back to school: know your route

Due to a severe nationwide shortage of school bus drivers, the Hawai'i State Department of Education is working to manage staffing and consolidate bus routes to minimize disruption to students and families. As a result, more parents are out on the road transporting their students to and from school. This may be increasing traffic around schools and causing more congestion than usual. More students may also be walking or biking to school.

In the event that families who qualify for bus transportation are unable to receive services, the HIDOE Student Transportation Services Branch will offer mileage reimbursement. Bus pass refunds are also available.
