Aloha friends, neighbors and graduating classes of 2021,

After the immense challenges of the last year, 2021 offered a welcomed opportunity to rebuild. I want to thank you all for your efforts in helping us through these challenges. We started the year off with uncertainty, but made much progress along the way. This began with the first vaccine roll-out in December and January, to combat the second surge in early 2021. One of our primary focuses of the 2021 Legislative Session was tackling the massive budget deficit due to revenue shortfalls. This included a proposed 10% cut to education which would have resulted in thousands of staff being laid off. My priority was to alleviate the school budget cuts to the greatest extent possible, ensuring that students could return to a safe school with teachers and staff prepared to welcome them back.

As the Session progressed, our hope became reality as larger vaccine roll-outs took place throughout the state and cases decreased. Additional Federal Relief monies came by way of the American Rescue Plan Act, which provided \$1.6B to the State and an additional \$412M to the Department of Education. Additional funding also went directly to the four counties. This funding offered invaluable support to local families and businesses, helping them get back on their feet after a devastating year.

We are so grateful to have ended Session with a balanced budget, restoring funding to critical areas like education, social safety net programs, and assisting small businesses. We added money to restore more Weighted Student Formula (the primary funding source for schools), as well as more funding for programs targeting learning loss and the reopening of our schools. A \$700M Unemployment Insurance loan was funded so local employers would not have to pay it back, but rather be able to maintain their staff and build their businesses. I have included my annual 2021 Bills of Interest status update in this newsletter to note the list of bills and Capital Improvement Projects in our district which I am very eager to see flourish. I know the importance of investing in our communities and am so glad to be able to meet our community needs.

Particularly because we are a tourist destination, our state faced losses unseen in the history of Hawai'i. And yet, despite these difficulties, we have persevered. We were resilient. We shifted—to remote working and learning, recognizing the true needs and priorities of our residents and how we could best serve them. And while our efforts along the way may have been imperfect, the values of aloha and our desire to mālama one another has been affirmed throughout these trying times. I'd like to wish our students and educators a wonderful end to their school year and am hoping that the plans the Department of Education has made to reduce learning loss will be successful. My deepest aloha and congratulations goes to the graduating classes of 2021. I hope you will all continue to persevere and do incredible things in this exciting next chapter of your careers!

3. <u>COVID-19 Vaccine Safety.</u> Expectations & FAOs

One Oahu offers information regarding Hawai'i's distribution plan, vaccine safety, as well as what to expect when receiving the vaccine and a list of FAQs to address community vaccine concerns. It is important to note that people who have recovered from COVID-19 are still urged to receive the vaccine with new variants being introduced into the country and natural immunity varying between individuals. Mask-wearing and hyper hygiene is still urged after receiving a vaccination.

2021 BILLS OF INTEREST

SB807: RELATING TO EDUCATION

Requires each school to include, as a part of their academic plans, an accounting of all resources that will be used to address and achieve their desired outcomes for their students. Schools retain full control over what outcomes they wish to achieve. This bill simply ensures that we collect the data on what the resource needs are for our schools and where there may be opportunities to bring schools together to address similar issues.

SB808: RELATING TO THE SCHOOL FACILITIES AGENCY

This bill clarified the roles and responsibilities of the school facilities agency, as established last year as Act 72. This bill also renames the School Facilities Agency as the School Facilities Authority, allowing it to compete for additional Federal funds and loans. I continue to have great hope that the School Facilities Agency will fulfil its mission to modernize and improve our schools to meet the needs of our students.

SB811: RELATING TO THE DEPARTMENT OF EDUCATION

With in-person learning expanding across our State, it is more important now than ever to ensure that students, parents, and staff know when there is a reported COVID-19 case at their school. The DOE continues to report these cases by complex area, which can span significantly large geographic areas. By requiring weekly school-level reporting, we are able to provide our students, parents and community with the information they need to make informed decisions on whether or not to send their students back to in-person learning.

SB814: RELATING TO CHARTER SCHOOLS

I have heard from many in the charter school community that there are on-going issues that must be addressed with the charter application process. At the same time, we must balance it with a fair and open process that respects the autonomy of the commission as the authorizer of charter schools in our State. I believe that SB814 is a good compromise that removes the letter of intent process from the application period and allows applicants to go directly to the application process.

SB1127: MAKING AN EMERGENCY APPROPRIATION FOR THE DEPARTMENT OF HUMAN SERVICES

This bill makes an emergency appropriation for the general revenues of the State of Hawai'i for fiscal year 2020-2021 to address the budget shortfall for support of the general assistance program (HMS 204) in the Department of Human Services.

SB1387: RELATING TO MICROCHIP IDENTIFICATION

Microchipping is an effective and low-cost way to ensure that animals, who become separated from their homes, have a safe way to be reunited with their families. SB1387 requires all cats and dogs to be microchipped, and is an important step in ensuring that our shelters and other service providers are able to contact their owners and keep pets from being euthanized unnecessarily.

SCR151: ENCOURAGING THE DOE TO IMPLEMENT SCHOOL-WIDE RESTORATIVE PRACTICES

It is important that our schools have supportive practices in place as a standard policy for students. Restorative practices include multiple levels of interventions and programs to ensure that students who are struggling have access to supportive staff and programs, and that students who are justice-involved have a safe and thoughtful plan for continuing their education. School must be seen as a solution for struggling students and this resolution encourages the DOE to be systematic in its approach to offering services.

HB961: RELATING TO MILITARY DEPENDENTS

This bill exempts dependents of military service members from state residency requirement for government employment if the military service member is in Hawai'i on bona fide military orders. Effective January 1, 2022, a spouse of an active duty service member in the military who accompanies the service member a permanent change of station to Hawai'i and holds a current, unencumbered license in another jurisdiction in specific professions to apply for licensure on an expedited basis in the State.

SCR152: URGING DOE TO COORDINATE WITH THE DCCA TO IMPLEMENT A GRADUATION REQUIREMENT OF FINANCIAL LITERACY

Having some financial literacy is important for every person to be financially stable and avoid becoming victims of fraud. In 2015, I introduced a resolution that formed a working group to look into possible courses and information for students. Unfortunately, the Department of Education has been slow to roll this programming out and provide this opportunity to our students.

CAPITOL IMPROVEMENT PROJECTS

- **-Waipahu High School**: \$23M in funding for phase 2 of the new Integrated Academy Facility as well as renovation and relocation costs for the Academic Health Center. This funding is critical to ensuring that these projects stay on track and that students have access to the facilities and equipment needed to be prepared for careers. (FY22)
- **–Kaleiopuu Elementary School**: \$2.139M in funding for critical infrastructure improvements on the campus including roofing or re-roofing, renovations, ground and site improvements, and hazardous materials remediation. (FY22)
- **–Kipapa Elementary School:** \$3M for design and construction of a covered play court and other related improvements. This is important not just to protect against rain but also to provide shade and shelter for students. (FY22)
- -Mililani High School: \$3.5M for the design and construction of funding for a much a needed expansion of the high school administration building. (FY22)
- **–University of Hawai'i at West O'ahu**: \$3.5M in funding to provide much needed repair and maintenance funding for the facilities at UH-West Oahu. While the newest campus in our system, this does not mean it escapes the need for repair and maintenance to ensure we achieve the maximum lifespan for these buildings. (FY22)

HB613: RELATING TO EDUCATION BUDGET:

The Department of Education took a substantial budget hit at the start of this session. Facing the Governor's cut of 10% of their budget, we were looking at potential cuts of thousands of school-level personnel and reductions to important statewide programs in STEM, CTE, and Early College. I am grateful for the partnership with fellow Miliani Senator Donovan Dela Cruz for his commitment in working with me to ensure that we passed a budget which restored funding directly to our schools. To do this, we utilized both our general fund budget as well as Federal Relief funds known as Elementary and Secondary School Emergency Relief (ESSER) funds. The general funded budget is found in HB200 and federal ESSER funds are allocated through HB613.

- \$35M to restore the cuts made by the Governor to Weighted Student Formula (EDN100), which is the primary funding mechanism for schools. This is critical to ensure that our schools have the resources to hire necessary staff, provide programming opportunities, and have funding on-hand to address any issues that arise throughout the school year.
- \$110M to be used to prepare schools for a safe reopening. This money can be used to address transportation requirements, air quality issues including air conditioning (with appropriate filters), food services costs, PPE needs, and more.
- \$100M divided up amongst the 15 complex areas to address student needs in areas of social-emotional health, academics like STEM and CTE, and other services to support students' return to in-person learning or remain hybrid or virtual learners.
- \$19M to increase virtual learning services, address connectivity issues, digital device refresh and replacement, and online subscriptions to virtual learning programs as approved by the DOE's Office of Curriculum, Innovation, and Design.
- \$20M for programs targeting under-served and minority populations who may need further engagement to return to school.
- \$4.6M to be allocated by formula to each school to address small repair and maintenance issues. Elementary schools will receive \$12K, middle/intermediate school will receive \$15.5K, and high schools as well as combined/mixed schools will receive \$22K. An additional \$12K will be allocated to schools with public pre-kindergarten classrooms on campus.

HB200: RELATING TO THE STATE BUDGET

More than ever, balancing the state budget was a challenge given our starting point in January. Thanks to a favorable outlook from the Council on Revenues and additional Federal relief funds from the American Rescue Plan Act (ARPA), the legislature was able to pass a budget that restored several critical programs, provided ESSER and assistance for our local small businesses. Here is a summary of the highlights from the budget:

Department of Accounting and General Services

- -\$2.38M restore sex assault treatment service contracts to continue 24/7 stabilization information and referral services, case management, counseling services, and late-night services.
- \$870K and (9) positions to establish the complex litigation, fraud, and compliance unit which will focus on civil and criminal cases and fraud and ethics violations within government.
- Over \$531K to change the means of financing for the Medicaid fraud control unit to investigate and prosecute
 Medicaid fraud and patient abuse or neglect in health care facilities, or board and care facilities.

Department of Budget and Finance

- \$313.6M for the repayment of a working capital loan.
- -\$93.2M in FY22 and \$122.625M in FY23 for debt service payments.

Department of Human Services

- \$500K for FY22 in funds for the Rent Supplement Program for low income families.
- \$5.4M for FY22 for General Assistance payments for temporarily disabled individuals to maintain the current benefits.

- \$14.3M for continued homeless services including the Housing First Program, the Rapid Re-housing Program, the Homeless Outreach Services and Civil Legal Services, and the Stored Property and Debris Removal Service.

Department of Labor and Industrial Relations

- \$700.2M in FY22 and \$5.09M in FY23 to repay the loan principal and interest of the unemployment insurance program.


- \$1M to offset lost revenue at the Waikīkī Aquarium.
- \$3.1M in each fiscal year for the Hawai'i Promise Program.
- \$1.2M for University of Hawaii Economic Research Organization for economic analysis

Department of Education

We must find ways to address the trauma and stress that our students have faced over the last year and a half. We cannot expect schools to be able to assist their students without appropriate resourcing. That is why the legislature allocated \$3M for FY22, \$6M for FY23 to expand Alternative Learning Programs and \$400K for Trauma-Informed Care Services. In addition to this, we understand that we must continue to address the physical health needs of our students as well.

- An additional \$2,482,554 was allocated to continue the Hawai'i Keiki Program, which promotes the health and wellness of our keiki and aims to reduce the amount of absences statewide.
- The Legislature also appropriated \$2,594,198 for the Early College Program which offers over 400 college level courses to 43 High Schools statewide to encourage their post-secondary studies
- Cuts to Special Education services (EDN150) were restored in the budget to ensure that all students have access to a free public education system that is responsive to their needs.
