Aloha Friends and Neighbors,

This month saw the close of our 2021 session on April 29th, one week shy of our usual schedule. This shorter session and budget woes prompted new challenges at the Legislature with a very busy week of conference committee hearings rather than the usual two weeks to ensure our deadlines. The lessons we have learned in the last year have been instrumental in guiding legislation and helping forge new paths forward as we work to rebuild our economy and find greater support for our local communities. Despite these setbacks, however, I have remained determined to seek the necessary changes our residents deserve.

When the pandemic began last March and the call for a statewide quarantine began, the Hawai'i State Capitol was immediately shut down and our 2020 Legislative session cut short. This called for the Special Session in June and the need for the Special 6 member Committee on COVID-19 of which I was a member, to provide support for the people of Hawai'i. The changes of 2020 have had great impact on the 2021 session and the goals we aim to reach for the future of our state.

Despite these challenges, however, we have endured. We reimagined traditions such as our annual Education Week, Art At The Capitol and the Women's Legislative Caucus' Easter Basket Drive with new precautions in place. Many things have changed this year-- from transitioning Legislative hearings online to a greater digital communications presence as well as socially distanced presentations and celebrations. At times the distance felt greater due to the physical separation that kept us apart, but as a community we have made tremendous efforts to foster greater closeness and transparency online. We have learned to utilize technology to our advantage as powerful digital tools. We garnered even deeper gratitude for the educators and essential workers whose resilience endured in the face of adversity. And, ultimately, we have an even greater appreciation for our friends and neighbors during such a trying year. The strides we have made in the last year will have a lasting impact on the future of our state and generations to come, and I am proud to be a part of such change.

# 2021 LEGISLATIVE BILL STATUS UPDATES





One of the biggest issues that we faced during session was paring down the State budget due to less revenues. While the receipt of Federal Aid through the American Rescue Plan Act (ARPA) and Elementary and Secondary School Emergency Relief (ESSER) funding will help to fill the budget hole, it requires a Maintenance of Effort (MOE) provision, which maintains the same proportionate level of funding in state funds to the DOE over the prior 3 year average. While this does not equate to a full restoration of all previously proposed

cuts by the Governor, the Senate draft of the budget makes strategic reinvestments into the DOE prioritizing school and complex level funding and resources, supports for teachers, and equity to charter schools.

Highlights of the Senate Draft (SD1) of the State budget for education includes:

- Restoration of reductions in the Governors budget to the DOE through program reviews
- Add \$4.4M funds to ensure that vulnerable populations of students (including students who qualify for special education), to make appropriate services available
- Appropriating \$5M to allow for extended summer learning for students utilizing teachers
- Restoring \$22.3M to Weighted Student Formula, the primary allocation formula for school-based budgeting
- Adding \$39.7M in FY22 and \$47.7M in FY23 to the Complex Areas to ensure that they have the resources available to support their schools and
- Adding \$5M for a pilot teacher rental subsidy program
- Adding \$5.1M for school level repair and maintenance
- Restore \$3.5M to the public library system that were cut in the Governor's budget
- Restore \$14.4M to the Charter Schools

#### Other Statewide highlights include:

- Restores \$1.8M for the Career Criminal and Victim Witness Program
- Pay down of the principal and interest of the working capital loan taken out by the Governor to cover on-going expenses during the pandemic
- Restores positions for the Youth Challenge Academy
- Adds \$5.4M to maintain General Assistance payments at \$388/month for some of Hawai'i's most vulnerable populations.
- Adds \$750,000 for State Rent Supplement Vouchers to prove up to \$500/month Adds a total of nearly \$720 million over the next two fiscal years to pay down the Unemployment Insurance Fund (Note: This is a loan obligations that local businesses have to pay to the Federal Government as part of the Unemployment Insurance program. The Senate, in trying to help local businesses and employers, is dedicating funds to pay this down so they aren't burdened by it.)

### 1. SB804: Relating to Teacher Rental Housing

Authorizes the Hawaii Public Housing Authority and Hawaii Housing Finance and Development Corporation to provide rental housing projects for teachers employed by the DOE and public charter schools.

# 3. SB807: Relating to Education

Requires the department of education to submit an annual report on the school academic and financial plans to the board of education and the legislature.

# 4. SB808: Relating to the School Facilities Agency

Transfers the total fund balance in the state educational improvement fund to the school facilities special fund by a certain date.

#### 5. SB811: Relating to DOE

Requires the DOE to publish a weekly report on schools that have reported COVID-19 cases.

# 5. SB830: Relating to Employment

Requires each department to establish a telework and alternative work schedule policy.


# 5. SB1387: Relating to Microchip Identification

Requires dog and cat owners to microchip their pets, if the pets are not licensed.

# COVID-19 RESOURCES:

### 1. Vaccine Registration

Currently accepting vaccination registrations for kupuna ages 75 and older. Eligibility is required based upon Hawai'i's tiered program and must review the prevaccination checklist before receiving their vaccine.

### 2. Hawaii Vaccination Plan

For more information regarding Hawai'i's detailed vaccination plan, please refer to the CDC-approved executive summary noting the operational structure to reach high-risk groups as quickly and efficiently as possible.

#### 3. Statewide PODs

A list of clinics or Points of Distribution (PODS) note locations throughout the state where you can receive your COVID-19 vaccination.

### 4. <u>COVID-19 Vaccine Safety</u>, <u>Expectations & FAOs</u>

One Oahu offers information regarding Hawai'i's distribution plan, vaccine safety, as well as what to expect when receiving the vaccine and a list of FAQs to address community vaccine concerns. It is important to note that people who have recovered from COVID-19 are still urged to receive the vaccine with new variants being introduced into the country and natural immunity varying between individuals. Mask-wearing and hyper hygiene is still urged after receiving a vaccination.

# Fully Vaccinated People Can:

- Gather indoors with fully vaccinated people without wearing a mask.
- Gather indoors with unvaccinated people from one other household without masks (unless one of those people or someone they live with has an increased risk for severe illness).
- Skip quarantine and testing if exposed or someone who has COVID-19 but are asymptomatic

# Fully Vaccinated People Must Still:

- Wear a mask, physically distance, and avoid crowds in public, while gathering with unvaccinated people from more than one other household, and visiting with an unvaccinated person who is has an increased risk for severe illness.
- Get tested if you experience symptoms of COVID-19.
