#### **A. MISSION STATEMENT**

The mission of the Department of Labor and Industrial Relations (DLIR) is to, "...administer programs designed to increase the economic security, physical and economic well-being, and productivity of workers, and to achieve good labor-management relations, including the administration of workers' compensation, employment security, apprenticeship training, wage and hour, and industrial relations laws. The department shall also have the function of developing, preparing, and disseminating information on employment, unemployment, and general labor market conditions," section 26-20, Hawaii Revised Statutes (HRS).

#### **B. BUDGET REQUESTS**

The sole general fund request is to provide for annual software license and cloud environment maintenance costs for the Disability Compensation Division's (DCD) eCMS (Electronic Case Management System) Cloud-environment Modernization program. The Amazon Workspace (AWS) funding is for cloud-based virtual desktop client licenses that allow employees and customers to work in the DLIR DCD AWS cloud environment in the office and remotely. The Salesforce Front-end Solution Platform licenses for employees and customers enables access to DCD's eCMS.

DCD's eCMS Modernization Program aligns with the Governor's and ETS' priorities; i.e. effective government, efficient government, open government, cybersecurity, IT cost transparence, IT governance, services-oriented infrastructure, and organization change management.

The department's remaining budget requests entail proposed reductions as detailed in Table 5 and in G below.

#### **C. CURRENT STATEWIDE CONDITIONS**

Hawaii's unemployment rate jumped from 2.4% in March 2020 to 23.8% in April and came down to 10.1% as of November. Only New Jersey had a higher unemployment rate in November amongst the states and Washington D.C. As noted by UHERO, Hawaii has been hit harder than other states due to the pandemic's impact to tourism. For the DLIR, this economic malaise has caused the deletion of positions and funding in generally funded programs whilst some federal funding has increased, notably for the Unemployment Insurance (UI) Division.

DLIR's federal funding largely fluctuates based on the State's unemployment rate, as compared to the other states. Hawaii has been at the top or near the top in the lowest unemployment rate nationally going back to 2011. Therefore, while the State's unemployment rate remained relatively low, the base funding for the department's larger divisions (Unemployment, Workforce Development) fell. Correspondingly programs that assist those functions experienced reduced funding (Research & Statistics, Employment Security Appeals, General Administration).

However, since the outset of the pandemic, the DLIR has received infusions of state and federal funds that have stabilized funding for these federal programs. Although some backlogs remain, particularly in the UI program, the passage of federal relief funds and federal fiscal year budget has protected agency operations.

Reductions in several generally funded programs has resulted in reduced service levels as discussed further in G below.

#### **D. FEDERAL FUNDS**

The department does not foresee any loss of federal funds at this time.

#### F. BUDGET DEVELOPMENT PROCESS & PRIORITIZATION

The DLIR budget process utilizes a "bottom-up" approach. Each program is requested to review

their current operational activities and identify resources needed to adequately provide the required statutory services to the public at acceptable levels. All program findings are then reviewed by the Director and appropriate staff to develop the department's final budget.

Requests for additional funds are prioritized based on factors that include, but are not limited to, the following: service levels to the public, State and Federal legal mandates, and modernization efforts to increase efficiency and transparency for workers, employers and beneficiaries.

Reductions in funding resulted from previous legislative actions as well as maintaining the Department's focus on its core programs that serve as safety nets or social-economic protection.

#### **G. SIGNIFICANT ADJUSTMENTS**

The following include the DLIR's budget requests in order of priority:

#### 1. <u>Disability Compensation Division (DCD, LBR183) — Modernization Project</u>

This request is to provide funding for annual software license and cloud environment maintenance costs for the Disability Compensation Division's (DCD) eCMS (Electronic Case Management System) Cloud-environment Modernization program. The licenses for AWS are for the cloud-based, virtual desktop that allow employees and customers to work in the DLIR DCD AWS cloud environment in the office and remotely. The Salesforce Front-end Solution Platform licenses enable employees and customers to access the DCD's eCMS. DCD's eCMS Modernization Program aligns with the Governor's and ETS' priorities; i.e. effective government, efficient government, open government, cybersecurity, IT cost transparence, IT governance, services-oriented infrastructure, and organization change management.

#### 2. Workforce Development Division (WDD, LBR111) – Workforce Advisory Boards

This request eliminates funding for the workforce advisory boards' grants. Due to the nature of the COVID-19 Pandemic disruptions, many of the DLIR's partners have not been able to participate in the programs as secondary education delivery has been via virtual or mixed virtual learning.

#### 3. Workforce Development Council (WDC, LBR135) – WIOA Grants

This item reduces \$300,000 for adults, dislocated workers, and youth that do not qualify for federal assistance after skills training.

#### 4. Wage Standards Division (WSD, LBR152) - Position Reduction

The current budget eliminated funding for two positions that will result in less timely enforcement of wage laws. Positions are being eliminated since funding will not be provided.

#### 5. Hawaii Civil Rights Commission (HCRC, LBR153) – Downsize HCRC

The deletion of seven positions will severely affect the ability of the Commission to enforce laws prohibiting discrimination and lengthen investigations.

#### 6. Disability Compensation Division (DCD, LBR183) – Delete Positions

The current budget eliminated funding for positions that will result in reduced services to enforce Workers' Compensation, Prepaid Healthcare, and Temporary Disability Insurance laws. Positions are being eliminated since funding will not be provided.

#### 7. Research & Statistics Office (R&S, LBR901) – Eliminate Career Kokua Program

This reduction terminates the delivery of career and training information used for job placement services.

#### 8. General Administration (LBR902) – Position Reduction

The current budget eliminated funding for two positions that will reduce staff support in the Director's & Fiscal Offices. Positions are being eliminated since funding will not be provided.

#### 9. Office of Community Services (LBR903, OCS) – Downsize OCS

The deletion of five positions will reduce the Employment Service program grants to non-profit organizations that help economically disadvantaged individuals in obtaining and maintaining employment.
