# II. Background and Summary

Boys & Girls Clubs of Maui, Inc. (BGCM), is a non-profit 501(c)(3) organization that operates drop-in service facilities that provide a safe, supportive, non-judgmental, nurturing and supervised environment where youth ages 9 to 17 years old can be themselves, experience positive role models, and learn the values and skills that promote success.

Founded in 2000, the Mission Statement of Boys & Girls Clubs of Maui is to inspire and enable all young people, especially those who need us most, to realize their full potential as productive, caring and responsible citizens.

At BGCM, we focus on increasing graduation rates and improving academic success for each member. We provide award-winning, evidence-based afterschool and summer programs in the areas of:

- Education and Career Development
- Character and Leadership Development
- Health and Life Skills
- The Arts
- Sports, Fitness and Recreation

BGCM serves over 7,000 Maui County youth annually through our six Clubhouses and community outreach activities. The Clubhouses are located in Central Maui (Kahului), Kahekili Terrace (public housing complex, accepts members as young as 6), Paukukalo (in the Hawaiian Homelands community, accepts members as young as 6), Haiku in Upcountry, Makawao in Upcountry and Lahaina on the Westside. Conversations within the community are happening about opening south Maui locations. The annual membership fee for our stand-alone Clubs is \$5 per child, or \$10 for a family, which includes all our quality programs and activities.

The clubs are staffed by youth development professionals who exemplify our values of excellence, fun, flexibility, ohana, respect, teamwork and safety. Not just after-school hangouts, our Clubhouses are safe and positive places where young people come to have fun, learn, do homework, develop social skills, express themselves creatively, and participate in sports. Our young members develop a sense of belonging and connection to the club, and make connections with one or more trusted adults mentors. Continual learning is celebrated and reinforced in every interaction, activity, and lesson in the Club.

The Club offers young people what they need and want most: adults who respect and listen to them; a safe environment where they can have fun and be themselves; and interesting, constructive activities that channel youthful energy into challenging pursuits.

At Boys & Girls Clubs of Maui, we believe that success is within reach of every young person who walks through the doors of our clubs.

2. The goals and objectives related to the request;
For the past 20 years, Boys & Girls Clubs of Maui has strived to fulfill our mission of enabling all young people, especially those who need us most, to reach their full potential as productive, caring, and responsible citizens. Put simply, BGCM is in the business of building good citizens for Maui by incorporating evidence-based strategies of youth development in our Clubs.

In addition to our youth development programmatic strategies happening daily throughout the Clubs, our goal is to create Maui's first-ever One Stop Resource Center (OSRC), to provide support and a safe haven for youth and families that may be facing various hardships.

The Boys & Girls Clubs of Maui proposes to use the requested funds to use its existing 8,800 square foot building (known as Central Club, Building B) to house the Boys & Girls Club Youth Success Center, the County of Maui's first One Stop Resource Center for Youth. All youth, adolescents and their families can visit the One Stop Resource Center to find the services they need and support systems that build on family strengths. Creating the OSRC involved a major revitalization of an unused, dilapidated building located at the Boys & Girls Club in Kahului located next to the central clubhouse, on the island of Maui, Hawai'i. By fashioning it into the main facility for the OSRC, we will be able to provide support for those in need. Currently, the facility is almost compete with renovations. The last portion to be finished is the commercial kitchen, to which conversations are being held with other community partners who are interested in funding the project.

The BGCM Resource Center will provide youth and their families a more seamless delivery system and easier accessibility to services for all youth. BGCM proposes to partner and include all agencies, organizations and groups who serve youth and their families. The Center will provide information and access to services under one roof. All too often, we forget just how difficult it can be for our youth and families to locate, access, and use the available services in the community. One-stop service offers a powerful antidote that will strengthen families. The One-Stop Resource Center will be a collaboration of all of Maui's youth serving agencies and groups that will provide a support system for the families of Maui County and will have a direct and definite impact on the community. Some of the proposed services that would be made available would include but not be limited to: Youth Crisis (suicide prevention, anger management, abandonment, hunger); Education (college prep, learning disabilities, truancy prevention); Technology Access; General Information (community resources to youth programs and activities).

BGCM's goal is to continue to be able to provide opportunities for youth to have a safe place to express themselves, and give them access to the appropriate resources needed in encouraging mental health, such as access to our community partners at the OSRC. We believe that achieving this goal and creating this opportunity for youth and their families within the OSRC, falls in line with the true spirit of Aloha that will unite us all.

## 3. The public purpose and need to be served;

Previously a local county youth center organization, The Boys & Girls Clubs of Maui (BGCM) was incorporated in 2000 and became part of a nationwide affiliation of local, autonomous organizations and the Boys & Girls Clubs of America. With that joining, we were able to adopt the programs of Boys & Girls Clubs of America into our programming. Traditionally, Youth become members of the club for a minimal \$5 per year membership fee, designed to be low so that no child is turned away. Scholarships are also available for youth who cannot afford the fee. However since the pandemic, BGCM has waived all fees. Youth members still have access to all facilities and program activities.

Celebrating its 22nd year anniversary, the Boys & Girls Club of Maui (BGCM), operating clubhouses in Makawao, Haiku, Central Maui, Lahaina, on Hawaiian Home Lands in Paukukalo and more recently in State public housing in Happy Valley (Kahekili Terrace), has been in the forefront of youth development, working with young people from disadvantaged economic, social and family circumstances. Today more than 2,000 boys and girls "at risk" and in need are taking advantage of the programs, activities and service provided by the Boys & Girls Club of Maui. BGCM has actively sought to enrich the lives of girls and boys whom other agencies have had difficulty in reaching. BGCM is dedicated to ensuring that our community's youth have greater access to quality programs and services that will enhance their lives and shape their futures.

Young people, especially in low-resourced communities, have increasingly limited exposure and opportunities to develop necessary social- emotional skills. In a study using a sample of 148,189 middle and high school students, only 20-45 percent reported having social competencies like empathy and decision-making [iii],[iv]. Youth also lack safe and positive environments that encourage the practice and development of these skills. Research also clearly indicates programs targeting social-emotional skills and learning have been shown to improve academic outcomes by 11 percent, [v] cultivate overall well-being, [vii] improve interpersonal relationships with peers and educators, and decrease problem behaviors [viii], [viiii].

Ensuring all youth have the social-emotional skills needed to be successful is a priority in our Clubs. Due to the overwhelming need to build the social-emotional skills of all youth, Boys & Girls Clubs of Maui recognizes the opportunity to address this imbalance by providing formal and informal opportunities to practice these skills from the moment youth walk in the door, and by the resources what will be available at OSRC. Youth will also be able to come to OSRC to look for local sports organizations to join, as well as participate in activities such as dance clubs, performing arts programs, and other after school curricula. This will create a diverse list of resources from youth activities to service providers that are relative to health concerns.

In a world that has never seemed more threatening and devoid of promise for a disproportionate number of America's children, Boys & Girls Clubs provide a tangible measure of hope. Boys & Girls Clubs have a rich and successful history of providing services to communities through non-traditional and innovative programming, such as the proposed OSRC.

At the BGCM's One Stop Resource Center (OSRC) located in Central Maui, we will serve the whole community through partnerships established in response to the COVID-19 pandemic. Through these partnerships, we will increase and improve access to telehealth services, governmental program support, and language referrals. These partners are Malama I Ke Ola Community Health Clinic (MIKO) and Kanu Ka Ike (KKI). The mission of MIKO is to provide culturally sensitive, coordinated primary care services emphasizing education, prevention, and advocacy, regardless of one's ability to pay at the time of visit. Healthcare utilization rates among residents are poor, attributed to many factors that include the lack of health insurance, transportation, and knowledge of the importance of preventative care. Based on federal

guidelines, the entire Island of Maui is a Medically Underserved Population (MUP) and a Health Professional Shortage Area (HPSA) concerning primary care, dental and behavioral health services. KKI is a Native Hawaiian family operated entity, which provides knowledge in the form of culture, health, education and mana to the community. They are weavers of culture and indigenous mindset striving to create access and engagement opportunities for our community. Their generational knowledge and indigenous mindset with modern tools and technology to provide alternative learning opportunities for the overall health and wellbeing of our families and community. Their goal is to enlighten and create connection to identity, while cohesively looking at the wellbeing of the ohana as a whole, living in Hawaii. Though non-traditional in nature, this unique three way partnership between Maui-based non-profit organizations represents a true community response to a shared threat: addressing the needs of families through a one-stop facility of information, health, and support. These partnerships will also help address the rising concern of mental health on youth during the pandemic.

Mental health is a major focus of the OSRC, for both youth and their families. Mental health is a part of an individual's overall wellness that includes thoughts, feelings and behaviors and is just as important as physical health. More than one in five teens has had a mental health disorder that impaired their ability to function at home, school or in the community. Some 50% of all mental illness begins by age 14.

The pandemic amplified heightened mental health issues by creating feelings of isolation, and in many cases leading to increased violence in homes and communities. Through a shared desire to spread awareness of the variety of resources available and accessible to support the well-being of community members - all partner organizations are deeply committed to do whatever they can to reduce the growing stress our local families face, while making certain they also have the tools they need to sustain and emerge from this time supported.

By having a supportive staff, individuals and families will no longer feel alone. They will have resources to find the help that they so desperately need. As the main facility for the one-stop resource center, it will be a collaboration of many of Maui's youth-serving agencies and groups to provide a support system for families of Maui County. It will have space for families to come in and connect with a variety of social service and other agencies in an atmosphere of acceptance and non-judgement. Many people may avoid going directly to a social service agency for fear they will be seen, which often means they don't get these important services they desperately need. By coming to a Boys & Girls Club, they will be more likely to show up and get the help they want and in most cases be provided the assistance they truly need.

# 4. Describe the target population to be served; and

Membership at Boys & Girls Clubs of Maui is open to all youth, ages 9 to 17 (or 18 if still in high school). The OSRC will be open to all youth and their families. Two of our Clubs, Paukukalo in Hawaiian Home Lands and Kahekili Terrace in a public housing complex, also serve ages 6, 7 and 8 due to the need in those communities. Youth can register at any of our Clubs across

Maui, no matter where they live or go to school, and membership is not dependent on any level of socio-economic status. Statistically, however, 70 percent of our members fall into the very low, low to medium income category, and more than half receive free or reduced lunch at school.

There is no criteria to be a user of the center. Youth of all ages, ethnicity, socioeconomic classes, etc. will be allowed to benefit from the center, as well as their family members. There will also be special programs and services for those young adults who are 19 to 21 years of age. If there are needs for special programs not being provided by the One-Stop Resource Center, all attempts and efforts will be made by the staff to connect the family and/or youth to the appropriate organization or agency. The OSRC will also provide service to the families and community of Maui County, including Molokai and Lanai.

### Describe the geographic coverage.

Our Clubhouses are located throughout Maui. Three are centrally located on the island (Central in Kahului, Paukukalo and Kahekili Terrace in Wailuku), one on the Westside (Lahaina), and two Upcountry/Northshore (Haiku and Makawao).

The OSRC is located in central Maui providing an easily accessible location for all community members. Due to the current pandemic, Molokai and Lanai will be able to access resources of the OSRC virtually.

### III. Service Summary and Outcomes

## 1. Describe the scope of work, tasks and responsibilities;

By expanding support for social-emotional development with the creation of the OSRC, we will maximize our already promising impact. We do this by providing youth, who might not otherwise have it, access to fundamental positive youth development opportunities and enrichment experiences for resilience building, and now an opportunity for families to engage in their youth's well-being as well.

In conjunction with our social-emotional development strategy in the Clubs, the proposed One-Stop Resource Center will lend itself to be very conducive to aiding in development and mental wellness of our youth and their families as well. The "one-stop" concept is becoming more and more popular in that it promotes an opportunity to support an enhanced collaboration between One-Stop partners, Maui's service providers. Under the one-stop paradigm, all of a customer's business can be completed in a single contact be it face to face or via phone, fax, Internet, or other means. One-stop customers do not have to hunt around, call back, or repeatedly explain their situation.

The One-stop customer service doesn't necessarily mean that the employee who answers the phone has to provide all the required services single-handedly although many organizations do ensure this level of service. Instead, one-stop customer service can mean that the employee who answers the phone knows exactly who can provide the needed service and is able to transfer the call there, without the customer having to hang up and dial a new number. Where a long-term business relationship exists, one-stop customer service may mean that customers always deal with a specifically assigned representative or team. And, in the context of services provided by multiple federal, state, and local agencies for shared customer groups, one-stop service can mean having all of these services conveniently located under one roof like the Trade Information Center that coordinates the services of 19 separate agencies or the U.S. General Stores located in Houston and Atlanta. Maui's One Stop Resource Center will do exactly this by providing services or at the minimum, access or introduction to services that may be needed by youth and their families.

In order to successfully operate the OSRC, BGCM needs to have software that can support our facility and community's success, which is respectfully requested for funding for in this grant. BGCM will offer appointment assistance for community members needing services from our partners. As well as house all information on partner resources on the BGCM website for ease of access. Currently, BGCM has an exceptional website, but looks to increase our software capabilities in order to better assist community members with appointments and information, and provide the level of service the community deserves. With the use of an effective online software, our to-be-funded community liaison will be able to assist members who are uncomfortable with technology, don't have access to technology, or struggle asking for help, in booking appointments and providing information that best fit their needs.

Our community resource liaison will be the connection, and database of knowledge, for our visitors needing assistance to our partner organizations. They will provide confidential and non-judgmental assistance to our visitors as they call or walk in the door. BGCM looks to fund this position with the use of this grant to ensure that we provide an invaluable experience to the community. This position will also utilize our check-in software, as well as the booking software, to assist in operational functionality. When clients walk in, they will be greeted with a system to help confidentially input their service needs, then can be further assisted by the liaison.

Though the One Stop Resource Center is currently suitable to provide services, there are still improvements needed to enhance its operations and provide a safe and enjoyable environment for the people utilizing the building. Additionally, BGCM is requesting funding for a marketing budget that will effectively increase community awareness of the One Stop Resource Center. BGCM intends to utilize existing digital media and social channels, newsletters, BGCM website, and relationships with community members to increase community awareness of the OSRC.

2. Provide a projected annual timeline for accomplishing the results or outcomes of the service;

If sufficiently funded, BGCM plans to fulfill our programmatic and OSRC goal within 12 months, and as COVID-19 allows.

Assessing our overall success as a service to local youth, we understand the importance of looking at this information over time. To continue to stay relevant and address youth and family needs, BGCM plans to create pre and post surveys for feedback and ensure we are meeting expectations at the OSRC as well. We plan to survey all members who utilize the OSRC on an annual basis. This will include surveys pre and post surveys during their first visit.

One of the most significant evaluation tools we use at the club level is the annual National Youth Outcomes Initiative (NYOI). Designed and implemented by Boys & Girls Clubs of America, every club member is asked to participate in an online survey that measures how well their club experience is meeting their needs, as well as what is going on in their personal lives. Clubrelated areas include sense of belonging, emotional safety, physical safety, adult connections, staff recognition, and overall club experience. Members are also asked questions relating to their time away from the club, including if they have been bullied at school, if they have volunteered to do community service, how important is school to them, and their avoidance of risky behaviors, including smoking, drinking, doing drugs and sexual activity.

The NYOI surveys will be an invaluable asset in addressing youth needs that may not be being met at the clubs, and that we can ensure are available at the OSRC.

As millions of out-of-work citizens look toward recovery, young people need Boys & Girls Clubs now more than ever to access the critical support and help they will need to succeed during these very trying times. With a safe space and appropriate service providers, today's youth and families will connect with the appropriate service providers in a timely manner. Determining the value of our programs and ultimate impact on young people is of critical importance to Boys & Girls Clubs of Maui. The following metrics have been selected to evaluate success at providing higher quality experiences that

result in greater outcomes for the youth and community we serve through the One Stop Resource Center.

Our main goal is to provide a central location for youth and their families to access community resources and support.

- Connect with the appropriate organizations and agencies that provide the needed services.
- Warm introductions and hand-offs to the people who are qualified to provide support in a specific area.

Boys & Girls Clubs of Maui has spent the past 20 years providing excellent, evidence-based afterschool programming to thousands of Maui youth.

Chief Executive Officer Kelly Pearson has been with BGCM since its inception in 2000. She was Director of Operations for 14 years, and was promoted to her current position in July 2014. Kelly has a Bachelor's Degree in Business Administration from the University of Hawaii, Hilo, and a Master's Degree in Human Resources Management from the University of Hawaii, Manoa. In 2012, Kelly was selected to be a Woodruff Fellow. Additionally, she graduated from the Hawaii Community Foundation Hawaii's Emerging Leaders Program and the Non-Profit Executive Leadership Program at the University of Washington.

With an annual agency budget of approximately \$2.8 million, BGCM has years of experience managing large grants, including both the fiscal and programmatic aspects. Our financial office, led by Director of Finance Susan Ellingwood, utilizes financial management systems that are designed to maintain accurate and comprehensive accounting records meeting financial and audit requirements in accordance with Generally Accepted Accounting Principles (GAAP). Our system adequately identifies the source and application of funds for all activities and grant programs.

Susan works with agency management and the Board of Directors (including the Finance Committee) to ensure proper governing and accounting policy and procedures are in place and followed. It is these accounting practices that give us the tools to enable us to properly administer these requested funds.

Gina McLain, Administrative Director, has been with the organization for 18 years. She started as a Club Director in 2004 and then joined the administrative team a few years later. She is vastly knowledgeable in many of administration, safety, compliance, and operations. Her role in the OSRC would be to provide administrative support.

The OSRC will be facilitated by our Child & Safety Coordinator, Tania Ilaoa. Tania has been with the BGCM for two years. She has over 10 years of experience in youth leadership, development and education. She also has 20 years of experience with coordinating and facilitating non-profit partnerships, community outreach programs, and service events.

The grant will be reported on by Makenna Anderson, BGCM's Grants Specialist. Makenna has experience in managing and administering grants for non-profits within Maui County. She has recently graduated with her Masters in Business Administration from Pacific University and holds a Bachelor's degree in Business Administration with a focus in Marketing from UH-West Oahu.

The Boys & Girls Clubs of Maui proposes to use its existing 8,800 square foot building (known as Building B) to house the County of Maui's first One Stop Resource Center for Youth. This building is located on the same property as the Central clubhouse, on County of Maui property. Having been recently renovated, our center is prepared to currently offer services, with the exception of using our commercial kitchen, and staffing.

The CEO oversees the entire organization, its mission and goals. She will work directly with the other staff to ensure all deliverables of this grant is achieved. Child and Club Safety Coordinator Tania Ilaoa will work hand-in-hand with the One Stop Resource Center's Community Resource Liaison in ensuring that relationships with community partners will be established and cultivated in order to provide a wide spectrum of resources. Makenna Anderson, BGCM Grants Specialist, will be responsible to submit timely and accurate reports to the State of Hawaii. Gina McLain, Administrative Directors, supports compliance and human resources items, while Director of Finance Susan Ellingwood will be accountable for all fiscal reports and tasks. Together this team will contribute over 50 years of non-profit experience to oversee the Maui' first One Stop Resource Center for youth.

All staff of Boys & Girls Clubs of Maui are required to participate in training relative to their positions within the organization. Some of this training is also a requirement of Boys & Girls Clubs of America and is provided via an online system (webinars, interactive training, etc.).

Supervision follows a chain-of-command, with the Chief Executive Officer (CEO) at the top, the Director of Operations (DOO) reporting to the CEO and all of the Club Directors reporting to the DOO. At the club level, the Club Directors supervise the Program Directors and the Youth Development Professionals.

BGCM is also requesting funding to staff the OSRC appropriately with dedicate associates including a community resource liaison, and a custodian due to increased use of the facility, and for additional cleanliness precautions due to COVID-19.
