four Health Center locations and serves over 10,000 patients on the island
of Hawai'i. Hamakua-Kohala Health has been serving the Hamakua coast
for over 50 years. HKH Health Center locations are in rural locations and
transportation is a major barrier to primary and behavioral care. HKH
clinics provide approximately 18,000 patient visits annually. Our foundation
and history on the Hamakua and Kohala coasts can be traced to the first
dispensaries of the early sugar plantation days.

Our mission is to "Provide quality healthcare that is responsive to our patients' and communities' needs".

#### A FEDERALLY QUALIFIED HEALTH CENTER

Hamakua-Kohala Health is a Federally Qualified Health Center (FQHC). We provide comprehensive, culturally competent, quality primary, behavioral health and dental care to medically under-served communities and vulnerable populations. This includes all people who face barriers in accessing services because of poverty, language or cultural differences or an insufficient number of health professionals or resources in the area.

- 2. The goals and objectives related to the request;
  - The current facilities at Honokaa Health Center are over 25-years old with no room for expansion. Due to the cramped and antiquated space, it is difficult to recruit and retain quality healthcare professionals to meet the growing demand. Federal dollars are available for expanded specialty care services, however, because of the lack of space, we are currently unable to qualify for those additional federal dollars or to add those services. The goal of this request is to secure funding to complete the planning, design, permitting and beginning infrastructure work for construction of a new two-story 15,000 square foot facility in Honoka'a that will be designed to include collaborative workspaces, integrated team spaces and community rooms for enhanced partnerships with social service organizations to Patient Centered Medical Care (PCMH). It will also include
    - Expanded Primary Patient Care Services Areas
    - Expanded Outpatient Behavioral Health and Substance Abuse Treatment
    - Wellness Classroom
    - · Pediatrics, women's health
    - On-Site pharmacy and Lab
    - Telehealth Room
- The public purpose and need to be served;

The new Center will enable Hamakua-Kohala Health to increase the number of physicians, psychologists, and telehealth services to shorten appointment wait times for patients and address Social Determinants of Health by increasing Enabling services such as transportation, food

insecurity and elderly care. The new center will also create new jobs as well as expand training opportunities for residents wanting an opportunity to pursue a career in the medical field.

4. Describe the target population to be served; and

Our patient population consists of:

- A) 10,300 patients
- B) 60% below the 200% of Poverty.
- C) 34% Medicaid patients
- D) 24% Medicare patients

Hamakua Kohala Health serves a large elderly patient population (24% Medicare). We wanted to ensure this population is not isolated and have a place to turn to for care, medications, and other assistance. Our telehealth goal is to maintain healthcare continuity and quality of care through technology.

Hamakua-Kohala Health provides access to quality health care for low to moderate-income individuals that are not insured, or insured by Medicare, Medicaid or MedQuest. This center provides services regardless of patients' ability to pay. None of the private practice physicians in this rural area accept Medicare, Medicaid or MedQuest patients. As a federally qualified health center, Hamakua-Kohala Health delivers high quality, culturally competent, comprehensive primary care, as well as supportive services such as health education, translation, and transportation that promote access to health care. Our system of patient-centered and integrated care responds to the unique needs of the diverse medically underserved patients in this area. In 2021, we served over 10,000 patients and over 30,000 visits.

5. Describe the geographic coverage.
The population of the area served is over 26,000 and spread over 100 square miles. Hamakua-Kohala Health provides medical, dental, and behavioral health services to the communities of Hawi, Kapa'au, Hala'ula, Makapala, Kawaihae, Waimea/Kamuela, Waikoloa, Honoka'a, Kukuihaele, Waipio Valley, Pauuilo, O'okala, Ninole, Laupahoehoe, and Hakalau.

- Laupahoehoe Health Clinic to address the growing behavioral problems among school-aged children and youth, a clinic was opened at Laupahoehoe School to meet those needs.

While many healthcare organizations struggle to recruit and retain physicians, Hamakua Health Center has had great success in attracting physicians to this

rural community and is expanding all of our health clinics to meet the growing demand for quality healthcare.
