A brief description of the applicant's background;

Hana Health is a 501(c)(3) non-profit organization and Federally Qualified Health Center (FQHC). The purpose of Hana Health is to improve the general health and well-being of the Hana community through the provision of medical care and other social, economic and health related programs. Hana Health is the only health care provider in the Hana district, serving the primary health care and

emergent medical needs of residents and visitors alike.

Hana Health currently provides primary medical, dental and behavioral health services to the people of Hana. Unlike most primary care clinics in the State and country, Hana Health coordinates activities with American Medical Response and Maui Memorial Medical Center in the provision of urgent/emergency medical services prior to transport to the hospital on the other side of the island. This takes place seven days a week, 24 hours a day. Hana Health is the source of almost all COVID-19 related services in the Hana District including testing, treatment and vaccination.

In fiscal year 2020-2021, Hana Health provided medical care to 1,528 individual patients who made 4,898 visits to the Health Center. Dental care was provided to an additional 603 patients who made 1,272 visits to the health center. Almost half of the patients served were insured through Medicaid, Medicare, or were uninsured and provided with subsidized care. Fifty one percent (51%) of patients served were Native Hawaiian.

The goals and objectives related to the request;

Goal 1. To advance health equity for Hana's medically under- served population (designated by federal government) the majority of whom are Native Hawaiian or Part Hawaiian, as well as the persistently underserved, residents of this rural, isolated community.

Goal 2. To improve the health, well-being, resilience and economic security of all community residents through an expanded health care delivery system.

Objective A. Complete construction of the Rehabilitation and Support Center, a new, 3,800 square foot development located directly behind the medical center. Specifically;

 The Rehabilitation and Support Center is a mixed-use facility which will accommodate behavioral and mental health services, physical therapy and cardiac rehabilitation, tele-health and complimentary/cultural healing practices. The facility will also include administrative offices which have been housed in trailers for more than twenty years.

Objective B. Complete pre-development plans for on-site affordable workforce housing in order to recruit and retain health care workers, locum tenens physicians and specialists. Specifically;

 Complete site plan, conceptual design work, construction documents and building permit application for two 500 sq. ft. studio units to be used by traveling medical providers/specialists, two 700 sq.ft. single family dwellings and two 1,000 sq. ft. single family dwellings to accommodate

health center staff and their families, who are relocating to the area for employment with Hana Health, i.e. physicians, nurses, nurse practitioners, administrative staff.

The public purpose and need to be served;

Construction of modern health care and support service facilities including workforce housing will improve the health, wellness and safety of the resident population, as well as visitors to the area who often need urgent care for illness and injury. This has never been more apparent than during the on-going COVID-19 pandemic. Without Hana Health, the only medical center in the District of Hana, the entire resident population would be at greatly increased risk for infection and other serious, often fatal medical problems and injury resulting in death. Services close to home and the need for professionals to provide those services has never been more important.

Located on the eastern side of the island of Maui, the moku (district) of Hana (Census tract 301) is one of the most isolated, rural areas in the state of Hawaii. The one-way trip from Hana to the population center of the island, takes approximately 2.5 hours, at a speed of between 10 and 25 miles an hour, along a single lane road with 617 turns and 56 one-lane bridges. If not for Hana Health, virtually all health care – primary, specialty, tertiary, ancillary, urgent/emergent services - would need to be obtained from the main population center on the other side of the island. Hana is federally designated as a Medically Under-Served Population, a Primary Care Health Professional Shortage Area, a Dental Health Professional Shortage Area and a Mental Health Professional Shortage Area.

According to U.S. Census 2019 5-Year Estimates, approximately 75% of the roughly 1,600 Hana District residents are Native Hawaiian or Part Hawaiian. Hāna's median household income (\$56,339) is 43% below the County of Maui (\$80,948). The March 2021 Hana Community Needs Assessment (conducted by Anthology Marketing Group) found that 16% of the population was unemployed and an additional 13% were underemployed. Sixty percent of the patients served at Hana Health live at or below 200% of the poverty level.

Department of Health data confirms that the district of Hana has the highest percentage of diabetics in the state, the third highest rate of mortality from all causes, and the fourth highest rate of death from both heart disease and cancer. Native Hawaiians have higher rates of death for diabetes and heart disease, as well as cancer and other leading causes of death as compared to the overall State's population (Center for Native and Pacific Health Disparities Research, John A. Burns School of Medicine, University of Hawaii). Longevity disparities continue to persist, with Native Hawaiians having the shortest life expectancy,

with a gap of approximately 10 years (Hawaii Journal of Medicine & Public Health, January 2017). Racial/ethnic disparities can be partially explained by differences in socio-economic status, health behaviors, health care access and racism ((University of Hawaii Study November 2019).

For vulnerable low-income clients who utilize community health centers as their safety net, access to specialty care remains a huge challenge. There is a clear disparity in specialty care access for the uninsured and underinsured. Income and the "right" insurance are the salient factors that impact access and utilization of specialty care services in addition to a number of other social determinants. Further, patients in rural areas experience higher preventable hospitalization and mortality rates than those in urban areas as noted in a 2020 edition of Health Affairs. (Study author Kenton J. Johnston, Ph.D., M.P.H., an assistant professor of health management and policy at Saint Louis University).

Overall, Hana District residents, particularly Native Hawaiians, have a high-risk health profile resulting in the onset of preventable chronic health conditions and premature death. This is exasperated by high rates of unemployment/underemployment and poverty. In addition, there is limited access to mediating opportunities due to the extreme isolation, small population, limited economic base and rural nature of the Hana District.

Built in 1965, Hana Health facilities are inadequate to meet current and projected patient service needs. Four modular units were placed on the property years ago to support program and administrative space needs, and wellness programs often operate under tents regardless of weather conditions. As the primary health care provider in the district, Hana Health is accountable for meeting the large majority of each patient's physical and mental health needs, including prevention and wellness, acute care, chronic care and urgent care.

Additionally, the geographic location of Hana Health provides one of the most significant challenges to recruiting and retention efforts. The lack of <u>any</u> housing in the Hana District has seriously impacted our ability to recruit and retain staff at all levels of the organization. This past May, Hana Health was put in the position of having to purchase one of the only "affordable" homes on the market (\$700,000) in order to assure housing for the newly recruited COO. Although we currently have a candidate for the very difficult to fill Medical Director position, there is absolutely no housing available in the district to either purchase or rent. The only alternative is to secure housing on the "other side" of the island, requiring a daily commute to the health center, either by air or ground transportation. This is an unrealistic option. A newly recruited nurse practitioner will be staying in a one-bedroom duplex while her family (husband and two children) remain on Oahu until alternative housing can be found. It is not yet

clear whether this will be sustainable for her. The logistical nightmare of providing care in the remote Hana region, has been on-going for years, compromising our efforts to secure and retain competent staff and placing further restraints on our expansion and quality improvement efforts. In order to remediate this on-going problem, Hana Health plans to construct its own affordable workforce housing in order that we may appropriately staff the health center and serve the Hana community.

The entire District of Hana will benefit from this project and the expanded level of health care that will be provided. Native Hawaiians, children, the elderly, those with or at risk of chronic health conditions, those with specific medical conditions, and those with behavioral or mental health conditions are primary targets of the programs to be provided through the Rehabilitation and Support Center.

III. Service Summary and Outcomes

Describe the scope of work, tasks and responsibilities;

Hana Health approached development of the Rehabilitation and Support Center methodically, completing the pre-development planning process as funding was secured. To date, all pre-development work has been completed. The necessary approvals have been secured and the Maui County building permit obtained. A construction contract has been executed and construction was initiated in mid-October 2021. Construction is on-going with project completion expected in November 2022.

The Executive Director is responsible for managing/supervising the Rehabilitation and Support Center construction project in partnership with Urban Works the architect firm that has been contracted to manage the construction contract and construction phases of this project.

Urban Works was established in 1984 and has extensive experience in architecture, master planning and the design of community buildings. The two

principals – John Ida, AIA and Lorrin Matsunaga, AIA LEED AP, each have over thirty-five years of professional experience and are licensed in Hawaii and Washington.

F&H Construction is the General Contractor for the project. The company has served Maui since 1972 and has developed public use facilities similar to the Rehab Center both in Hawaii and California.

The Executive Director is also responsible for managing the development of the workforce housing project and is working with G70 a full service architectural firm to complete all pre-development work as follows:

- Schematic Design phase would include preparation of complete design and basis of design; final code check; and consulting with Structural, Mechanical, Electrical, Plumbing (SMEP) engineers as to service options to the site. Final deliverables to include the final schematic set which entails: a cover, code summary, floor and roof plans, elevations, building sections, corresponding SMEP basis of design narrative, and site civil and landscape design. A basis of design, conceptual exterior renderings, and updated conceptual estimate will be provided.
- 2. Design Development Phase is to establish design elements, layout, size and finishes for the project. The engineered system would be advanced with consulting SMEP engineers. This phase would also conclude final site electrical design and confirm utility service requests. Final deliverables would include cover, code summary, floor and roof plans, finish schedules and corresponding SMEP plans and system schedules and details. Basis of design will be updated with conceptual exterior renderings and conceptual estimate also revised.
- 3. Working Drawing/Construction Document phase would establish design elements, layout, size and finishes for the project. Site electrical design will be completed and confirm utility service request. Coordination of interior design and submit building permit applications to Maui County and monitor review. Integration of County comments into CDs and prepare final construction submittal documents for Hāna Health review and approval prior to construction bid. Final Design submittal would be provided with specification and details of summarized plans in previous phases and include exterior/interior finish board, FF&E plans, a final basis of design, and final estimate.

Hana Health is committed to providing quality services to all beneficiaries in an organization - wide effort to continuously improve our processes and the delivery of care to the community we serve. Hana Health maintains a Quality Assurance/Performance Improvement System to assure excellence in the quality of care provided. The system is designed to increase accountability, support quality improvement, facilitate and support program decisions, monitor the population's health status, empower patients and families to make informed health care decisions and provide evidence to eliminate wasteful practices. Hana Health's quality assurance program measures, monitors, tracks and improves performance in key aspects of all operations.

The Board of Directors maintains oversight for the Quality
Assurance/Performance Improvement Program and will be monitoring progress
on both the construction of the Rehab Center and the pre-development planning
for workforce housing.

Urban Works is the architect firm that has been contracted to manage construction of the Rehabilitation and Support Center. OAC (Owner, Architect, Contractor) meetings take place every two weeks and provides an opportunity to assess progress and resolve any issues or conditions that warrant discussion. This will ensure that the completed building support the design intent, conforms to the construction documents and ensures the quality of materials and workmanship. The architect is available for advice and consultation throughout the construction phase. Additionally, the project will be monitored against both time and cost objectives.

The Executive Director will work with G70 on contract implementation for the planning of workforce housing and assure that all contractual requirements are met including time and cost objectives.

V. Experience and Capability

1. Necessary Skills and Experience

Hana Health has been providing medical care to the district of Hana since July 1997 when the State transferred the operation of the Hana Medical Clinic to Hana Health (Act 263). State POS agreements have been awarded to Hana Health for the same period. Hana Health was granted Federally Qualified Health Center status in 2000 after meeting numerous requirements and has received federal operating support from the Bureau of Primary Health Care since that time.

Hana Health's Executive Director and Board of Directors has a demonstrated track record in securing and managing public and private funds for operations, capital improvement and special projects. In addition, Hana Health manages a twelve-acre project site which currently includes the medical center, an employee residence, administrative offices, Hana Fresh Nutrition Center built in 2012 (a \$2.3 million project), the Hana Fresh organic farm and farm stand. The Executive Director has managed three Environmental Assessments, construction of the \$2.3 million nutrition center, a \$900,000 medical center renovation project, an \$80,000 employee residence renovation project, the closure of four Large Capacity Cesspools and installation of three septic systems, a \$200,000 project. She is also managing the pre-development phase of a 30 acre parcel of property located immediately behind the leased state property.

The Executive Director worked with Urban Works Architect firm in the development of design and construction documents for the Rehabilitation and Support Center, secured a determination from DLNR that additional environmental review is not required for project construction pursuant to Hawaii Administrative Rules Section 11-200.1-11 and secured the Maui County building permit. She is currently working with Urban Works in the management of the construction component of the project.

2. Facilities

Hana Health operates on a 2.035 acre parcel of property where the current medical center is located, and on an adjoining ten acre parcel where the Hana Fresh farm is located. Both parcels are owned by the State of Hawaii and have been leased to Hana Health for 55 years, at \$1 per year. With the exception of the Hana Fresh Nutrition Center which was completed in May 2012, Hana Health facilities range from more than 50 years old to more than 90 years old and are in need of continual repair and maintenance. Built in 1965, the current 4,000 square foot medical center underwent a major renovation several years ago including the installation of new windows, floors, central air conditioning and a new roof. However, the space is inadequate to meet program and administrative needs. Four modular units have been placed on the property to support both program and administrative operations.

The Executive Director is responsible for project implementation and oversight. She has worked with several architectural and planning firms to address the completion of state and federal environmental assessments, zoning issues, conceptual designs for the health center campus, schematic designs and construction documents for the Hana Health Nutrition Center and the Maui County building permit process. She managed construction of the Nutrition Center, as well as the permit process for the Telemedicine, Business and Training Center which did not move forward due to lack of approval from DLNR. Ms. Vasconcellos managed a \$900,000 state CIP grant for the renovation of the medical center and the installation of three new septic systems to replace the existing Large Capacity Cesspools located on the property as required by EPA. Ms. Vasconcellos is currently working with Urban Works, a Honolulu based architect firm contracted to develop the design and construction documents for the Rehab Center.


