A brief description of the applicant's background;

The Kamuela Philharmonic Orchestra Society is a non-profit organization established in 2005 which is dedicated to bringing live, high-quality orchestral music to audiences on Hawaii Island. The Kamuela Philharmonic celebrates and promotes the timeless beauty of classical music, as well as the rich cultural and musical traditions of the Hawaiian people. Through our Children's Concerts and other forms of educational and community outreach, we nurture a love and understanding of orchestral music in young people. In addition to our education and outreach programs, the Kamuela Philharmonic Orchestra provides a showcase for our talented local musicians each concert season. This organization is staffed by volunteers with the help of contracted staff. The volunteer base is well-organized with seasoned and committed volunteers and the staff is dedicated to mission of the organization. Both the volunteers and the staff are managed by members of the Board of Directors.

2. The goals and objectives related to the request;

- 1. Provide free community concerts to rural communities on Hawaii Island: These concerts will be held in out-door venues easily accessible to all people and will encourage the enjoyment of live music in a health safe enjoyment. The music performed to the community will be varied between Hawaiian mele's, holiday appropriate music and classical pieces. The repertoire is carefully chosen to spark interest in a large cross section of people of all ages.
- 2. Inspire youth to participate in one of our in-school programs or attend the yearly educational concert: This orchestra supports in-school educational programs which students are encouraged to attend. There are both music application classes and side-by-side instruction for students who already play an instrument.
- 3. Provide free educational concerts to students grades 3 12. During these concerts students learn about each instrument, how they sound, what it takes to play one and how they work in an orchestra. These concerts are offered free and are held in an auditorium or theater so that students get the full experience of attending an orchestral concert. Teachers are provided with educational materials that they can use before the concert to teach about the music being performed and follow up packets are sent out to teachers to evaluate the program.
- 4. Provide free community concerts to seniors in care homes: Besides the out-door venue concerts these groups will be performing for Seniors in senior living homes such as Life Care of Kona and Hilo and Yukio Okutsu State Veterans Home in Hilo.
- 5. Provide employment to musicians: These concerts will feature local musicians from the orchestra and support them financially. During the 2021-22 season 40 musicians were employed by KPOS.
- 6. Bring awareness about our orchestra and encourage attendance to other programs: These concerts offer an opportunity to introduce new people to our orchestra and our programs. We use this opportunity to encourage people to sign up for our monthly newsletter or follow us on social media.

The public purpose and need to be served;

Rural communities in Hawaii are underserved in any arts field. Access to live orchestral music is especially challenging because the orchestra performs in a concert hall that is too far for many to travel to. To meet these challenges Kamuela Philharmonic Orchestra Society provides public access to free symphonic music in several ways:

This organizations sends small ensemble groups to these rural areas and perform in small outdoor areas which is easily accessible to the community members. These concerts are very popular with families looking to expose their children to classical, symphonic music but have limited access to indoor, ticketed concerts. Small ensemble groups also go directly into senior care homes with live orchestral concerts serving seniors who mostly would not be able to travel to the concert hall for an evening concert.

This organization devotes 30% of its operating budget to free educational school programs. These programs go directly into the schools to teach music appreciation, introduction to orchestral induments and side-by-side instruction for students needing more advanced

training. This organization also helps students repair and purchase instruments for students who would like to play an instrument and cannot afford one. Each year we have more requests from schools that we can meet but the programs keep growing as funding is allowed.

Describe the target population to be served; and

This organization serves all ages and cultures of peoples on Hawaii Island. We are especially concerned with reaching students grades 3-12 in our educational outreach programs, these students have limited access to orchestral live music. The second target group we serve is the seniors in our community, especially those living in senior living facilities or the veteran's home.

30% or our operating budget is targeted at youth education, and we work closely with the title 1 public schools getting music education into these schools. Programs include: Music appreciation, instrument care and technique side-by-side instruction to students needing additional learning, concerto competition for advanced students to play with the orchestra and a program where free instruments are given to students needing them.

Exceptional care and consideration are given to our Kupuna (Senior) community members. During concerts bussing and assistance is available to concerts. During the pandemic when indoor concerts were cancelled small ensemble groups went into the senior residence homes and performed concerts during holiday such as veterans' day. Activities Directors in Senior living homes tell us how important live music is to the senior's mental health and we are committed to bringing live music to them.

Describe the geographic coverage.

This organization stives to serve the entire Hawaii Island communities. This island is rural, and communities are spread out with difficult traveling distances between them. While the concert hall is in the center of the island it still is a 2-hour drive from some communities. This makes the small ensemble programs so important. These free community concerts travel to other communities on the island making live orchestral music accessible to all. The same is true with the music educational programs. The music education team travels to the schools and serves as many schools as possible in a year depending on funding. To manage these efforts, we have set up East Side and West Side coordinators. These coordinators understand their communities the best and have close ties to the schools and venues in their communities making the effort to reach as many pockets as possible of the island.

Communities directly served during 2021 were: Kona, Hilo, Waimea, Kau, Honoka'a, Mountain View, Volcano, Waikoloa, Keauhou and Hawi.

III. Service Summary and Outcomes

The funding from this grant will cover free community concerts on Hawaii Island with enfaces on youth education, awareness to orchestral music and serve seniors. The annual timeline will begin in August 2022 – June 2023.

The work to be accomplished will be to take live orchestral music into the community, schools, and senior homes to entertain, inspire, uplift, and educate youth.

The tasks will be to program:

Schedule and evaluate visits to the schools

Schedule, programs and evaluate the outdoor small ensemble concerts

Schedule, program and evaluate the education concerts

Schedule, program and evaluate the senior home visits

Promote the programs with social media, flyers, newsletters, and public service announcements. The responsibilities these tasks will be divided between the artistic director, the east and west side coordinators, the education chair, and the personnel manager.

Artistic Director (Paid Staff): Responsible for programing the school visits, programing the outdoor concerts, programing the education concerts, and programing the senior home visits. Organizing the concerto competition. Rehearing the musicians and directing larger concerts.

East/West Side Coordinators (Volunteers): Responsible for scheduling outdoor venue for Small Ensemble concerts and scheduling school visits. These coordinators also collect and organize the reports which are made after each event and prepare the evaluation of the program for the board's review.

Education Chair (Board Director): Responsible for securing the venue for the education concert, inviting the schools, and organizing the volunteers who help with the concert. Collecting data from the teachers which we will use to evaluate the program.

Personnel Manager (Paid Staff): Responsible for hiring the musicians after the Artistic Director programs the events. Sends contracts and communicates with the Treasurer for paychecks to be sent to the musicians after the performances.

Marketing Manager (Paid Staff): Responsible for marketing the concerts and programs so that the community knows about them. This person also is responsible for documenting digitally the programs to be used for educational purposes, web site promotion and YouTube videos.

Provide a projected annual timeline for accomplishing the results or outcomes of the service;

School visits are allowed September, October, November, December 2022 and January, February, March, April 2023. During these months, the education team will perform music appreciation classes and side-by-side instruction in public title 1 schools on Hawaii Island. Most years 20 schools are visited with over 2000 students served.

Concerto Competition for advanced students is held in September 2022 and the concert where they perform with the orchestra is in January 2023. Unlimited applicants can apply but usually 15-20 apply and 3 winners are chosen.

Education Concert for all students happens in March 2023 and serves 1000 students.

Community Concerts are offered all year round but are often held around holidays such as Memorial Day, 4th of July, Labor Day, Veteran's Day, Mother's Day, Father's Day, the December Holidays, MLK day and Easter. During a typical year 35-40 concerts are performed and 10,000 people served.

Senior Concerts are offered during Veteran's Day, Mother's Day, Father's Day, the December Holidays. The senior care homes served are Life Care of Kona and Hilo and Yukio Okutsu State Veterans Home in Hilo. Typically, 9 concerts per year are performed with 500 people being served

This evaluation includes quantitative numbers such as how many people participated in the program and how many people were served. It also includes the ages and any target group that was served. The coordinator also asks the venue for a letter with feedback which is used to evaluate the program and make changes. There is a volunteer assigned to take photos or videos which are also used for promotion. This information is communicated back to the Artistic Director, Directors of the Board and Chairs of Committees to make necessary changes and improvements.

A detailed Google Document is kept which shows each program and imbedded under each event is the quantitative numbers, the amount of calabash money collected, the number of musicians paid for services performed, names and titles of the coordinators responsible for organizing the program. Outcomes are tracked with both quantitative numbers and qualitative evaluations and letters. These are easy to upload into any system as proof of program accuracy and performance. For education programs students are also evaluated and encouraged to write letters which we archive for proof of the effectiveness of the program. Before staff and musicians can be paid for their services these reports must be in.

If appropriation differs from the amount included in this application the Board Treasurer will provide a detail of what funds were spent and on what services. Because these programs are well established, and the coordinators have strong history with the programs we do not anticipate this to happen. There have been some pivot programs which have happened due to recent State health Mandaites, but the core programs have still been performed even if they needed to be on a digital platform.

V. Experience and Capability

This orchestra has served Hawaii Island since 2005. Since its inception we have provided both ticketed and free concerts to the community, educational programs to the schools and sought to encourage young people to play an instrument. Our founder, Madeline Schatz-Harris dedicated her life to teaching music and starting this orchestra on Hawaii Island. We continue her vision as new leadership has taken over since her retirement. We honor her memory each year when we host a concerto competition where advanced students compete for a spot to be the featured soloist at a concert. This organization continues to grow and learn now things. We started as a string ensemble group and are now a thriving 40-piece orchestra. Our ticketed major concerts are fundraisers for our other programs which we offer free to the community. These programs grow each year along with our educational outreach in the public schools. In 2021, even with COVID restrictions, we performed over 40 concerts and did 10 school visits. This is a testament to our connection with the community and the trust the schools have in our educational team.

Board President, Joel Gimple has been with this organization since the beginning in 2005. He has served as past president, vice president, director, and advisor. Joel is a retired lawyer and was responsible for writing our bylaws and helping to establish our non-profit status. His leadership at the board level helps new board members to develop an understanding of their own leadership potential and strengths. We count on his sound leadership and advise as we have navigated through the restrictions COVID-19 as faced us with. The Board President is acting Executive Director and supervises the Marketing Manager and Grant Manager.

Artistic Director, Brian Dollinger joined KPOS in 2016 after a long national search after our founder retired. Brian has been instrumental in leading this organization and establishing a more organized and efficient educational team which works side by side with students and teachers providing additional music education in our public, title 1, schools. Brian works closely with the Board of Directors and supervises the Personnel Manager. More about Brian: Brian Dollinger – Kamuela Philharmonic

Musicians are auditioned, classically trained professionals in their field and are rehearsed regularly to prepare for concerts, educational programs and community outreach. Throughout the year this organization employees around 40 musicians.

Many of these musicians have been with the orchestra since the beginning and are also private instrumental teachers and/or music teachers in the schools. These teachers have supported the growth of the organization by inspiring their students to join the orchestra. Musicians are contracted by project and are paid through the IRS 1099 program. The musicians report directly to the Artistic Director.

She is instrumental in connecting schools with music programs and is an amazingly effective fundraiser for youth education programs. Susan volunteers her time to this outreach and leads an educational team which has worked together since 2016,

Sharon Cannon – West Side Coordinator and Chair of the Education Program - Kamuela Philharmonic Orchestra's Board Treasurer and volunteer coordinator. Team Leader of Music Education for West side Children's Outreach Programs. Cannon has been an orchestra member since 2005 and has a degree in Music Performance. She has been the lead organizer in the children's education programs since the beginning in 2016. She has also lived in this community for over 30 years making her one of our best assets to connecting the community to this program. Cannon volunteers her time to this outreach. She also leads an educational team which has worked together in the schools since 2016.

Donna Nichols – **Personnel Manager and Coordinator for the Small Ensemble Programs** (Paid Staff) - Resident of Hawaii Island for two years and a professional executive assistant for forty-five. Donna has owned a record label since 2003 and has produced and distributed more than 90 albums and singles for musicians from around the world. She has volunteered for many philanthropic organizations since 1988 including the Children Affected by AIDS Foundation, the Wellness Community of San Diego, Mainly Mozart San Diego and participated on the board of the San Diego Flute Guild for 13 years. As Personnel Manager, she fosters a close relationship between the musicians and Artistic Director, and other constituents. She manages the Small Ensemble Programs, books musician travel for MasterWorks performances, handles all documentation and nurtures positive relationships between groups.

Donna Nichols (Paid Staff) – Marketing Manager - As Marketing Manager, she is responsible for Website management, social media, YouTube management, email marketing, press releases, event promotion for MasterWorks events and fundraisers, design/printing of concert programs, manages Zoom board meetings, handles systems administration (Box).

As Kamuela Philharmonic Orchestra Society's programs grow and become more professionally organized, we see the interest with the community growing. This awareness brings more private funding. During the Pandemic we developed more involvement through social media and virtual platforms which has broadened our audience. This has directly influenced the donations received to the organization.

We now have committed private donors who will sponsor ticket quarterly concerts when indoor concerts are allowed again which will be used as fundraisers for the organization.

Several reliable grant funding has come from private philanthropy foundations: The Laura Jane Musser Foundation, The Dorrance Foundation, The John M. Ross Foundation and The Richard Smart Foundation.

We will continue to apply for grant support though our local County of Hawaii, State Foundation for Culture and the Arts as well as Hawaii Community Foundation. This year we will also be requesting funding from national sources though the NEA grant programs. This will be the first time seeking national funding besides funding received to us by the ARP programs.
