## II. Background and Summary

## A brief description of the applicant's background:

As the only general history museum for the islands of Kaua`i and Ni`ihau, Kaua`i Museum (KM) is the main repository for cultural treasures, works of art, and priceless artifacts found nowhere else in the world. KM also serves as a significant heritage institution dedicated to educating the public about the indigenous history and culture of Kaua`i.

KM's mission statement is to inspire and promote an appreciation and respect for the indigenous and immigrant people of Kaua'i and Ni'ihau and their cultural heritages. KM's mission is to work in active cooperation with the indigenous and immigrant people to help sustain their respective cultures in the contemporary world; developing and preserving outstanding collections which reflect the heritage and artistic achievements of the indigenous and immigrant peoples; creating appropriate exhibits, publications, and educational programs which serve the indigenous and immigrant peoples and the general public; offering access to archives and artifacts for

research; and providing an opportunity for local artists and students to exhibit their creations which may one day be the artifacts of tomorrow.

Centrally located in the historic main district of Lihu'e town, KM services an average 40,000 visitors and 5,000 students (K-12) annually (pre-Covid statistics). KM also provided educational outreach to schools and communities throughout the island via a traveling exhibit led by KM's educational outreach docents who would bring artifacts to the schools when the cost of field trips and in-person visits were too expensive for the schools and their families. KM has maintained a long-standing commitment servicing the island community by reserving every Saturday of the month as 'Ohana Day providing free admission for Kaua'i and Ni'ihau residents. The museum is currently open Mondays-Thursdays 9 a.m. to 2 p.m. which is an abbreviated schedule from the pre-Covid six days a week.

Pre-Covid, KM regularly offered a variety of programs and services designed to promote, maintain, and teach the history and culture of Kaua`i; serving as a venue that offered local artisans and practitioners the opportunity to share their skills through on-site workshops and classes. KM also hosted special lectures and concerts offering residents and visitors the opportunity to experience the island's history and culture with some of the State's pre-eminent practitioners and cultural icons. Despite the unprecedented circumstances of the Covid pandemic, KM was able to fulfill its goal of completing the museum's new exhibit center. KM has already secured grant funding to open the new exhibit center with a series of never before seen collections from KM's extensive archives. These exhibitions highlight the historical and cultural contributions of Kaua`i's indigenous and immigrant populations.

During this past year, KM has found ways to navigate through this pandemic while still providing services to the community and sharing the history and culture of the island with the entire world. KM created a platform to offer virtual tours to accommodate for the ever-changing circumstances. KM's Executive Director recently partnered with HTA to share Kaua`i's history with guests in Japan via a virtual tour. KM plans to enhance its virtual tour platform and be able to offer it to schools, many of which are no longer able to provide their students with field trips to the museum which, for so many students, had been an annual event.

KM has always been a cultural center for this island, a place where organizations throughout the community could come together, a place for our keiki to learn the history of their islands, and as an institution dedicated to the preservation of the history and culture of our indigenous and immigrant people. KM remains resolute in fulfilling this mission and dedicated to finding new and innovate ways to continue serving our island community as it has done for so many decades before.

KM is a private 501(c)(3) non profit organization. Daily operating costs are covered by paid admissions, membership, gift shop sales, photograph reproduction fees, donations, grants, and a few fundraising events. Special needs and collection conservation projects are generally funded by grants from charitable foundations and trusts.

#### 2. The goals and objectives related to the request:

There are two primary goals of this project. The first project goal is to preserve the historic Albert Spencer Wilcox Building. The Historic Hawai'i Foundation decrees the Wilcox Building as "a particularly fine example of a truly indigenous style of architecture, completely original to Hawai'i with no counterpart anywhere else and is one of the few surviving Hart Wood designed buildings on the island of Kaua'i."

The historic Albert Spencer Wilcox Building is a hallmark, not only of the museum, but for the entire town center of Lihu'e. The Wilcox Buildings prominent facade along the main Rice Street is as historic as the artifacts found within its walls. The preservation of the Wilcox Building is not only a community responsibility because of its historic nature and storied past, but it is also home to irreplaceable pieces of the indigenous and immigrant history of Kaua'i and Ni'ihau.

Thus, the other equally important project goal is to ensure that KM is able to continue forward with its mission of serving the peoples of Kaua'i and Ni'ihau as the only general history museum and as a significant Hawaiian heritage institution that preserves the history and culture of the immigrant and indigenous populations. This project ensures that both the Wilcox and Rice Buildings will continue as historical repositories, preserving and housing a large portion of the history for Kaua'i and Ni'ihau.

Without this project, an entire portion of this shared history, the tangible stories of the immigrant and indigenous peoples will no longer be on display and shared with the public. It is the goal of this project and the duty of KM to preserve the historic Albert Spencer Wilcox Building and to ensure that the collections and artifacts within both the Wilcox Building and the adjacent Rice Building remain always secure and on display for the public.

In 1924, the Albert Spencer Wilcox Building opened its doors as Kaua`i's first public library and in 1979, it was added to the National Register of Historic Places listings in Hawai`i. Nearly a century later, the iconic building still stands, housing priceless artifacts of the early Hawaiian and missionary eras, showcasing replicas of early Hawaiiana life, and housing the famed remnants from the Ha`aheo O Hawai`i (Cleopatra's Barge) shipwreck which were excavated by the Smithsonian Institution (1995-2000) and brought home to rest on display in the Wilcox Building.

Filled with treasures from the history of Kaua'i and Ni'ihau, the 97-year old Wilcox building is now in need of necessary and urgent repairs as the past few years of torrential storms and unprecedented rains have caused severe leakage throughout the tile roof. Furthermore, the severity of the roof leakage in the Rice building has damaged the building's north wall and required priceless collections to be removed from display for their preservation lest these artifacts suffer water damage. The wall was also deteriorating from termites and in 2021, KM fumigated both buildings with funding from a private grant source. The exterior covered walkway between the two buildings is also in desperate need of repair as the wood has become

so rotted through from termites that KM had to put in temporary frames to maintain the safety and integrity of the walkway.

KM received a quote from Kauai Island Roofing, LLC, a locally Kaua'i owned and operated business, to provide for the new tile and flat roof areas for the Wilcox building (see attached quote). Based upon initial discussions with Kauai Island Roofing, LLC, additional funds of \$100,000 have been included in the grant request for the Rice building re-roofing (formal quote pending not to exceed \$100,000). KM also received a quote from Preitauer Construction, Inc. for the walkway and north wall replacement.

With your assistance and under the dedicated leadership of a committed Board of Trustees, and the tireless efforts of the Executive Director, KM is poised to emerge from these turbulent times with improved facilities, new exhibits, and a renewed energy to share the history and culture of these islands. The roof replacement, walkway and north wall replacements are the final steps in a long-term, large scale, necessary capital renovation for KM.

#### 3. The public purpose and need to be served:

It is of utmost importance to our island community that KM is able to repair its damaged structures because KM serves as both a historical repository and an educational resource for our community. First and foremost, KM must be able to safely preserve its priceless artifacts, many of which are the last remaining visages of the history of Kaua'i and Ni'ihau. The current conditions of KM's facilities means that for many of these artifacts to be preserved, they must be placed away in the archives lest they suffer water damage from the leaking roofs. This does a disservice to the resident and visitor populations as KM serves as the main historical repository for Kaua'i and Ni'ihau as well as serving as an important educational resource dedicated to providing an accurate historical and cultural account of our indigenous and immigrant populations.

As an institution dedicated through its mission statement to inspire and promote respect and appreciation for the immigrant and indigenous populations; KM believes that two of the largest contributing factors to the promotion of any underlying inequality is under-representation and inaccurate historical context/education.

For decades, KM has hosted school field trips and in recent years, museum educators noted an increasing gap in knowledge about Kaua'i's unique history. Qualitative data taken during school field trips to the museum has shown that a large number of Kaua'i's keiki do not know some of the most basic facts about the island's indigenous history. This remains a problem that will only continue to grow if there are not new and innovative programs, and if there are not institutions such as KM that will continue to provide the resident community and visitors with a comprehensive and accurate representation of the culture and history of Kaua'i and Ni'ihau.

#### 4. Describe the target population to be served:

Through carefully researched exhibits, educational programs, lectures, workshops, and personalized tours; KM has shared the history and culture of Kaua'i and Ni'ihau with an estimated 40-50,000 annual guests and an additional 5,000 school-children K-12 annually (pre-Covid). The specific target population to be served by this project includes a large number of Kaua'i's school children, K-12. At least one-third of Kaua'i's school age population, in addition to 800+ special needs children, grades K-12 from 20 schools island-wide visit the museum annually on school field trips. Without the necessary structural repairs, KM will with no longer be able to accommodate our educators and students or, at the very least will only be able to offer a limited experience as parts of the museum may have to close due to these structural issues.

Another specific target population to be served through this project is the island community of Ni'ihau. KM has annually hosted a Ni'ihau Day in collaboration with the families, specifically members of the Kanahele 'Ohana from Ni'ihau, allowing the community the opportunity to share in the traditions, songs, language, and culture of a group that is often under-represented within modern society. All of these community collaborations and partnerships formed throughout the years allows KM to help give voice to those peoples who have been disproportionately under-represented. Without the assistance of the State GIA, KM may no longer be able to accommodate these cultural celebrations as the walkway and north wall, both adjacent to the museum courtyard become further structurally damaged.

The larger target population to be served includes the over 72,293 Kaua'i island residents (last US Census Bureau estimate 2020), as the museum has a long-standing commitment servicing the community and had reserved every Saturday of the month as Ohana Day providing free admission for Kaua'i and Ni'ihau residents. For many island residents, there are a limited number of affordable, on-island, cultural experiences and during these times when off-island travel may not be feasible, it is especially important that organizations such as the KM are able to provide comprehensive, family-oriented cultural activities while also serving as a centrally located, gathering place for the community.

Equally important is to provide the returning visitor population with a historically accurate and culturally significant reference point where they may immerse themselves in the stories of the immigrant and indigenous peoples. According to HTA figures for 2019, Kaua'i had 1,374,944 visitor arrivals, as the numbers naturally decreased in 2020, the annual transient population increased within the last year to over 711,920 (HTA 2021 excluding December 2021). As the visitor industry continues to improve, as schools begin offering field trips, and as residents search for family-friendly cultural activities; KM plans on being fully operational with improved facilities and new exhibits to share with both our local and visitor populations.

#### Describe the geographic coverage.

As previously stated, KM services the islands of Kaua'i and Ni'ihau. From one third of the island's school children, to the individual cultural practitioners, to the large number of community groups that utilize the museum's facilities and central location, KM play an important role throughout the entire community. Due to the very nature of KM's central location, prominently featured along the main Rice Street in the heart of Lihu'e town, any activity by the museum, whether it be the building of the new exhibit center or renovations to the existing buildings; these projects become noteworthy public operations. Thus, the museum is confident that the renovation of a historic building in the middle of town will inherently generate its own sense of anticipation and excitement, and serve as a further revitalization of Lihue town, in line with the current efforts already begun by the County of Kaua'i.

Equally as important, as part of Kaua'i County, the island of Ni'ihau and her people are an integral part of the culture and history maintained by KM. It is important to note that the very isolation which makes Ni'ihau so unique also makes it susceptible to cultural obsolescence which is why this project is also so important for the Ni'ihau community to help preserve the history and culture unique to their island.

- Rebuild 2x6 straight wall with 1/2" ply sheer and Densglass direct application Stucco, "matching new building."

General Building Scope of Work for the Courtyard Walkway Replace as provided by Preitauer Construction, Inc. According to Description and preliminarily drawings shown in December 2021.

The implementation of the renovation project will be overseen by KM's Executive Director and the Board of Trustees. The Executive Director is on site daily, the Board of Trustees meets monthly; plus several Board members are incredibly active on site and remain in daily contact with the Executive Director. The Executive Director and the Board will evaluate the quantitative progress of the project at the official monthly Board meetings and qualitative evaluation will be done on a regular basis through the daily communications between the contracted individuals, the Executive Director, and Board members. For a renovation of this scope and considering the important historical nature of the Wilcox Building, KM is opting to work with Kauai Island Roofing, LLC; based on the size of their operations, the quality of their past work, and their overall efficiency in project management. KM also appreciates that Kauai Island Roofing is a Kaua'i owned and operated local company that operates from Anahola, KM is confident in the positive outcome and successful completion of this project largely based upon the leadership present at the museum as this is the same leadership team that successfully completed the construction of a new building on site while still maintaining the daily operational duties of the museum, during a pandemic. The success of this recently completed renovation project is a positive indicator for the success of this current proposed renovation project.

Within the past five years, under the stewardship of the current Executive Director and current Board of Trustees, KM has received substantial grants to create a multimedia gallery kiosk highlighting the cultural and natural history of our island and commissioned the creation of an authentic feather cape and helmet of King Kaumuali`i currently on exhibit in the Wilcox building. KM recently, within the past three years, commissioned and completed the creation of the statues of King Kaumuali`i and his favorite wife, Kekaiha`akulou which are featured prominently on KM's front lawn on Rice Street in the center of Lihue town; these community statues serve as a prominent reminder of the indigenous heritage of the island. This past year, with private grant funding, KM also fumigated both the Rice and Wilcox buildings. Within the past three years, KM also completed the build of an entirely new exhibit center with prior State GIA funding. KM has vast experience working on large scale capital improvement projects, all funded through grants. KM has maintained successful grant partnerships and remains in good standing with the County of Kaua`i OED, HTA, Hawai`i Community Foundation, Bank of Hawai`i, and the Hawai`i Council for the Humanities, along with a myriad of smaller private grant organizations.

KM facilities consist of three separate structures, the historic Wilcox building, the Rice building, and the newly completed exhibit center, The (3) structures surround an enclosed open air courtyard and are connected via a covered walkway. See attached site plan for further details.

Overseeing the project is KM Executive Director Chucky Boy Chock, an acclaimed songwriter and Hawaiian cultural practitioner who has overseen numerous events and projects island-wide. Under his stewardship, KM has received grants to create a multimedia gallery kiosk highlighting the cultural and natural history of our island, commissioned the creation and put on display an authentic feather cape and helmet of King Kaumuali'i, commissioned and completed the creation of the statues of King Kaumuali'i and his favorite wife, Kekaiha'akulou, and completed the build of an entirely new exhibit center. KM's Executive Director has maintained successful partnerships with HTA, Hawai'i Council for the Humanities, Bishop Museum, the Smithsonian Institution, and a variety of local cultural and business organizations.

KM's Board of Directors works closely in conjunction with the museum's Executive Director. Former Kaua'i Mayor Maryanne Kusaka remains an active member of the Board of Trustees and was responsible for acquiring the previous State GIA which funded the construction of the museum's new exhibit center. Current Board President, Dr. Goodale is a highly respected member of the community whose family first founded the museum. Dr. Goodale and Board Vice President Patrick Powaser, PhD. meet with the Executive Director, on a regular weekly basis; and together they form an incredibly strong foundation for the museum's leadership.

KM's Grant Administrator will be in charge of project reporting for this grant. She has her B.A. in English and Political Science with her M.A. in Rhetorical Theory and Composition and has been serving as KM's grant administrator since 2012. She has administered museum grants with the County of Kaua`i, HTA, OHA, the State of Hawai`i GIA, the federal Shutters grant, and private grants through Hawai`i Community Foundation and Bank of Hawai`i. KM's Assistant Director has been employed in this position for more than a decade and has also served as KM's Educational Coordinator. KM's Assistant Director was in charge of monitoring the invoicing and reporting for the previous State GIA. She will provide daily support for the Executive Director and once again, be in charge of maintaining invoicing for this project.

### 2. Organization Chart

KM has an active Board of Trustees currently consisting of 13 trustees including the president, vice-president, treasurer, and secretary. The Board of Trustees meets once a month, always with the Executive Director in attendance.

Daily operations are overseen by KM's Executive Director with a support staff including the Assistant Director who will be in charge of maintaining invoicing for this project. KM's grant administrator will be in charge of any reporting required by the State GIA. Both the Assistant Director and Grant Administrator report directly to the Executive Director on a daily basis and both have weekly meetings with the Executive Director. Additional KM staff includes a programming specialist in charge of social media and web design; one carpenter; two cleaning crew; and gift shop sales staff. All staff report directly to the Executive Director who is on site daily and always during regular operating hours. Aside from monthly board meetings, the Executive Director regularly meets with the Board President and Vice President on a weekly basis.

#### 3. Compensation


