II. Background and Summary

A brief description of the applicant's background;

The Pacific Fleet Submarine Memorial Association (PFSMA), is an IRS 501(c)(3) tax-exempt nonprofit organization formed in 1978. PFSMA was created with the purpose of preserving and sharing the stories of submarine veterans. PFSMA acquired the USS Bowfin, a Balao-class WWII submarine in 1979, and opened to the public in 1981. The museum campus, which houses both the museum and ship, is located adjacent to the Pearl Harbor National Memorial at Pearl Harbor. Over 10 million visitors have explored our campus and engaged with our history.

Additionally, PFSMA oversees a robust education program and scholarship programs. The USS Bowfin Memorial Scholarship program that is managed by the Hawaii Community Foundation has awarded over \$1.2 million to Hawaii-based submariners and their families since 1985. A scholarship endowment with the Pauahi Foundation awards the USS Kamehameha Scholarships to native Hawaiian students.

In February 2021, PFSMA completed a two-year 23 Million dollar renovation of its campus. PFSMA committed 10 Million dollars (3 Million dollars for design and 7 Million dollars for construction). PFSMA received Capital Improvement grants of \$215,000 from the 28th Legislature and \$150,000 from the 29th Legislature to support these renovations. The remainder of the project was financed by a loan from the United States Department of Agriculture (USDA).

PFSMA is obligated, at no expense to the Navy, to keep Bowfin safe and presentable for public exhibition, and to maintain the vessel in such a manner that it will not cast discredit upon the Navy or upon the proud tradition of this historic vessel, and not allow the vessel to become a menace to navigation, public health or safety. This includes all necessary painting and cleaning of exterior surfaces and the assurance of the watertight integrity of the hull. Bowfin must be periodically dry docked to inspect the condition of the underwater hull, make any necessary repairs and then re-paint the hull.

USS Bowfin is nearly 80 years old. She has been moored waterborne at her present location in Pearl Harbor, Hawaii since 1981. All waterborne vessels require periodic dry dockings to ensure that they maintain their watertight integrity and to inspect the preservation of their underwater hull. While at her mooring, she is protected with an impressed current cathodic protection system.

PFSMA employs a full time maintenance staff that ensures that Bowfin is maintained in such a manner that it will not cast discredit upon the Navy or upon the proud tradition of this historic Vessel, and not allow the Vessel to become a menace to navigation, public health or safety. While waterborne, this staff works continuously topside and below decks to maintain her safe and suitable for public display.

While closed to the public in 2020 for the COVID-19 pandemic, significant repairs were completed. Bowfin was thoroughly cleaned and repainted below decks. Topside and the superstructure was repaired and repainted. Through these efforts, she remains in pristine condition topside and below decks. However, the only way to truly determine the condition of her underwater hull is by conducting a periodic dry dock maintenance period.

Bowfin was last dry docked in October 2004 and with this next dry dock maintenance period in the fall of 2022; she will be safe and presentable for public exhibition the next 15-20 years. PFSMA has long-range plans to dry dock Bowfin in the 2040-2041 period in preparation for the 100th anniversary of her launching on December 7, 2042.

The cost of the 2004 dry docking was \$700,000. PFSMA estimates that the cost of the 2022 dry docking to be 2 Million dollars. PFSMA is requesting this capital improvement grant of \$250,000 for a portion of the expenses associated with the dry dock maintenance period. PFSMA has also applied for a Save America's Treasures grant – this program is a matching funds grant administered by the National Park Service. The remainder of the expenses for this dry dock maintenance period will be paid for using funds in PFSMA's capital improvement fund.

This maintenance must be performed in a commercial shipyard at PFSMA's expense. There are two Hawaii-based commercial shipyards that are capable of performing this dry dock maintenance period – Pacific Shipyard International (PSI) and Marisco. PFSMA has issued a Request for Proposal (RFP) to these companies. PFSMA will evaluate the responses to the RFP and will select the shipyard to perform this maintenance period in the spring of 2022.

2. The goals and objectives related to the request;

The goal of this project is to complete a dry dock maintenance period of the WWII Fleet Submarine USS Bowfin (SS-287) to ensure that this historic vessel remains in a condition satisfactory to the Department of the Navy as required by the terms of the donation contract executed between the Department of the Navy and PFSMA.

This contract obligates PFSMA, at no expense to the Navy, to make and keep Bowfin safe and presentable for public exhibition, and to maintain the vessel in such a manner that it will not cast discredit upon the Navy or upon the proud tradition of this historic vessel, and not allow the vessel to become a menace to navigation, public health or safety. These maintenance obligations include all necessary painting and cleaning of exterior surfaces and the assurance of the watertight integrity of the hull. In order to meet this obligation, Bowfin must be periodically dry docked to inspect the condition of the underwater hull, make any necessary repairs and then re-paint the hull.

Bowfin was last dry docked in October 2004 and with this next dry dock maintenance period in the fall of 2022, she will be safe and presentable for public exhibition the next 15-20 years. PFSMA has long-range plans to dry dock Bowfin in the 2040-2041 period in preparation for the 100th anniversary of her launching on December 7, 2042.

Key Steps in this project include:

Prepare work package.

Issue request for proposal (RFP).

Evaluate responses to RFP. Select shipyard to perform the maintenance period.

In water inspections and tow preparations.

Tow to maintenance facility to be determined (either in Honolulu Harbor or in Barber's Point Harbor) and enter dry dock.

Clean the underwater hull to remove all sea growth.

Inspect the hull, hull blanks and tanks. Repairs as determined by inspection results.

Prepare and paint the vessel – both underwater and topside.

Undock and return tow from the maintenance facility to Pearl Harbor.

Moor per mooring plan.

Restore access to the public.

3. The public purpose and need to be served;

As one of the most popular tourist destinations in Hawaii and the most visited submarine museum in the United States, the USS Bowfin and the Pacific Fleet Submarine Museum is central to educating people about Pearl Harbor, our State's history, and the sacrifices made by veterans. For most visitors and almost all of our student visitors, the museum also serves as an introduction to submarines and the science behind them, from new technologies to the engineering achievements that make the US Submarine Force the best in the world.

Prior to the COVID-19 pandemic, over 400,000 visitors and students from hundreds of schools visit the museum annually. From hosting local schools to international student groups, the museum and the ship are, in many ways, a living classroom.

USS Bowfin is one of about fifteen WWII era fleet submarines remaining on public display. She is the centerpiece of the Pacific Fleet Submarine Museum. No other submarine is fortunate enough to be moored so near to the site where U.S. involvement in the Pacific War began. She has welcomed aboard over ten million visitors from all over the world in the past 40 years, and continues to serve her country as an educational site, a memorial, and an inspiration to present and future generations.

Because all of the United States Navy's current submarines are nuclear powered, and therefore subject to the requirements and regulations of the Naval Nuclear Propulsion Program, there will be no more U. S. Navy submarines eligible for donation under the Navy's inactive ship donation program. This means that we must preserve and maintain those currently on display so that they remain safe and suitable for public display for as long as possible.

The consequences of not conducting a periodic Maintenance Dry Docking of a waterborne ship are potentially catastrophic. A loss of hull integrity could result in Bowfin becoming unsafe and unpresentable for public exhibition. Additionally her condition could cast discredit upon the Navy or upon her proud tradition as an historic Vessel, or she could become a menace to navigation, public health or safety. PFSMA is taking a pro-active approach to maintain Bowfin in order to prevent this from occurring.

Other historic naval ships that have not pro-actively executed periodic maintenance dry dockings have experienced significant material degradations including the loss of hull integrity. Two of Bowfin's sister ships, the submarines USS Clamagore and USS Ling are no longer safe and presentable for public exhibition. USS Clamagore is currently planned to be sunk as an artificial reef. USS Ling has been closed to the public since being damaged by Hurricane Sandy in 2012. She was further damaged and flooded by vandals and her fate remains uncertain.

Describe the target population to be served; and

Although we place a strong emphasis in serving Oahu, the Neighbor Islands, and the United States mainland, our target population is truly global. School groups, historians,

veterans, military enthusiasts, tourists, government and civilian officials visit USS Bowfin and the Pacific Fleet Submarine Museum from all over the world.

The recently completed campus and museum renovations included interactive exhibits that illustrate a number of Science, Technology, Engineering and Math (STEM) concepts. From bow to stern, Bowfin is a STEM laboratory. PFSMA has actively engaged with the State Department of Education (DOE) to promote on campus visits to promote STEM education. A recent on campus visit by students from Aiea Intermediate School was highly successful and was praised by the highest levels of the DOE. Additional campus visits are planned for this spring and we plan to expand this program as the state emerges from the COVID-19 pandemic.

5. Describe the geographic coverage.

USS Bowfin and the Pacific Fleet Submarine Museum at located at Pearl Harbor, immediately adjacent to the Pearl Harbor National Memorial. With approximately two million visitors from all over the world annually, the Pearl Harbor National Memorial is one of the most visited tourist locations in the state.

As described above, all of the work during this dry dock maintenance period will be performed by the selected shipyard – either Pacific Shipyards International or Marisco. PFSMA has operated the USS Bowfin Submarine Museum & Park at Pearl Harbor since 1978. During this time, PFSMA has overseen dry dock maintenance periods (1986 and 2004).

As of January 2022, PFSMA has 33 employees. The payroll in 2021 was 1.2 Million dollars. Additionally, there are 40 employees from companies (including Service Systems Associates and Maui Divers Jewelry) that provide services (ticketing, retail, food service) on campus.

A 15-member Board of Directors provide governance, strategic planning, and oversight. Our contacts and partnerships extend across a wide spectrum of community, national, and international relationships that have been forged over the years.

The PFSMA's Board of Directors is chaired by Captain Peter W. Miller, USN (Ret.) who is a retired nuclear-trained submarine officer. He served as PFSMA's Treasurer for five years before becoming Board Chairman in 2021.

This project will be supervised by the PFSMA Executive Director, Captain Charles Merkel, US Navy (Retired). Captain Merkel served 30 years in the US Navy as a nuclear-trained submarine officer and has extensive experience in planning and executing submarine maintenance periods. He has been the PFSMA ED since May 2016. He most recently oversaw the execution of a two-year, \$23 million dollar renovation of the museum and campus of the Pacific Fleet Submarine Museum. This renovation project was awarded the 2021 Naval History and Heritage Command Museum Excellence Award. Captain Merkel's final active duty assignment was Director of Maintenance and Material Readiness for Commander, Submarine Force U.S. Pacific Fleet where he was responsible for the material condition of all U. S. submarines in the Pacific.

Additional oversight will be provided by members of the PFSMA Board of Directors. Three of these directors are also retired nuclear-trained submarine officers, and other board members have extensive technical backgrounds.

2. Facilities

USS Bowfin Submarine Museum & Park occupies approximately 3.8 acres of land that is leased from the U. S. Navy adjacent to the USS Arizona Memorial Visitor's Center. This lease is administered by Naval Facilities Engineering Command, Hawaii. In May 2018, Naval Facilities Engineering Command and PFSMA executed a new 25-year lease. The campus is comprised of:

• The USS Bowfin, a decommissioned WWII submarine that is permanently moored in Pearl Harbor;

- The Pacific Fleet Submarine Museum, a 13,000-square-foot museum dedicated to submarine history;
- A variety of outdoor exhibits including:
- the Waterfront Memorial, which honors more than 3,500 submariners lost during WWII;
- a Conning Tower, where visitors can explore the confined space of a WWII submarine;
- a Kaiten, one of the only remaining Japanese manned torpedoes in existence;
- a submarine rescue chamber; and,
- · over a dozen missiles, torpedoes, and propellers.
- Comfort Station (restrooms);
- · An outdoor classroom;
- A Multi-Purpose Learning Space;
- · Food court;
- · Gift shop; and,
- · Staff lounge and offices.

The recently completed renovation has made the site more visitor-friendly in terms of restrooms and ADA access. Tighter security at the site's entrance will also allow us to more closely monitor and better control visitor traffic, resulting in a safer environment for everyone.



USS Bowfin Submarine Museum & Park completes the Pearl Harbor Historic Sites along with the USS Arizona Memorial, the Battleship Missouri Memorial and the Pearl Harbor Aviation Museum. Naval History and Heritage Command provides oversight for the accountability and maintenance of artifacts on loan from the Navy to PFSMA.

Between dry dock maintenance periods, PFSMA employs a full-time maintenance staff to clean, preserve and maintain Bowfin.

PFSMA has long-range plans to dry dock Bowfin in the 2040-2041 time frame in preparation for the 100th anniversary of her launching on December 7, 2042.
