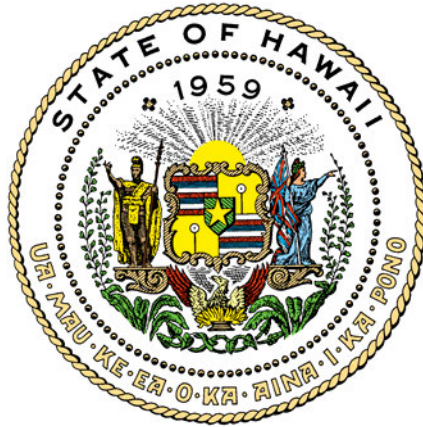



Salt Makers of Hawai'i will fund the CAP process needed to preserve the cultural significance of Hawaiian Sea Salt as well as to continue to provide economic opportunities for Hawai'i residents and community service initiatives. II. Background and Summary

1. A brief description of the applicant's background;

Salt Makers of Hawai'i is a pending 501(c)(3) non-profit organization currently consisting of five Hawaiian salt businesses from Moloka'i, Kaua'i, and O'ahu. Salt Makers of Hawai'i formed out of the urgency to advocate for the livelihood of Red and Black Hawaiian Sea Salts. Current FDA regulations exclude the culturally and economically important Red and Black salts, thereby hindering and possibly erasing these salts from widespread usage. Salt Makers of

Hawai‘i began to collaborate in 2015 after finding out that according to 721(a) of the FD&C Act (21 U.S.C. 379e(a)) the FDA deemed the charcoal and red clay found in Black and Red Hawaiian Sea Salt, respectively, as not on the approved list of safely consumable color additives.

In a nonbinding recommendations document entitled, *Guidance for Industry: Colored Sea Salt* provided by the FDA Office of Food Additive Safety, the FDA stated,

Under section 201(t) of the Federal Food, Drug, and Cosmetic Act (FD&C Act) (21 U.S.C. 321(t)), a color additive is a dye, pigment, or other substance made by a process of synthesis or similar artifice, or extracted, isolated, or otherwise derived, with or without intermediate or final change of identity, from a vegetable, animal, mineral, or other source, and when added or applied to a food, drug, or cosmetic, or to the human body or any part thereof, is capable (alone or through reaction to another substance) of imparting color thereto. When substances such as charcoal and red clay are added to sea salt, these substances meet the statutory definition of a color additive under the FD&C Act because these substances impart color to the salt.

This means that the manufacturing or distribution of Red and Black Hawaiian Sea Salt can lead to the FDA taking action to prevent the salts from being made, distributed, and used, despite the safe consumption of these salts for centuries by Native Hawaiians and the expansive use and reverence of these salts in Hawai‘i. Further, according to the Office of Food Additive Safety, activated charcoal was once on the FDA approved list of color additives; however, no investigations were completed to establish its continued safety according to changing regulations resulting in its removal.¹ Furthermore, activated charcoal is an approved color additive under governmental regulations in Europe² and Canada³. FDA collected 32 samples of Black and Red Hawaiian Sea Salts, tested in their own labs, demonstrating well below standards of heavy metals based on FDA testing.⁴

In order to avoid adverse outcomes of this ban, Salt Makers of Hawai‘i must undergo the Color Additive Petition (CAP) process through the FDA to get charcoal and red clay on the approved color additives list. This endeavor has been an arduous one for Salt Makers of Hawai‘i as the time and financial responsibilities in advocating for Hawai‘i culture, locally grown/ made, and small family-run business has reached a point of saturation. The CAP process is costly. The members in Salt Makers of Hawai‘i have spent over \$40,000 out-of-pocket in the mineral analyses and application fees associated with this process. Salt Makers of Hawai‘i worked with the State of Hawai‘i and the University of Hawai‘i at Hilo in completing a mineral analyses of Alaea in 2018 and has completed the Pre-Petition paperwork needed to move forward with complete mineral analyses needed for approval; however, per FDA regulations, resources spent up until this point is strictly for fact gathering and background information in order to proceed with the actual filing of the CAP. Funds through this grant are crucial to seeing the CAP

process to full fruition and to preserving the cultural, communal, and economic sanctity associated with Red and Black Hawaiian Sea Salt.

2. The goals and objectives related to the request;

The goal of this request is to obtain funding to complete the CAP process through the FDA that will ensure the continued survival of Red Alaea and Black Hawaiian Sea Salt within the local, national, and global cultural and economic arenas. The objective of this request to successfully place charcoal and red clay on the approved list of color additives through the FDA with the goal of protecting Red and Black Hawaiian Sea Salt from potentially being banned from usage by the FDA indefinitely. An FDA ban on the Black and Red Hawaiian Sea Salt will adversely alter the culture of Hawai'i as these Hawaiian Sea Salts are a cornerstone in Hawai'i cuisine, ceremonies, and in Native Hawaiian practices that advance the spiritual, relational, and physical well-being of Native Hawaiians while upholding the importance of the Native Hawaiian culture within the diversity of Hawai'i.

3. The public purpose and need to be served;

The public purpose and need to be served in the continuation of Red Alaea and Black Hawaiian Sea Salt in widespread use with our cultural, economic, educational, and ecological commitments to Hawai'i and our local island communities as the driving force behind this need.

The members of Salt Makers of Hawai'i are all: highly active in their local business communities; provide donations and service for community organizations; are family owned and operated; hire many employees through partnerships with organizations dedicated to career placement for those who are differentially-abled; and are personal and professional proponents of the Hawai'i grown and made economy.

Beyond this legislative endeavor, the primary purpose of Salt Makers of Hawai'i is to partner with governmental, non-profit, and community entities in perpetuating the Hawaiian culture, empowering our various island communities, and advancing legislation that impacts Hawai'i with the goal of responsibility growing a healthy local economy tied to the cultural and communal strengths inherent to each island as well as Hawai'i as a collective.

The mission of Salt Makers of Hawai'i is to support each other in empowering Hawai'i. For example, Hawai'i Kai Co. founded the Salt Masters Guild of Hawai'i, thereby honoring Hawai'i's first independent Salt Master and raising awareness of the ancient traditions of salt making. Additionally, businesses like Sea Salts of Hawai'i partner with the Polynesian Voyaging Society to provide the Hōkūle'a with Hawaiian salt to preserve fish during the Mālama Honua Voyage as well as routinely donate funds to Papahānaumokuākea for Marine Debris Cleanup. These are just some examples of projects and partnerships that Salt Makers of Hawai'i aim to generate more of by achieving this grant and completing the CAP process.

4. Describe the target population to be served; and

The potential ban of the Red Alaea and Black Hawaiian Sea Salt by the FDA would lead to adverse outcomes for some Hawai'i Grown and Hawai'i Made businesses, including the loss of thousands to millions of dollars in projected revenue, the continued laying off of employees, the lack of capacity to create more jobs for locals, and the extinction of Red and Black Hawaiian Sea Salt in exports and wholesales. In addition and most importantly, however, is the prohibition of traditionally and culturally significant salts, which will lead to these products being less accessible and potentially less visible in Hawai'i culture. Further, aligned with the purpose of Salt Makers of Hawai'i, the larger purpose of this grant is to pass on the knowledge of the history, cultural significance, and usage of Hawaiian Sea Salt and the ways it is made to others, particularly the next generation, while providing employment opportunities and an explicit dedication to the Hawai'i grown and made economy.

5. Describe the geographic coverage.

The geographic area of coverage for this grant would be all of the islands in Hawai'i and all entities impacted by the personal, cultural, and commercial use of Red and Black Hawaiian Sea Salts.

III. Service Summary and Outcomes

The work required to complete the CAP process is broad in scope. Individuals and organizations helping to achieve the goals of this grant are members of Salt Makers of Hawai'i. All work, tasks, and responsibilities are volunteer. Members of Salt Makers of Hawai'i have already completed much of the CAP process using personal funds and labor and are a small (five businesses), but dedicated group of individuals. Salt Makers of Hawai'i has worked with the U.S. Senate and House in compiling what is needed to complete this process and is currently working with the state Senate to pass a new bill in 2020 that supports this initiative. A private company has agreed to complete the mineral analyses and have provided a quotation. Salt Makers of Hawai'i has been in consistent communication with the FDA who is aware that all best faith efforts are being made to be in compliance with their requirements, with the only thing delaying the process being the costs associated with filing. The FDA is not enforcing sanctions against the salt industry, but may begin taking actions if filing the CAP application is not achieved soon.

FY July 1 2022-June 30th 2023:

July 2022: Submit \$3000 for Red Alaea CAP application to FDA. Submit \$3000 Black Hawaiian Salt CAP application to FDA. Submit 50% (\$69,357) to Intertek to begin mineral analyses.

October 2022-July 2023: Hire CAP consultant (\$65,000) to aid in completion of CAP.
By July 2023: Successfully submit CAP applications to FDA for approval.

Quality assurance and evaluation will occur through meeting the deadlines set forth in the annual timeline. The proposed budget highlighted in the grant will be followed and any addendums will be discussed and agreed upon by all members of Salt Makers of Hawai'i in collaboration with other entities as deemed necessary. All addendums will be submitted per grant protocol. Salt Makers of Hawai'i will meet regularly to address any challenges and adjustments that come up and to discuss all successes and limitations immediately following the occurrence in order to ensure accordance with the completion of grant goals.
