### A BILL FOR AN ACT

RELATING TO THE OFFICE OF HEALTHCARE ASSURANCE SPECIAL FUND.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The purpose of this Act is to establish the
 annual expenditure ceiling of the office of health care
 assurance special fund through the state budget process and to
 fund increasing operational expenses that include contracts to
 implement a new management information system and background
 checks system.

SECTION 2. Section 321-1.4, Hawaii Revised Statutes, is
amended to read as follows:

9 "§321-1.4 Office of health care assurance special fund; 10 deposits; expenditures. (a) There is established within the 11 department of health, to be administered by the department of 12 health, the office of health care assurance special fund into 13 which shall be deposited moneys collected under section 14 321-11.5(b), license fees for the administration of the durable 15 medical equipment supplier license program collected pursuant to 16 section 321-544, and all administrative penalties imposed and 17 collected by the office of health care assurance pursuant to 18 section 321-20.

1 (c) Any amount in the special fund in excess of \$387,500
2 on June 30 of each year shall be deposited into the general
3 fund.

(d) (c) The department of health shall submit a report to
the legislature concerning the status of the special fund,
including the amount of moneys deposited into and expended from
the special fund, and the sources of receipts and uses of
expenditures, no later than twenty days prior to the convening
of each regular session."

SECTION 3. There is appropriated out of the office of health care assurance special fund the sum of \$710,000 or so much thereof as may be necessary for fiscal year 2022-2023 to complete the health care facility management information system project.

15 The sum appropriated shall be expended by the department of 16 health for the purposes of this Act.

17 SECTION 4. Statutory material to be repealed is bracketed18 and stricken. New statutory material is underscored.

19 SECTION 5. This Act shall take effect upon its approval;
20 provided that section 3 of this Act shall take effect on July 1,
21 2022.
