### A BILL FOR AN ACT

RELATING TO STATUTORY REVISION: AMENDING OR REPEALING VARIOUS PROVISIONS OF THE HAWAII REVISED STATUTES OR THE SESSION LAWS OF HAWAII FOR THE PURPOSES OF CORRECTING ERRORS AND REFERENCES, CLARIFYING LANGUAGE, OR DELETING OBSOLETE OR UNNECESSARY PROVISIONS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 15-13.5, Hawaii Revised Statutes, is

2 amended to read as follows:

3 "\$15-13.5 Eligibility of voter after absentee ballot cast.
4 The absentee ballot of any voter who was eligible to vote at the
5 time the ballot was cast shall not be deemed invalid solely
6 because the voter became ineligible to vote after casting the
7 ballot. For the purposes of this section, "cast" means that the
8 voter has:

9	(1)	Deposited the absentee ballot in the mail for ballots
10		mailed in accordance with section $\left[\frac{15-9(a)(1)}{2}\right] \frac{15-9}{2}$
11	(2)	Delivered the absentee ballot to the appropriate
12		county clerk or polling place in accordance with

14	(3)	Completed voting in person at an absentee polling

place."
