A BILL FOR AN ACT

RELATING TO THE STATE DRUG AND ALCOHOL TOXICOLOGY TESTING LABORATORY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Act 196, Session Laws of Hawaii 2021 (Act 196),
- 2 established the state drug and alcohol toxicology testing
- 3 laboratory special fund to support a state drug and alcohol
- 4 toxicology testing laboratory; specified that moneys in the
- 5 state highway fund may be expended for the cost of establishing
- 6 a state drug and alcohol toxicology testing laboratory; required
- 7 that fines imposed on offenders convicted of certain offenses
- 8 involving operating a vehicle under the influence of an
- 9 intoxicant be deposited into the state drug and alcohol
- 10 toxicology testing laboratory special fund; and required the
- 11 department of health to submit reports to the legislature on
- 12 expenditures from the state drug and alcohol toxicology testing
- 13 laboratory special fund.
- Act 196 also provided that the state drug and alcohol
- 15 toxicology testing laboratory special fund shall be abolished
- 16 and repealed on June 30, 2026, and any unencumbered remaining

- 2 appropriate moneys from the state highway fund to be deposited

- 16 SECTION 2. There is appropriated out of the state highway
- 17 fund the sum of \$400,000 or so much thereof as may be necessary
- 18 for fiscal year 2022-2023 to be deposited into the state drug
- 19 and alcohol toxicology testing laboratory special fund
- 20 established by Act 196, Session Laws of Hawaii 2021.

- 1 SECTION 3. There is appropriated out of the state drug and
- 2 alcohol toxicology testing laboratory special fund the sum of
- 3 \$400,000 or so much thereof as may be necessary for fiscal year
- 4 2022-2023 for the establishment of a state drug and alcohol
- 5 toxicology testing laboratory, including the costs of laboratory
- 6 instrumentation, facility renovation and security upgrades,
- 7 office furniture and supplies, laboratory equipment, and other
- 8 purposes that support a state drug and alcohol toxicology
- 9 testing laboratory.
- 10 The sum appropriated shall be expended by the department of
- 11 health for the purposes of this Act.
- 12 SECTION 4. Any provision of this Act to the contrary
- 13 notwithstanding, the appropriation authorized under this Act
- 14 shall not lapse at the end of the fiscal year for which the
- 15 appropriation is made. Any unexpended and unencumbered balance
- 16 of the appropriation made in this Act as of the close of
- 17 business on June 30, 2023, shall lapse back to the credit of the
- 18 state highway fund.
- 19 SECTION 5. This Act shall take effect on July 1, 2022.
