ACT 206 879 S.B. NO. 879 S.D. 1

A BILL FOR AN ACT

RELATING TO COUNTIES.

	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:
1	SECTION 1. The legislature finds that the department of
2	Hawaiian home lands often continues to have the responsibility
3	to maintain infrastructure despite compliance with county
4	requirements.
5	The purpose of this Act is to require the counties to
6	provide for the maintenance of infrastructure for any housing
7	development for the department of Hawaiian home lands within
8	sixty days and under certain conditions.
9	SECTION 2. Chapter 46, Hawaii Revised Statutes, is amended
10	by adding a new section to part I to be appropriately designated
11	and to read as follows:
12	"§46- Infrastructure maintenance; housing development
13	for the department of Hawaiian home lands. (a) Notwithstanding
14	any other provision to the contrary, infrastructure for any

1	county agency of a completed application for maintenance
2	request; provided that:
3	(1) Applicable meter and connection fees and utility costs
4	relating to the infrastructure have been paid;
5	(2) The infrastructure conforms to applicable county
6	standards in effect at the time the infrastructure is
7	turned over to the county;
8	(3) The infrastructure is connected or adjacent to
9	infrastructure maintained by the county; and
10	(4) The completion of the improvements of the
11	infrastructure is granted approval by the county.
12	(b) For the purposes of this section, "infrastructure"
13	includes water lines and appurtenances; storm drainage,
14	including culverts and catch basins; sewer lines and
15	appurtenances; waste disposal and waste treatment systems; and
16	roadway improvements, including pavement, gutters, curbing,
17	sidewalks, street trees, signage, road striping, traffic calming
18	measures, and street lighting that connect or are adjacent to
19	county infrastructure."
20	SECTION 3. New statutory material is underscored.
21	SECTION 4. This Act shall take effect upon its approval.
