#### STATEMENT OF OBJECTIONS TO SENATE BILL NO. 2142

Honorable Members Thirty-First Legislature State of Hawai'i

Pursuant to Section 16 of Article III of the Constitution of the State of Hawai'i, I am returning herewith, without my approval, Senate Bill No. 2142, entitled "A Bill for an Act Relating to Computer Science."

The purposes of this bill are to (1) allow Department of Education students to fulfill graduation requirements by taking world language, fine arts, career and technical education, or computer science courses; (2) establish a scholarship at the University of Hawaii to encourage students majoring in education to take a computer science course; (3) require the University of Hawaii to establish computer science pathways for students majoring in education; (4) require teacher licensing and certification to include computer science; and (5) appropriate funds for the computer science in teaching scholarship program at the University of Hawaii.

This bill is objectionable because it imposes a new admissions requirement on the University of Hawaii (UH), which will be applicable to all campuses. As written, this bill would require that applicants for admission have successfully completed a world language, fine arts, career and technical education, or computer science class. This requirement would effectively preclude many adults from entering the UH Community College system. Approximately one-third of all community college applicants are over the age of 25 and would not have met the proposed admissions requirement. In addition, UH's Community Colleges work hard to provide opportunities to those who did not complete high school. The new admissions requirement set forth in this bill would create a barrier to public higher education that could impact thousands of potential adult learners.

Furthermore, this bill diminishes the power of the Board of Education (BOE) to formulate statewide educational policy, as established by Section 3 of Article X of the Hawai'i Constitution. The BOE already has a policy regarding high school graduation requirements; under the constitution, any revisions to those requirements should be made by the BOE, and not by the Legislature.

For the foregoing reasons, I am returning Senate Bill No. 2142 without my approval.



RELATING TO COMPUTER SCIENCE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:


1	SECTION 1. Chapter 302A, Hawaii Revised Statutes, is
2	amended by adding a new section to part II, subpart B, to be
3	appropriately designated and to read as follows:
4	"§302A- World language, fine arts, career and technical
5	education, and computer science; diploma substitution.
6	Beginning no later than the school year 2023-2024, the
7	department shall allow each student to fulfill up to two credits
8	required for a high school diploma with world language, fine
9	arts, career and technical education, or computer science
10	credits."
11	SECTION 2. Chapter 304A, Hawaii Revised Statutes, is
12	amended by adding a new subpart to part II to be appropriately
13	designated and to read as follows:
14	" . ADMISSION REQUIREMENTS
15	§304A- World language, fine arts, career and technical
16	education, and computer science; substitution. Beginning no
17	later than with applicants applying for the fall 2024 semester,
18	an applicant for admission shall successfully complete a high

3	SECTION 3. Chapter 304A, Hawaii Revised Statutes, is			
4	amended by adding a new section to part II, subpart B, to be			
5	appropriately designated and to read as follows:			
6	"§304A- Computer science in teaching scholarship			
7	program. (a) There is established the computer science in			
8	teaching scholarship program to be administered by the			
9	University of Hawaii. The purpose of the scholarship program			
10	shall be to increase computer science knowledge among Hawaii's			
11	department of education and public charter school teachers.			
12	(b) Subject to available funds, the University of Hawaii			
13	shall award scholarships in the amount of \$1,000 for each			
14	student that is earning a degree in teaching and also want to			
15	take computer science classes. No person shall be awarded more			
16	than one scholarship under this program.			
17	(c) The scholarship program shall prioritize awarding			
18	scholarships to students from underrepresented groups and			
19	students who agree to teach computer science in schools having			
20	higher percentages of students from underrepresented groups,			
21	rural schools, or under-resourced schools."



1	SECTION 4. Chapter 304A, Hawaii Revised Statutes, is	
2	amended by adding a new section to part IV, subpart B, to be	
3	appropriately designated and to read as follows:	
4	"§304A- Pathways in computer science education. (a)	
5	The college of education shall develop and implement pathways in	
6	computer science for students studying to obtain a degree in	
7	education.	
8	(b) The pathways shall prepare a student to teach computer	
9	science education at the elementary or secondary level.	
10	(c) The University of Hawaii shall submit pathway programs	
11	to the Hawaii teacher standards board for computer science	
12	licensure approval to provide the opportunity for students	
13	completing the pathway established pursuant to this section to	
14	be eligible to add a computer science license to an elementary	
15	or secondary teaching license or to acquire an initial teaching	
16	license in computer science.	
17	(d) The college of education may collaborate with the	
18	information and computer sciences department and nonprofit	
19	organizations to implement this section."	
20	SECTION 5. Section 302A-802, Hawaii Revised Statutes, is

2	policies. (a) The board shall establish licensing and
3	certification standards that govern teacher licensing and
4	certification in Hawaii. Licensing and certification standards
5	established by the board shall be adopted as rules under
6	chapter 91 unless otherwise specified in this subpart.
7	(b) In the development of its standards, the board shall
8	consider the existing teacher applicant pool that is available
9	in the State and the level of the qualification of these
10	applicants, as well as the nature and availability of existing
11	preservice teacher training programs.
12	(c) The board shall adopt policies, exempt from chapters
13	91 and 92, to initiate the following:
14	(1) Develop criteria allowing more individuals with trade
